Democrats Urge Quick Expansion Of Medicaid

PIERRE — South Dakota Democrats will push to have the Legislature quickly expand Medicaid to cover thousands of additional low-income residents, but Republican Gov. Dennis Daugaard and GOP lawmakers say they need more time to study the potential costs.

Senate Democratic leader Jason Frerichs said the Medicaid expansion, which is part of the federal health care law, would cover an estimated 48,000 South Dakotans.

"It needs to be done, and we hope it will happen," said Frerichs, of Wilmot. "In most cases, these folks are not covered right now by some type of health insurance."

But House Republican Leader David Lust, of Rapid City, said lawmakers must first find out who would be covered by an expansion and, most importantly, whether the federal government can afford to pay its share. Much of the next legislative session, which opens Tuesday, will be spent seeking that information, he said.

"Until there's more information, more clarity, I think it would be irresponsible for anyone to reach a conclusion as to whether or not to expand Medicaid," Lust said.

The Republican governor had hoped President Barack Obama's health care overhaul would be stopped, but the Supreme Court upheld the law in June and Obama was re-elected in November. As a result, states have the option to expand Medicaid, with the federal government picking up most of the extra cost.

South Dakota's Medicaid program now covers about 116,000 children, adults and disabled people, or more than 14 percent of the state's population, at a cost of \$300 million a year to the state. The expanded eligibility would add an estimated 48,000 people, mostly adults without children.

Daugaard — who believes health insurance decisions should be left up to each state — has said he does not favor expanding Medicaid when much of the federal law goes into effect in 2014, partly because he's uncertain of the federal government's ability to pay for it. But he said an expansion might be possible in 2015 or later, depending on how much the state would need to chip in and how much flexibility federal officials will allow.

The aim of the health care law is to help uninsured people get health insurance through online markets called exchanges, with many people getting federal aid to help pay premiums.

People with lower incomes — up to 138 percent of the federal poverty line under the law — would be covered by a Medicaid expansion, the cost of which the federal government would fully cover through 2016. The state's contribution would rise in stages to 10 percent, but South Dakota would face substantial extra costs in administrating a larger program.

Some governors have asked if they can do a partial expansion, and Daugaard had hoped to get some flexibility in determining eligible income levels and covered services. But the Obama administration in December said if states expand Medicaid only part way, they wouldn't get the three years of full federal funding provided under the law.

Heineman Seeks Two-Year Tuition Freeze At U. Of Neb.

LINCOLN, Neb. (AP) — Gov. Dave Heineman said Monday that he will propose a two-year tuition freeze at the University of Nebraska and the state's other public colleges as part of his proposed budget plan.

Heineman's budget, which he'll unveil Jan. 15, would include a \$43 million increase in state aid for the University of Nebraska in the 2015 fiscal year, which would peg the school's total annual state aid at \$541 million. The Nebraska State College System would see a \$4.1 million increase, which would raise total state aid to \$49.6 million.

"In Nebraska, we understand that education is the great equalizer, and that's why it's a priority for me," Heineman said at a news conference. "Investing in education is important to Nebraska's future."

The agreement would apply to the University of Nebraska's four campuses the state colleges in Peru, Chadron and Wayne.

Heineman said the idea came about in mid-December during a conversation with University of Nebraska President J.B. Milliken. He then took the proposal to the state college system's chancellor, Stan Carpenter. The Republican governor has sought to make education a centerpiece of his time in office, specifically through the state's P-16 initiative, which aims to increase college graduation rates and keep educated young people in Nebraska.

Heineman said his proposal doesn't preclude the possibility of tax cuts in his budget plan. He declined to release specifics, but has repeatedly suggested that he wants to continue cutting taxes when lawmakers convene this year.

Milliken said the average undergraduate Nebraska resident who takes a 15-hour course load would save about \$1,000 over the two years. State aid to the university has remained flat over the last five years while other states slashed their aid to higher education institutions, he said.

"Nonetheless, it's not a sustainable model if we're going to remain both competitive and affordable," Milliken said. "That's why this proposed compact is so important at this time. It represents a renewed commitment to state investment in the university and the state colleges, and acknowledges our shared responsibility for affordable access."

Is SD's Pheasant Boom Nearing End?

MITCHELL (AP) — A wildlife biologist says that South Dakota's pheasant boom could go the way of the Black Hills gold rush of 1870s — as in, it might disappear.

Pheasants Forever farm bill biologist Mike Blaaid says that the bust is tied to there being less land in the Conservation Reserve Program. *The Mitchell Daily Republic* reports that there was more than 1.55 million acres of CRP in the state in 2007. To date, that number has fallen by nearly 600,000 acres.

In about the same time, the state Department of Game, Fish and Parks reports that the pheasant population has dropped by nearly half.

Blaaid wants Congress to pass a new farm bill and for CRP rates to stay competitive to encourage farmers to take part in the program.

Accessory Charge Filed In Slaying

LINCOLN, Neb. (AP) — Authorities say a 23-year-old man will be charged with being an accessory to the shooting of a man whose body was found in a rural area north of Lincoln.

Lancaster County Attorney Joe Kelly said in a news release Monday that Miguel Castillo faces up to 20 years in prison if convicted of the felony. Castillo had been arrested last week on suspicion of murder.

Investigators say Castillo is involved in the slaying of 25-year-old Tyler Schoenrock, also of Lincoln. Schoenrock's body was found early Dec. 30 by a newspaper carrier.

Online court records don't list the name of Castillo's attorney.

Officers also are looking for another Lincoln man who witnesses say made threats to Schoenrock.

Tax Exemption For Soda Pop Targeted

LINCOLN, Neb. (AP) — A Lincoln senator says he'll sponsor another measure that would end the Nebraska sales tax exemption for soda pop.

Sen. Bill Avery told the *Lincoln Journal Star* that the exemption for soda is illogical and indefensible. Avery says soft drinks have no nutritional value and so don't belong in the same tax-exempt category as food.

Avery filed a similar bill last year that didn't reach the floor for debate.

Many nutritionists say soda consumption contributes to obesity.

It's estimated that ending the exemption would bring the state an estimated \$11 million in new sales tax revenue. Avery's bill requires that 70 percent of the new revenue would be used for school wellness programs and data collection and 30 percent would go to local health departments for health-related issues.

S.F. Gas Station Robbed At Gunpoint

SIOUX FALLS (AP) — Sioux Falls police are investigating the armed robbery of a gas station.

The holdup at the BP station was reported just before 7 a.m. Monday. Police have brought in a canine unit to help in the search for the suspect.

Mayor Pays Off Bet On Vikings' Loss

MINNEAPOLIS (AP) — Minneapolis Mayor R.T. Rybak has paid off his friendly wager with Green Bay Mayor Jim Schmitt over Saturday's playoff game between the Vikings and the Packers.

Green Bay beat Minnesota, so Rybak sent Schmitt sausages from Minneapolis restaurant Butcher and the Boar.

Schmitt had wagered Green Bay cheese, root beer and candy if the Packers lost.

In a news release, Rybak says, "We lost fair and square, so we're sending the sausages."
