SDRVMOC To Hold Training Session In Pierre

PIERRE — The annual training session of the South Dakota Reserve Veterinary Medical Officer Corps (SDRVMOC) was held Jan. 3, 2013, in Pierre. This was the 13th training module for the Corps which was established in 2001. Dr. Jesse M. Hostetter, with Iowa State University's Center for Food Security and Public Health presented materials from his Emerging and Exotic Diseases of Animals course

Dr. Donald Lepp of Yankton is a member of the South Dakota Reserve Veterinary Medical Officer Corps which consists of 42 private veterinarians who have participated in specialized training in foreign animal diseases (FAD) and emergency response. In the event of a FAD occurrence the Corps members may be called to assist in responding to the event.

The SDRVMOC program is in its 12th year and it is important to sustain this group and expand their training in animal health emergency management and knowledge of foreign/emerging animal diseases," says Dr. Dustin Oedekoven, State Veterinarian.

He said he is very grateful of the commitment from the Corps Veterinarians to assist the South Dakota Animal Industry Board in the preparation for animal health and food safety emergencies.
