CITY OF YANKTON WATER PLANT OPERATOR

The City of Yankton is currently accepting applications for the position of Water Plant Operator.


An employee in this position is responsible for the routine maintenance and repair of plant and pump equipment under the direction of the plant supervisor; checks dosages and feed rates; adds chemicals to maintain proper feed rates and chemical balances; checks equipment to ensure proper functioning; maintains and backwashes 10 filter cells; monitors water quality through onsite laboratory analysis; operates lawn equipment (seasonal); meets with supervisor for assignments and updates of EPA and DENR regulations; and maintains data recording and daily logs. This position works M-F 3pm to 11pm. This position is also required to work every fourth weekend and holiday. The position also responds to water treatment and water distribution emergencies when needed.

Applicants must be at least 18 years of age, a high school diploma or GED and one year of previous mechanical maintenance experience. Ability to pass Class I Certification exam in Water Treatment at the completion of one year of directly related Water Plant operation experience. Must have the ability to obtain a Class 3 Certification within 8 years. Must maintain certification level through continuing education requirements set by State. Certified operators will have preference. Employees of the water/wastewater plants are required to live within ten miles of the legal corporate limits of the City. Individuals who live more than ten miles outside the city limits of Yankton, South Dakota, may make application for employment. However, if selected, you shall be required to comply with this policy within 120 days of employment. Candidates must possess a valid Class B with air brakes SD Commercial Drivers' license or be able to obtain one at their own expense within 120 days of hire.

The salary for this position is Range 31, \$34,002 to \$43,047 annually, plus fringe benefits.
