failed. It is also quite common that many of the violations noted during inspection are actually corrected during the inspec-

He added that formal legal action is typically a hearing before an administrative law judge, but said he couldn't comment further since the action is still pending.

JoDean's owner Jack Nielsen told the *Press* & Dakotan that the failed health inspections came as a shock to both him and his employees.

"I'm very concerned about it. This is my livelihood," he said. "I've been in this business for over 40 years, and we've been proud of what we do here.

Before last September's inspection, JoDean's previous three routine inspection rating scores were 90, 90 and 94 with no critical violations. Nielsen said that he had

• Spray bottles containing Windex cleaner were not labeled. Nielsen said these were the only spray bottles in the establishment, but

 A handwashing sink was broken. Nielsen said it has

been fixed, but other handwashing sinks were available in the same area at the time;

• Meat from an unapproved food source was found at the facility. Nielsen said an employee was storing the meat, which was labeled "not for sale or use," at JoDean's for later use during

the holidays at her home; • Raw chicken had been placed above cooked ribs, which could lead to crosscontamination. Nielsen said employees are aware of procedures to avoid cross-contamination, but one employee inadvertently placed meat in the incorrect location.


