for an "earned time" law for violent inmates that would give credit only to those who behave and participate in rehabilitation programs.

The choices we make today are about Nebraska's future, Heineman said. "We must not mortgage Nebraska's future by expanding Obamacare's Medicaid program. We need to protect Nebraska citizens by reforming Nebraska's good time law (for prisoners). And we need to increase the take-home pay of Nebraskans by providing them tax relief.'

The prison issue surfaced partly in response to the case of Nikko Jenkins, who is accused of four Omaha-area slayings after his release from prison. Jenkins was released despite repeated warnings that he suffered from mental health problems and still posed a

threat to society. The state's prisons are also chronically overcrowded, with an inmate population at more than 150 percent of the state's capacity in recent months.

The recent murders were a wake-up call for everyone one of us," Heineman said. "The people of Omaha and the citizens of Nebraska should be able to walk the streets of their neighborhoods without fear of being

Heineman called for a longterm study of the Nebraska Department of Correctional Services to address chronic overcrowding. He recommended several short-term fixes, including adding security staff, contracting with county jails that have available beds. and relying more on the state's Work Ethic Camp in McCook. He said he also would push for reducing the number of federal detainees in state facilities.

Over the longer term, Heineman promised to work with lawmakers on ways to reduce the state's prison population, including a limited supervised

release program.

"There may be opportunities for our state to enact innovative solutions that ensure public safety at a lower cost to our taxpayers," he said.

Lawmakers offered mixed reactions to the governor's

proposals. State Sen. Beau McCoy, of Omaha, said he supported changing the state's good time law for prisoners and he remains opposed to Medicaid expansion.

"I'm not willing to risk the fate of the state on the federal government's likelihood that they are going to honor their commitments," he said.

Sen. Jeremy Nordquist, of Omaha, said Heineman presented a "false choice" when he argued that Medicaid would drain money from state education. He said the expansion would generate savings in health programs that would offset its future Medicaid costs.

"Expanding health coverage is good for the economy, our health care system and our neighbors," Nordquist said.

Yankton Restaurant Liquor License Approved For 2nd Year

The first Yankton establishment to purchase a full-service restaurant liquor license has qualified for another year, according to a city official.

Czeckers Sports Bar & Grill, which is located in the former Elks Lodge at 407 Walnut Street, purchased the license in August.

They have submitted documentation and have qualified for another year of service with that particular license," City Finance Officer Al Viereck said.

Restaurants seeking such licenses must make at least 60 percent of their gross revenue each year from food sales and non-alcoholic beverages. They must submit a report with supporting documentation to the city annually to prove their sales meet the requirement. If the criteria is not met, the license is revoked.

Kelsey Thomas, Czeckers' business manager, said the percentage of sales derived from food and non-alcoholic beverages during the establishment's first several months in operation was well over 60 percent.

"We've had a lot of support from the community," she said. "That's what we wanted and needed, and we got it.'

In February 2009, the City Commission set the fee for a new full-service restaurant on-sale liquor license at \$70,000.

According to a 2008 state law, the price of the license had to be at least the price of the most recently sold on-sale liquor license sold within the city between Jan. 1, 2003, and Jan. 1, 2008.

The restaurant liquor license fee cannot be changed for  $10^{\circ}$  years from the time it was set

Thomas said the large upfront investment in such a license was a source of much debate.

You're never sure of what customers are going to come in and how things are going to go," she stated. "It was a huge risk, and we definitely had a lot of conversations about whether it was worth it. So far, it has been. We're only four months into it, so we're not that set as a business. But in the first several months, it has played out really well for us.'
