• Multi-Hybrid Planter — Peter Sexton, Southeast Research Farm Supervisor and South Dakota State University (SDSU) professor;

 Varietal Selection Tips for Choosing the Best Lines — Nathan Mueller, Agronomy Specialist, SDSU Extension;

 Weed Resistance: How Bad Is It? — Paul Johnson, Agronomy Field Specialist, SDSU Extension;

• Wind Energy Development in Southeast South Dakota — Ron Hornstra, B&H Wind, LLC;

• Grazing Management in Annual Forages — Warren Rusche, Cow/Calf Field Specialist, SDSU Extension.

The Southeast Research Farm acts as a living laboratory, working with both crops and livestock. While located near Beresford, the research farm's impact is felt across southeastern South Dakota, from the Missouri River to the Iowa border.

The service area includes Minnehaha, Lincoln, Turner, Clay, Union, Hutchinson, Yankton, Bon Homme, Douglas, and Charles Mix counties.

The annual meeting is generally rotated at centralized locations, Jepsen said. We serve a large area, and we hold our annual meeting where it won't be such a long drive for people," he said.

Sexton's presentation will describe a one-of-its-kind collaboration and product, Jepsen said. The project involved the partnership of SDSU and Cooperative Extension Service, Raven Industries and DuPont Pioneer.

'We have a new planter that we had rebuilt," Jepsen said. "You can plant double or single row, and you can change the population of seeds per acre and varieties

of your seed and fertilizer." The multi-hybrid planter allows producers to adapt instantly to changing field conditions, Jepsen said. "You can adjust if you're in the field and run into different kinds of soils, wetlands and hills," he said.

The planter has undergone field testing, with more fine tuning in the works, Jepsen said.

"Last year, it was in a testing stage. For everyone, it was a learning process," he said. "We will do more experimentation and see how well it works.

The development of the multi-hybrid planter started in spring 2012, according to Growing South Dakota, the SDSU magazine.

Sexton sought advice from the research farm's board concerning a new planter. The board agreed that a precision planter capable of planting multiple hybrids was the way to go. The farm's corporation purchased the planter, and the board provided funding for the raw materials to cus-

tomize the planter. The research farm and Raven signed an agreement during 2012 in which Raven donated the engineering time to customize the plant to Sexton's specifications.

'This was a great model of industry partnering with public entities," said Raven product manager Douglas Prairie in the magazine article.

Sexton provided feedback to Raven engineers in the development of hydraulic drives, control system and software for modifying the planter. The planter was first used in spring 2013, with Raven engineers working onsite to make adjustments and receive feedback from Sexton and other research farm staff.

The project development was kept a secret until patents were filed, according to the SDSU magazine. Raven unveiled the prototype planter a June 2013 trade show demonstration. The planter was also shown at the Farm Progress Show in Decatur, Ill., the largest rowcrop machinery show in the world.

Tests were conducted not only at the research farm near Beresford but also on private farms near Parkston,

Tripp, Lennox and Baltic. Sexton turned to DuPont Pioneer for the appropriate corn and soybean hybrids, the magazine said. Pioneer agreed to supply the seed and make recommendations. The first crops planted with the new machine were harvested in October 2013, with the data now under analysis.

SDSU will provided agronomic and financial reasons why farmers should consider using a multi-hybrid approach, according to the magazine. Raven seeks to play a role in further design of the multi-hybrid planter.

The project could lead to further collaboration between Raven and SDSU for precision agriculture innovations, according to the SDSU magazine.

Sexton told the magazine that he anticipates such planters will become commonplace.

What gets commercialized may look different, but the basic ability to switch between lines on the go, I think, is part of the future," he said in the article.

The Democrats generally seemed to be supporters of Common Core, while the Republicans who voted no mostly seemed to be true opponents of Common Core.

Sen. David Omdahl, R-Sioux Falls, urged the legislation's defeat. "It's a waste of time and a waste of money,' he said.

The legislation originally included \$100,000 to pay for the two years of work. That was amended to \$1 Thursday as a point for negotiations with House members so that the bill would eventually return to the Senate if the House didn't kill it, according to Senate Republican leader Tim Rave of Baltic

Yet to come is legislation that attempts to halt Common's Core use. The state Board of Education decided in late 2010 to transition to the new standards that were developed through the National Governors Association and the national chief school officers' organization.

The first round of achievement testing, using the new Smarter Balanced assessments and Common Core standards, is scheduled for the current school year.

Sen. Phil Jensen, R-Řapid City, said in an interview he has legislation being drafted that would attempt to roll back South Dakota standards to the 2000-era version.
