# Bill Would Let SD Lawmakers Carry

PIERRE (AP) - Saying they were afraid of being at-tacked while on the job, members of a South Dakota legislative committee approved a bill on Tuesday that would allow elected officials to carry guns in the Capitol and county

courthouses. State law currently permits only law enforcement officials and iudges to carry guns in those public buildings. The bill would expand the law to legisla tors and other elected officials. as long as they have state permits to carry concealed weapons.

Supporters on the House Local Government Committee, which voted 8-5 to endorse the plan, said lawmakers have been particularly worried about security since former Arizona U.S. Rep. Gabby Giffords was shot in 2011. Glffords, 43, is still recovering from a brain injury she suffered when a mentally ill man short her in the head as she met with constituents outside an Arizona shopping center. Six people were killed in the attack. Rep. Stace Nelson, R-Ful-

ton, said the measure would give lawmakers and other elected officials the ability to protect themselves. But representatives of law

enforcement agencies, lawyers, local governments and the courts said they want the law to remain in its current form. They testified that law officers would have a tough time identifying public officials or others who might be allowed to be armed in those public buildings.

Opponents also said armed legislators would not make the Capitol any safer.

# Wismer To Run For SD Governor

PIERRE - The Legislature's most persistent critic of the 2011 budget cuts said Tuesday she will start gathering signatures on her candidacy petition to run for governor.

Most of the Legislature's Democrats turned out to support Rep. Susan Wismer of Britton as she made her announcement at the state Capi-

tol. "I know it will be an uphill battle," Wismer said.

If she wins the Democratic primary June 3, Wismer would be the first woman to be the nominee for governor of one of the major political parties. Wismer said she wants to talk to voters

about the budget cuts passed by the Legislature at the request of then-new Gov. Dennis Daugaard, a Republican, three years ago.

She said there were choices that could have been made, rather than cuts across the board that were in most instances 10 percent.

"I want to explain to the rest of the state what those choices were and what my priorities are," Wismer told reporters.

The 58-year-old accountant is the second Democrat to declare a candidacy for governor. The other is Joe Lowe of Piedmont, who was the state's wildlands fire chief.

The filing deadline for statewide candidates' petitions is March 25.

Wismer said her campaign won't hit high gear until after April 15. She wants to focus on finishing the legislative session, which ends March 31, and tax season.

She said Lowe is a credible candidate but she is a life-long resident of South Dakota and a business owner with six years of experience in the Legislature.

Wismer comes from a strong Democratic tradition in Marshall County. Her grandfather was state Sen. Art Jones and her uncle was state Sen. Curt Jones.

She said extremists have come to dominate



An attorney for Mishra, of Rancho Cucamonga, Calif. says his client has already gotten a check for more than \$1.07 million, plus interest. Now, the U.S. Attorney's Office will pay her \$39,035 to cover her legal fees
