cility - that's where the industry is going," he stated. "Why? Because we have so much made offshore, and it comes back to this country in containers and has to be broken down at an intermodal facility. That asset that is being built out there (at Napa junction) has the capabilities of breaking down unit trains."

Unit trains are groups of rail cars that usually range from 40 to 120 cars.

Kramer said the Dakota Plains project is rare in the Yankton area because companies typically look to the public sector to develop industrial parks here. 'You've been very success-

ful at acquiring some great companies for Yankton and the area, but you've had to invest very, very heavily because the private sector does not build industrial parks in Yankton," he stated. The absorption rate is not significant enough for them to

make money at it, so they don't "(The Napa junction project

is) a huge asset that you don't have to put a dime in," Kramer continued. "(Dakota Plains is) willing to share that with us. We have to get some commitments on who gets to use it, and the costs of using it have to be competitive. It's giving

our area a significant asset."

Kramer was before the City Commission Monday to ask its support for a resolution that addressed the Dakota Plains project and other economic development issues that may

"It's a motion of support to the county to know that, as economic development projects come forward in the area - not just within city limits — we will take the opportunity to support them," said City Manager Amy Nelson, who also serves on the YAPG executive board. "We want to be able to say, if it is good for Yankton County, it is probably good for the city, as well. It's the 'rising tides helps all ships' idea.'

Kramer said YAPG has offered to do a comprehensive development plan that would anticipate what impacts Dakota Plains, as well as other potential businesses, could have on an area covering approximately 640 acres.

"The opportunity to grow beyond that 50-acre (Dakota Plains) development is very strong," Kramer said. "We don't know how much natural gas, sewer or water that development is going to need. To do that comprehensive plan so that it's a full build out ... is essential."

YAPG will contract out work on the development plan. Kramer anticipates it could cost anywhere from

\$5,000 to \$30,000, depending on how much research is needed.

"We hope to have that done in the next three to six months," he said. "In the meantime, we've encouraged the county to allow this proj ect to begin construction in April and to move forward with rezoning.'

The Napa junction is a unique location because it is where a Burlington Northern Santa Fe Railway Company line intersects with the stateowned Napa-Platte line. The short line triggers an agreement between the Burlington Northern Santa Fe Railway Company and the State of South Dakota that would allow other rail companies to come up to the Dakota Plains facility.

Dakota Plains would like to break ground at the site between 436th Avenue and 437th Avenue, and north of Highway 50, by April 15 and be open for the fall harvest in 2015.

The City Commission gave its unanimous support Monday to the resolution of support for YAPG and the county.

actually encouraging excellence, it reduces it to just meeting these standards. Your more able students end up being stymied and discour-

aged. Forbes added that the school has thoroughly investigated the Common Core during the past year, but determined its own standards are better suited for its stu-

"We just felt like the sequence of teaching didn't make a lot of sense in a lot of cases. We believe the way we do it is more methodical and more able to be grasped by students," he said. "For example, in math, Common Core tends to be more process than knowledge. For the younger students, we believe — and I think research has shown that a knowledge base is really needed instead of describing different ways two plus three could equal five."

Numerous parents also expressed concern about the

MVCA implementing Common Core standards, Forbes said, and not just for educational reasons

"Parents are very uneasy about this database of information that is being collected." he said. "There's not much trust in the government to collect that information.'

While some nonpublic schools have chosen to adopt portions of the Common Core standards and reject others, Forbes said the MVCA decided against such an approach.

"We really felt like that was a Trojan horse," he said. "How are you going to differentiate that? We just thought it was better to say no."

Following its rejection of

the Common Core standards and state accreditation, the MVCA association decided instead to seek accreditation through a Christian-school accrediting body, Forbes said. Those standards will be more rigorous than what the state is

implementing, he said. "In our viewpoint, we're going above and beyond what Common Core calls for." Forbes said. "We're not lowering our standards — we're actually raising them. And that's what we're all about.
