The regular meeting of the Yankton County Commission was called to order by Chairman Bruce Jensen at 3:30 PM on Monday, December 29, 2014.

Roll Call was taken with the following Commissioners present: Donna Freng, Bruce Jensen, Gary Moore, John Harper, and Allen Sinclair.

Action 14495C: A motion was made by Sinclair and seconded by Freng to approve the meeting agenda as posted. All present voted aye; motion carried.

Action 14496C: A motion was made by Moore and seconded by Harper to approve minutes from the December 16th, 2014 Commission meeting with the following correction: parcel 72.200.006.020 was reported being sold to Gary Berry and should have read Pete and Nancy Steffen. All present voted aye; motion carried.

Action 14497C: A motion was made by Sinclair and seconded by Moore to approve the following budget supplements: Commissioners \$42,000.00; Court Services \$73,000.00; Data \$31,300.00; and Government Buildings \$77,500.00. All present voted aye; motion carried.

Action 14498C: A motion was made by Sinclair and seconded by Harper to approve the following Contingency Transfers: Safety Center \$21,000.00; Coroner \$1,000.00; Mentally Handicapped \$11,400.00; Historical Sites \$2,000.00; Emergency Management \$30,400.00 and County Building and Structures \$32,200.00. All present voted aye; motion carried.
