Senate Panels Support Proposals To Fix Holes In State Election Laws

PIERRE — Legislators gave their first blessing Wednesday to two sets of pro-posals for election reforms in South Dakota and set the stage for another set to move forward.

Secretary of State Shantel Krebs said they are parts of a package that responds to various problems during the 2014 campaigns.

She said the proposals were developed with the state Board of Elections and carry the board's approval.

Two of the measures could be up for votes by the full Senate as early as today.

One allows more time for circuit courts to decide challenges to validity of candidates' petitions.

The Senate State Affairs Committee unanimously endorsed Senate Bill 67. It calls for petition challenges to be filed in court no later than the second Tuesday in March.

It works with another measure, Senate Bill 69, which would change the time frame for candidates to circulate their nominating petitions for signatures from registered voters.

The current time frame for gathering signatures on candidate petitions for state and county offices is Jan. 1 through the last Tuesday of March.

SB 69 would change those dates to Dec. 1 of the preceding year through the last Tuesday of February.

A court challenge to Republican U.S. Senate candidate Annette Bosworth's petitions was dropped last spring because time ran short.

A necessary preliminary step in the legal process couldn't be completed by the challenger, Rep. Steve Hickey, R-Sioux Falls, in time for the case to be decided before primary-election ballots had to be printed.

The State Affairs Committee delayed

action on SB 69 until Friday so an amendment could be assembled regarding new political parties.

Krebs said the Libertarian and Constitution parties failed to draw the nec-essary 2.5 percent of the vote in the governor's election last November to remain qualified for 2016. They would need to circulate petitions to get official status on the 2016 ballot.

The Senate Local Government Committee meanwhile endorsed another measure, Senate Bill 68, that gives the secretary of state the authority to randomly check 5 percent of the signatures on the petition of a statewide candidate.

Currently no official is expressly responsible for checking the validity of the signatures. An individual citizen can file the challenge in court.

The 5 percent spot-check is used for statewide petitions for initiated measures, constitutional amendments and referrals of legislative acts.

The various deadlines are based on absentee voting starting 46 days before election day. The 46 days provide time for overseas and military voting. The ballots need to be ready for the start of absentee voting.

In 2014, the last day for candidates to submit petitions for the primary elections was March 25 and absentee voting began April 18.

Krebs and the Board of Elections also propose eliminating the exception allowing the late arrival of petitions if candidates used registered mail to postmark them before the deadline.

That change is part of SB 69. Krebs said the short time between the petition deadline and the start of absentee voting was made tighter by petitions that arrived after the deadline by registered mail.

Sen. Ried Holien, R-Watertown, and Sen. Corey Brown, R-Gettysburg, questioned whether eliminating the

registered-mail provision would remove some of the safeguards for submitting petitions by mail.

Krebs acknowledged there wouldn't be a way for a candidate to know whether the petitions arrived. She said petitions came days past the deadline last spring, including one petition that was filed 14 days late.

Sen. Bernie Hunhoff, D-Yankton, asked the State Affairs Committee to consider allowing open slots for legislative candidates to be filled in August by the state party chairmen if candidates didn't submit petitions for the primaries.

Democrats typically had more diffi-culty filling the 105 legislative slots than Republican did in recent election cycles.

Krebs, a Republian, was carefully and politely non-committal. "I don't see why your proposal isn't something we could at least look at," Krebs said. Republican senators didn't respond

favorably to Hunhoff's idea, which might be revisited Friday by the committee.

Brown said he would struggle with the idea that a party chairman from another part of South Dakota could decide on candidates in a legislative district where the people and issues might be unfamiliar.

A common practice by Democrats in recent elections has been placeholding, where a candidate submits petitions for a legislative slot on the ballot and later withdraws. The slot then can be filled by another Democratic candidate or left empty.

Brown said placeholding is "abhorrent" and violates the reason that withdrawals and replacements are allowed: Emergencies or other unforeseen situations can come up.

"I think that whole process has been abused," Brown said.

EB-5 Legislation Set For Hearing Friday BY BOB MERCER

PIERRE - Rep. G. Mark Mickelson plans to hand aside his chairman's gavel Friday and present to the House Judiciary Committee two proposed sets of business restrictions on state government employees and appointees.

The measures come in the wake of the investigation last year by the Legislature's Government Operations and Audit Committee into economic development activities in-

volving the EB-5 immigrant investor program. Mickelson, R-Sioux Falls, served on the committee but voted against the resolution last year calling for the investigation.

One of the proposals, House Bill 1023, came from the committee. He is listed as the prime sponsor.

It would expand an existing prohibition in state law against state government employees having an interest in a state government contract within the scope of the employee's duties.

The committee's recommendation was to extend the prohibition to cover one year after the person leaves state government.

Mickelson recently submitted his own measure, House Bill 1064. It has the same core group of GOAC members as sponsors but is more complicated and extensive than HB 1023.

HB 1064 would in part affect other governments throughout South Dakota, repeal the existing law for state government employees and replace it with a series of conditions that in various cases allow an employee or officer to have an interest in a contract.

The committee meeting begins at 10 a.m. CST Friday. IM 17 DISPUTE: The Legislature's Code Commission meets Monday afternoon and part of the discussion will be about the correct location in the state's legal code of the "any willing provider" law passed by South Dakota voters Nov. 4.

The location question has the interest of insurance and healthcare officials. Where it's placed can affect the scope of the law, including whether it would apply to state government's employee health plan.

FEE INCREASES: The Senate Commerce and Energy Committee will hold a hearing Tuesday morning on Senate Bill 62. The Daugaard administration's proposal would raise licensing and registration fees for lodging, camping and food-service businesses

JUVENILE JUSTICE: The Senate State Affairs Committee plans a hearing Friday for the juvenile justice reforms proposed by Gov. Dennis Daugaard and Chief Justice David Gilbertson.

The measure, Senate Bill 73, has more than 90 of the 105 legislators signed to the sponsors list. The prime sponsor is Sen. Alan Solano, R-Rapid City.

DEBATE DELAYED: At the request of Rep. Jacqueline Sly, R-Rapid City, the House of Representatives deferred consideration Wednesday of House Bill 1058. It would revise and expand the power and authority of the state Health Department to deal with contagious diseases and public health emergencies.

The measure is now scheduled for House debate Tuesday. Reportedly an amendment is under construction. The bill is among the top five priorities for Gov. Dennis Daugaard this year.

Currently it contains an emergency clause. That would allow it to become law and take effect immediately upon receiving the governor's signature after it had passed.

But an emergency clause requires a two-thirds majority in each chamber - and that could be a high hurdle after the bill emerged from its House committee hearing on a vote of

Ricketts Seeks \$60M For Lower Taxes

LINCOLN, Neb. (AP) - Nebraska Gov. Pete Ricketts will call for an additional \$60 million a year to lower property taxes in his first State of the State address to lawmakers.

The proposal is part of the governor's budget recommendations that will be released after his speech on Thursday at 10 a.m. Central Time. Ricketts has said reducing property taxes is his top priority this year. The proposal would boost Nebraska's property tax credit fund to \$400 million over two years. The state money would help offset what Nebraskans have to pay in local taxes on their property, including homes, farms, ranches and company buildings Ricketts says Nebraska has been ranked behind New York state and California in its overall tax burden on citizens. He will also propose other tax relief measures.

Measles Patient Spent Time In Omaha

OMAHA, Neb. (AP) - Health officials say a person who recently spent time in Ómaha and Blair has been diagnosed with a confirmed case of measles.

The Douglas County Health Department issued a health alert Wednesday after the infected person visited several public locations, including the Omaha Children's Museum, a church near Blair and a physician's office.

Measles is a highly contagious viral illness that spreads through the air through breathing, coughing or sneezing. Officials say any person exposed to it who has not been vaccinated is likely to contract the disease.

Officials have also urged anyone born in or after 1957 who may have been in the diagnosed patient's vicinity to check vaccine records. They say those who haven't received two measles vaccine doses should contact their doctors immediately.


