#### **High Court Ruling Could Affect 3 S.D. Inmates**

PIERRE (AP) — Officials in South Dakota have identified three inmates in the state prison system who are serving mandatory life sentences for murders they committed when they were younger than 18, Attorney General Marty Jackley announced Thursday.

A U.S. Supreme Court decision last month said mandatory life-without-parole sentences for juvenile homicide offenders violates the Constitution's ban on cruel and unusual punishment. The decision's impact on the South Dakota cases is unclear.

More than 2,000 people are in U.S. prisons under such a sentence. Some might win immediate release, while others still could be kept locked up for life. Judges also could impose new sentences carrying a specific number of years and a parole review.

The three South Dakota in mates serving mandatory life sentences  $% \left( 1\right) =\left( 1\right) \left( 1\right) \left($ for murders committed when they were under 18 are Paul D. Jensen, Daniel N. Charles and Jessi Owens.

The Supreme Court decision "may not impact the mandatory life sentences imposed on Jensen, Charles and Owens," Jackley said in a news release. "Courts must determine if the decision retroactively applies to juveniles previously sentenced to life imprisonment."

#### **Homeless Woman Fined \$50 For Child Neglect**

OMAHA, Neb. (AP) — A mother who lived with her toddler in a car outside an Omaha homeless shelter has been fined \$50 for a misdemeanor count of child neglect.

Omaha television station KMTV reports that police found Theresa Stockfeld living in the car in April. Police also say she had allowed several intoxicated, homeless men to take care of her 3-year-old daughter while she left the car.

Police say that when officers found the girl, her diaper hadn't been changed in a long time, the interior of the car was littered with clothes, trash and old food and a weapon was within the girl's reach.

Stockfeld pleaded guilty to misdemeanor child neglect earlier this week. She's due in court later this month to see if she can regain custody of her daughter.

#### **Animal Shelter Crowded With Runaway Pets**

OMAHA, Neb. (AP) — The Nebraska Humane Society's shelter in Omaha has been overwhelmed with calls from people seeking pets sent fleeing by their fear of Fourth of July fireworks.

The Humane Society's Jason Crumley tells Omaha television station KETV that the shelter runs into the same problem every July Fourth, but this year has been worse because residents were allowed to shoot fireworks for more than a week before the holiday.

Crumley says dog owners have been calling for days reporting their dogs jumping fences and running off because of fireworks. Crumley says those dogs often wind up at the Omaha shelter.

## **Police: Hit-And-Run Preceded Neb. Shooting**

LINCOLN, Neb. (AP) — Police said a gunfight erupted after a motorist hit an 8-year-old boy lighting a firework in the street, leaving the boy's father dead and another man injured in Lincoln.

Orlando Rey Sifuentez, 41, of Lincoln died after he was shot in the chest just before 11:30 p.m. Wednesday, about an hour and a half after his son was struck by a hit-and-run motorist. Police said Sifuentez was shot when he and other family members confronted the man they believed had hit the boy after police didn't arrest him, though he was arrested after the shooting.

The boy was later released from a local hospital with a busted

"This is the kind of tragedy that can occur when emotion runs high and you don't let the police do their job," Lincoln Police Chief Jim Peschong told the *Lincoln* Journal Star.

The boy, Andrew Sifuentez-Coleman, was lighting a firework in the street just before 10 p.m. when a car hit him and drove off. Family members said a friend followed the car and reported its location to police.

An officer went to the location and questioned the vehicle's owner, 23-year-old Robert Sweets Robinson, who said he didn't hit the boy. The officer left after seeing no damage on the vehicle that would warrant an immediate arrest, but Peschong said the investigation had been ongoing and the allegations weren't "something we

wind up taking lightly."
Peschong said Andrew's family members had threatened Robinson before leaving. The relatives then went back, in two or three vehicles, and exchanged gunfire with Robinson, authorities said.

Police said Robinson shot Sifuentez in the chest. An 18-yearold man who was with Sifuentez, Matthew J. Guerra, was shot in the calf and taken to a Lincoln hospital with injuries that weren't lifethreatening. Robinson wasn't

Police didn't find a gun on Sifuentez or Guerra but saw five bullet holes in the house that they believe came from someone in Sifuentez's camp, Peschong said.

While investigating the shooting, police found evidence suggesting Robinson did hit the boy. They arrested him on suspicion of leaving the scene of an injury accident and may add other charges, Peschong said.

"I'm angry. I'm very frickin' angry," the boy's mother, Christy Coleman, told the newspaper. "This is all I have in the world. My boys.

The police chief said it was early in the investigation and officers were still interviewing witnesses.

"There were a lot of people there when officers were sent out," he said.
