Man Shoots Self During Warrant Serve

SIOUX FALLS (AP) — Sioux Falls police say that a 42-year-old man shot and killed himself inside the basement of a house Friday as officers were trying to serve an arrest warrant.

Police say that officers from the Sioux Falls Police Department and the Minnehaha County Sheriff's Office were investigating a suspect in a series of felony warrants about 8:30 a.m. when they located him in a home asked other occupants to exit. Police say they asked the man to exit the basement but then heard a gunshot.

The city's emergency response team blocked off the street and used a bomb squad robot to search the house before finding him alone in the basement with what appeared to be self-inflicted wounds.

Oglala Leader Red Cloud Dies At 93

PINE RIDGE (AP) — The Oglala Sioux Tribe says Oliver Red Cloud, a descendant of the legendary Lakota Chief Red Cloud, has died at the age of 93.

Tribal spokeswoman Toni Red Cloud, who is Oliver Red Cloud's niece, says her uncle died Thursday in a Denver hospital surrounded by family. Memorial arrangements are being planned.

Family members in a statement say Oliver Red Cloud was a powerful orator about obligations each nation had to the other in keeping peace during modern times. They say he was the leading statesman for keeping peace between Lakota, Cheyenne and Arapaho people.

Chief Red Cloud was an Oglala Lakota signer of the 1868 Fort Laramie Treaty peace agreement with the United States.

Police ID 2 Men Injured In Shooting

OMAHA, Neb. (AP) — Omaha police have identified two men who were victims of early-morning shootings, including one with life-threatening injuries.

Police say 19-year-old Timothy J. Howell of Omaha was in critical condition after the shooting, shortly before midnight on Friday. He was taken to Creighton University Medical Center.

Police say another man who was a witness to the first shooting walked into the hospital shortly before 3 a.m. Spencer Mason, 22, was being treated for non-life threatening injuries.

Omaha police say they're still investigating. Anyone with information is urged to contact Crime Stoppers, and may be eligible for a \$1,000 reward.

Fire Destroys Southern Neb. Home

KEARNEY, Neb. (AP) — An early-morning fire has destroyed a home in south-central Nebraska.

The *Kearney Hub* reports that the fire was reported around 1 a.m. Friday in Orleans. The home was engulfed when firefighters arrived. Authorities say 18 firefighters from Orleans and Alma fought the blaze until it was under control around 3 a.m.

No one was home at the time of the fire.

Firefighters remained on scene with the Nebraska State Fire Marshal until 6 a.m. The cause of the blaze hasn't been determined, and authorities say the home is a total loss.

Man Kills Self During Park Celebration

LEAD (AP) — Police in the Black Hills city of Lead say a 67-year-old man killed himself with a gun in a park filled with several hundred people for a July 4th celebration.

The *Black Hills Pioneer* reports the incident occurred at Manuel Brothers Park at about 7:35 p.m. Witnesses say the man was being escorted from the park by law enforcement officers just before the shot.

Lead resident Misael Rivera says he was standing about three feet from the man when he heard police say "put the gun down."

Witness Trevor Neal says officers tried to stop the man but he shot himself. He was taken by ambulance transported to Lead-Deadwood Regional Hospital but died.

The man's name was not being released until family members could be notified.

Carmike Theater To Close In Sioux Falls

SIOUX FALLS (AP) — A Sioux Falls movie feature will be showing its final films later this month.

The *Argus Leader* reports that Carmike 7 is closing Sunday, July 14, as part of redevelopment of the property just off 41st Street near Interstate 29.

Work is expected to start next month on a LaQuinta Inn & Suites that will be built in the parking lot.

Carmike was the only theater chain in Sioux Falls for several years until Century Theaters opened in 1999. Carmike at the time owned the Carmike 7, Empire 6 and West Mall 7 theaters, operating 20 of the 34 screens in Sioux Falls.

The company also has theaters in Yankton and Rapid City.

Court Upholds Stop In Drunk Driving Case

PIERRE (AP) — The state Supreme Court has upheld a South Dakota man's conviction for drunken driving, ruling that a Highway Patrol trooper had sufficient reason to stop the man after seeing his pickup truck cross a lane marker on the side of the highway.

Jason Hett was stopped by a trooper in December 2011 near Buffalo in northwestern South Dakota. Hett argued the evidence against him should be thrown out because the trooper had no reasonable suspicion of a traffic violation that would justify the stop.

But the high court says the trooper was justified in stopping Hett because the trooper had a reasonable suspicion Hett had violated the law by driving outside his lane.

A jury convicted Hett of drunken driving and having an open container of alcohol in his vehicle.

Court Orders New Trial In Case

OMAHA, Neb. — The Nebraska Supreme Court on Friday ordered a new trial for a man convicted of fatally stabbing another man at a 2010 party in Norfolk.

The state's high court overturned the second-degree murder conviction of De'Aris Trice, 23, who was sentenced early last year to 40 years-to-life in prison for killing 27-year-old Timothy Warren.

At trial, prosecutors painted a chaotic scene at the house where Warren was killed. The party began after a local bar closed at 1 a.m. and was intended for a few people, "but turned into a lot," according to one witness. Warren and another man began fighting in the house, court records show. Within minutes, other became involved, either trying to break up the fight or join it.

"In short, the record shows that a

brawl broke out," the high court wrote Friday.

Trice's brother testified that Trice later admitted to stabbing Warren in an effort to protect himself and his brother. The brother's girlfriend also testified that Trice admitted to her that he "cut somebody."

The high court reversed Trice's conviction, finding fault in an instruction to the jury. The jury was instructed to convict Trice of second-degree murder if it found beyond a reasonable doubt that he had killed intentionally, but without premeditation. The jury was further instructed that only if prosecutors failed to prove one of those elements could it consider whether Trice had committed manslaughter, a lesser offense.

The high court said that while the instruction regarding manslaughter was correct at the time it was given, the state Supreme Court's decision in another case shortly thereafter rendered the instruction in Trice's case faulty.

Western SD To Host Adventure Motorcycle Ride

Sports in Spearfish, came up with the Dakota Adventure Loop ride as a way to show off western South Dakota to adventure motorcycle riders and, he hopes, establish the area as a destination for adventure riders from around the world.

Adventure bikes — named for their ability to travel far off paved roads, yet cover long distances — are a different breed from the Harley-Davidsons and other heavy highway motorcycles that dominate the Sturgis rally. The adventure bikes have high fenders and raised suspensions that enable them to travel on gravel

roads and dirt trails that are inaccessible to many other bikes and most cars. They also have bigger frames and gas tanks than most dirt bikes, allowing them to travel long distances.

Adventure bikes are one of the fastest growing segments of the motorcycle market.

"My goal was to create a route of national significance," Hearne said.

"I think adventure riders will jump on this," he said. "I hope it ends up being a significant addition to the tourism draw, a demographic we've not had here before."

For the initial ride he has invited riders who have national clout, including Stan Simpson of Cibola, Texas, a member of the board of directors of the 232,000-member American Motorcyclist Association.

"My goal is to have these people be the ambassadors of the ride," Hearne said.

The entire route is on roads and trails that are open to the public, and Hearne said riders will be careful not to disturb the environment.

"A week after we ride, there should be no sign that we were ever there," he said.
