was an Eagle Scout with Troop 180 and an altar server at Sacred Heart Convent through middle and high school.

He graduated from Yankton High School in 1978. He earned his Bachelor of Science in Electrical Engineering in 1985 from South Dakota School of Mines and Technology in Rapid City, SD. Chris began his professional career that spring in the Omaha, NE office of the US Army Corps of Engineers.

In 1986, Chris returned to Yankton to join his father's electrical contracting firm, Bauer Electric, which he operated for 17 years. In 2004, Chris became the Electrical Engineer for company-wide maintenance with Menu Foods of Ontario, Canada. In 2010, Chris joined the team at Sanford Underground Research Facility at the old Homestake gold mine in Lead, SD as the Electrical Safety Engineer and was extremely proud to

be part of the important role South Dakota and SURF play in advancing science.

While a student at SDSM&T, Chris met fellow-student Julianne Peterson. They were married October 22, 1982 in Browns Valley, Minnesota. Chris and Julie had two daughters: Tessanna in 1987 and Emmalynn in 1991. Chris' greatest joy was spending time with his family. Chris was a skilled carpenter and with his family, they uniquely re-modeled their home in Yankton. Chris was very involved in Tessa's and Emma's activities, including serving as Yankton Swim Team President and Backstage Production Manager for Dakota Dance Association and the Academy of Dance. Chris received the "Make It Happen" award in recognition of his work for Yankton's dancers.

Chris had a life-long dedication to long distance running. He ran cross-country in high school and college. In recent years, until disease prevented him, he returned to racing. In 2011, Chris, as a master's division runner, ranked nationally in

the steeplechase and won the inaugural Crazy Horse Half Marathon in Custer, SD.

Chris is survived by his wife, Julianne, Yankton; daughters, Tessanna, Sioux Falls, SD and Emmalynn, Minneapolis, MN; his father, James Bauer, Yankton; sisters, Katherine Sanders (Steven), McCook Lake, SD and Paula (John Lewis), Berkeley, CA; brother, Steven Bauer, Pittsburgh, PA; nephews, William and Jamie Sanders and Spencer Bauer; and niece, Hannah Pommerer.

Led by University of South Dakota adjunct bassoon instructor Lorrie Thomas, the Not Yet Famous Bassoon Band is comprised of several of Thomas' current and former bassoon students and colleagues. Inspired several years ago by The Boulder Bassoon Band performances at International Double Reed conferences, the Vermillion-based group decided it would be fun to play popular, recognizable, and some classical music as a "band."

Since then, the Not Yet Famous Bassoon Band has given concerts in Sioux Falls, Vermillion, Sioux City, and LeMars, and expanded its repertoire to include swing tunes written especially for the band; marches and pop tunes such as Michael Jackson's "I'll Be There," a polka written by a former student; and a march written especially for them this year by USD Professor Emeritus Steve Yarbrough. Making sure there's something for everyone, the band also plays Americana and children's tunes.

When not performing with the Not Yet Famous Bassoon Band, Thomas is a bassoonist with the Sioux City and Northwest Iowa symphony orchestras and the Sioux City Symphony Woodwind Quintet. On summer Sundays she plays clarinet with the Sioux City Municipal Band. She teaches private woodwind students from the surrounding area and adjudicates at solo and small ensemble contests. In addition to USD, she has been an adjunct instructor on the faculties of Northwestern, Dordt, and Morningside Colleges.

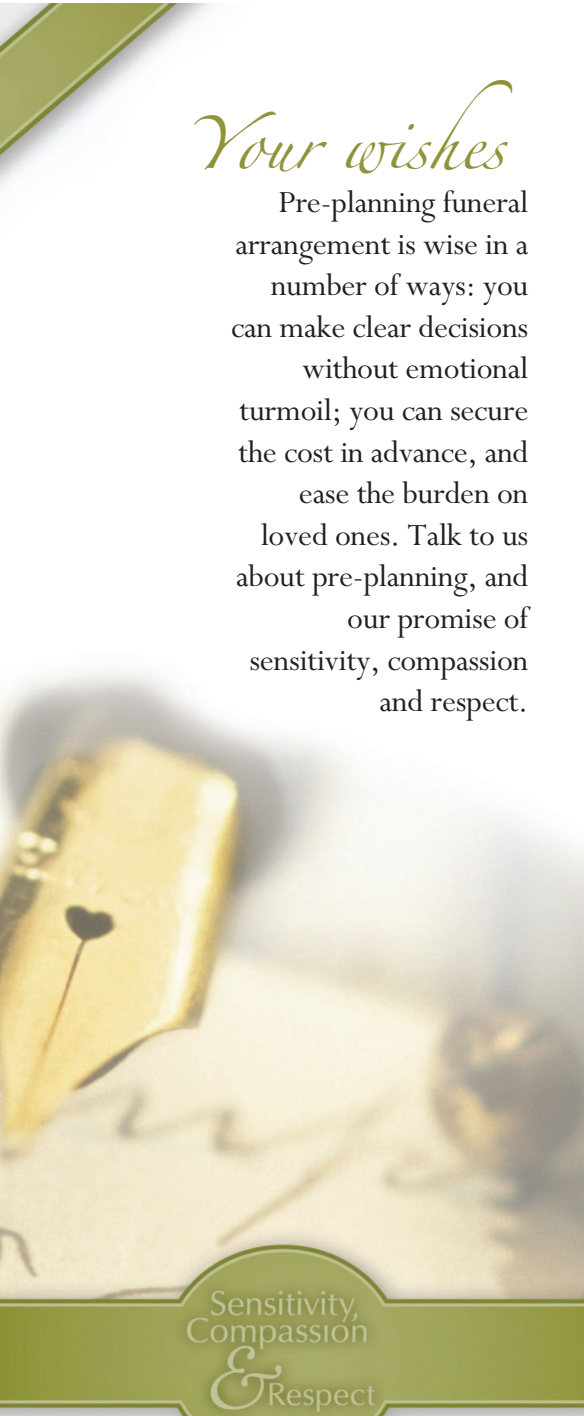
