Local Rail Authority **Proposal Headed** To The State Level

After months of proposals and fine tuning, a basic agreement for a Yankton County regional rail authority has been set up between the Yankton City Commission and Yankton County Commission.

However, County Commissioner Debra Bodenstedt told the Press & Dakotan that there's still plenty of work to do before the

group meets officially. We have to wait 20 days after (the minutes have been) published," Bodenstedt said. "Then we have to package up that agreement and other documentation of public hearings and send them to the Secretary of State. Then the Secretary of state verifies us and then sends us paperwork back stating that."

The push for a Yankton County regional rail authority began this spring at the County Commission level. The rail authority will be a conduit for federal funds to help aid in rail and rail-related projects within the authorized zone - in this

Southeast CASA **Expands To Bon Homme County**

The volunteers of Southeast CASA (Court-Appointed Special Advocates) have been helping children in Yankton County through exceptionally difficult court cases since 2012. As of this month, that service has been extended to Bon Homme and Clay counties and this is only the beginning of the group's expansion.

Sherri Rodgers-Conti, program director for Southeast ČASA, told the Press & Dakotan that the group, officially organized in October 2011, was ready to move forward.

"Ín 2012, we started assigning volunteers who had been trained as child advocates to active abuse and neglect cases in the court system, and we were only doing that in

Yankton County to start with, Rodgers-Conti said. "Now we are at a point where we feel that, not only are we experienced enough to expand our services, but we also feel that there is enough community recognition of what we do and enough community support financially for what we do." Rodgers-Conti said the ex-

pansion became official earlier this month.

"We decided that this spring, we were going to work on expanding to Clay County and Bon Homme County," she said. "As of July 1, we are in both counties as well as Yankton County. We now serve the children in three counties."

She added that this expansion has been anticipated since the very beginning.

SIOUX FALLS (AP) - A concert planned by a 9-yearold terminally ill girl in South Dakota will allow her to fulfill her wish of helping other children.

The Argus Leader reports the event planned by Rebekah Spader, of Sioux Falls, raised enough funds Saturday to help at least one ill child.

Rebekah was diagnosed with a genetic nerve disorder at age 1. She was later diagnosed with a bone marrow failure disorder.

Rebekah survived a transplant, but her family decided against a needed second one. Her father, Tony Spader, says the family chose to "celebrate" her life.
