Prisoner Missing From Min. Unit

A Yankton minimum unit state prison inmate has been placed on escape status after he didn't return from a work shift Sunday morning.

Sunday morning. Inmate Jack Williams failed to return to the unit this morning following his work release shift at a local business.

Williams is a 35-year-old white male, 5-feet-11-inches tall and weighs approximately 240 pounds. He has blonde hair and blue eyes. He is currently serving a 10-year sentence (with seven years suspended) for forgery, a five-year sentence (with two years suspended) for possession of a forged instrument and a concurrent 10-year sentence (with seven years suspended) for unauthorized ingestion of a controlled substance. All of the sentences are from Union County. Williams began serving the sentences in January 2014.

Anyone who sees Williams or knows of his whereabouts should contact law enforcement immediately.

Corrections Official: No Need To Change Screening Tactics

SIOUX FALLS — A South Dakota inmate walked away from a minimum-security unit in Sioux Falls last week and allegedly went on to commit a string of crimes across Minnesota, but state corrections officials say they still believe their system of classifying inmates is working.

Clint Eldeen, a 46-year-old inmate serving 20

years for writing bad checks, left the campus of the State Penitentiary on July 10 and allegedly committed a string of crimes in both states before being arrested in a Minneapolis suburb

on Wednesday. Denny Kaemingk, the secretary for the Department of Corrections, said that officials will have to review Eldeen's case but said the vast majority of inmates in minimum-security units stay put and don't leave and commit crimes.

In the fiscal year that ended in June, 11 of

the more than 740 minimum-security inmates left the prison grounds and didn't return.

"We really believe that our assessments and classification policy are very sound," he said. The number of inmates who have left min-

imum-security units in South Dakota over the past decade has increased slightly but steadily, according to data provided by the Department

Neb. Woman Dies After Falling Into Missouri River

RUNNING WATER — A Nebraska woman died Saturday after falling into the Missouri River near Running Water. Authorities say 23-year-old Veronica Jo Keeble of Niobrara, Nebraska, fell into the water while she and four others were down near the river by Standing

Bear Memorial Bridge. KELO-TV reported at least two people jumped into the river to try and save her.

Keeble died at the scene. Two others were flown to a Sioux Falls hospital, one of them with serious injuries.

Authorities believe alcohol was a factor, but have ruled the situation an accident.

Departments assisting in the rescue included the Bon Homme County Sheriff's Office; the Knox County Sheriff's Office; the Santee Sioux Tribe Police; Yankton Search and Rescue; South Dakota Game, Fish and Parks; and Springfield police and emergency crews.
