Ackman 22nd In NCAA Discus

EUGENE, Oregon — Sarah Ackman's second shot at the NCAA Outdoor Track and Field Championships fell short Wednesday in Eugene, Ore. Ackman ended her season with a throw of 146 feet five inches, placing 22nd out of 24 throwers.

She advanced to the NCAA Outdoor Championships with a ninth-place finish at the NCAA West Regional in Austin, Texas, on May 28, with a throw of 166-9. Ackman qualified for the regional with her first-place toss of 163-10 at the SDSU Twilight April 27. The throw was ranked 27th nationally, securing one of the top-48 spots in the regional.

Ackman placed in the top-four in two events at the Summit League Championships May 13-15. She placed third in the discus with a throw of 156-9 and fourth in the shot put with a toss of 43-4.25.

A year ago, Ackman advanced past the NCAA Midwest Regional to become the first SDSU athlete to qualify for the NCAA Championships at the Division I level. She placed 21st in the preliminary round of the discus with a toss of 155-8, missing the finals by less than 10 feet.

Ackman is the indoor and outdoor school record holder in the shot put and also holds the indoor record in the weight throw and outdoor record in the discus.

Ackman's event concludes the outdoor season, as well as her career with the Jacks.

Bryan Standout Headed To MMC

OMAHA (Nebraska) Bryan outfielder J.D. Urban will attend Mount Marty College and play baseball for the Lancers, the institution announced.

Urban was an Honorable Mention Super State selection (Lincoln Journal Star), Honorable Mention All-State selection (Omaha World Herald) and 2nd Team All-Metro selection during his junior and senior seasons. He was also named Academic All-State in his junior and senior seasons. He was a member of the District A-4 runner-up team in 2008 and the District A-4 championship team in 2009.

This past season, he was recognized by Collegiate Baseball Newspaper as one of the top high school collegiate prospects in the state of Nebraska. He batted .436 with 36 runs batted in this past spring.

"JD fits the mold of the players that I like to bring into this program," said MMC head baseball coach Andy Bernatow. "JD has performed at a high level both athletically and academically during his high school career. He looks to have the ability to make an immediate impact at the varsity level for the Lancers.

"JD is one of the better players in the Omaha Metro area and one of the top high school players in the state of Nebraska. He possesses many physical tools that should allow for a quick transition into college baseball. He runs well, has a strong throwing arm, is an outstanding defensive outfielder and is a solid offensive player. I am eager to have him join the program and am pleased to have the opportunity to work with him."

Urban plans to major in recreation management at Mount Marty College, where he will receive a Trustee Scholarship and Baseball Award Scholarship. He is the son of Jeffrey and Sarah Urban of Omaha.

is a perception in Nebraska that Texas wields too much influence on league policies. "We certainly don't have anything against anybody in the Big 12," Osborne said on the Husker Sports Network. "This decision is not going to be based on animosity or petty jealousy. I mean, you're talking about something that could maintain for the next 75 or 100 years. This is a big deal in terms of the University of Nebraska (and) this is a big deal in view of many other institutions."

Former Oklahoma coach Barry Switzer, a coaching rival of Osborne's in the 1970s and '80s and longtime friend, said hearing Nebraska and the Big Ten in the same sentence doesn't sound right.

Switzer told The Associated Press he doesn't envy Osborne having to play a major role in the possible destruction of the Big 12, which evolved from the old Big Eight and Southwest Conference.

"I'm sure it weighs heavily on Tom," Switzer said. "I hate to think we would lose what we have and what we built for so long. Finances are a factor, and sometimes you have to give up tradition for finances."

McClurg said the Big 12 has been a good fit for Nebraska but the Big Ten, if it extends an invitation, could be better. It would greatly expand the school's reach and could mean far more money for the school's athletic programs.

"We have to seriously evaluate any opportunity that comes our way," McClurg said, "because everybody else is doing that."

The university said Wednesday night that members of the regents' executive committee held a conference call to discuss the agenda for Friday's meeting.

"No action was taken during today's conference call," the statement said, "and none will be taken prior to Friday's meeting."
