S.D. Inmate Asks For Execution To Proceed

SIOUX FALLS — A man sentenced to death for killing a prison guard says the state Supreme Court's decision to delay his execution to allow for a mandatory review is denying him his constitutional rights.

Eric Robert, 50, will ask the South Dakota Supreme Court to allow his execution to proceed and is proposing legislative changes to prevent similar cases in the future in briefs that are expected to be filed later this week or early next week.

Robert pleaded guilty to killing prison guard Ronald Johnson during a botched prison escape in April 2011. A judge sentenced him to death for the crime last fall, and his execution was set for May. But the South Dakota Supreme Court stayed the execution in February to allow more time for a mandatory review, which could delay the execution for up to two years.

In briefs not yet filed with the court but given to The Associated Press in an email, Mark Kadi, Robert's lawyer, argues that Robert has a constitutional, due process right to be executed based on the trial court's order.

"If this process will take up to (two) years

as reported, Robert proposes we seek to answer the main underlying issue in this case: does a death row inmate have a constitutional right to die on time as ordered?" Kadi said in an email.

In the briefs, Robert proposed the Legislature consider changes to the law, allowing death penalty proceedings to be given priority in the state Supreme Court or, absent a voluntary appeal, requiring the court to review the case in a set number of days before the execution date.

The briefs noted that during the months since Robert was sentenced, the state Supreme Court has reviewed numerous cases, including civil cases such as the dispute between actor Kevin Costner and an artist about whether sculptures were appropriately displayed at a Deadwood resort.

"These civil cases are undoubtedly important to the parties involved regarding their equitable or monetary interests. Death penalty cases due to their special nature and consequences, however, deserve special consideration," the brief said.

Attorney General Marty Jackley said he could not comment on the new briefs because he has not yet seen them. Under appellate procedure, the state is only allowed to file one brief, which it has already done.

Robert was serving an 80-year-sentence on a kidnapping conviction when he attempted to escape April 12, 2011, with fellow inmate Rodney Berget.

Johnson was working alone the morning of his death — also his 63rd birthday — in a part of the prison known as Pheasantland Industries, where inmates work on upholstery, signs, custom furniture and other projects. Prosecutors said that after the inmates killed Johnson, Robert put on Johnson's uniform and tried to carry a large box toward the prison gate with Berget inside. The inmates were apprehended before leaving the grounds.

Berget also pleaded guilty and has been sentenced to death. Another inmate, Michael Nordman, 47, was given a life sentence for providing the plastic wrap and pipe used in

The penitentiary made more than a dozen procedural changes less than a month after Johnson's death, including adding officers and installing additional security cameras. Other changes, outlined in a 28-page report, included further restricting inmate traffic, strengthening perimeter fencing, improving lighting and mandating body alarm "panic buttons" for staff.

Rape Trial Delayed Again For S.D. Bar Owner

HURON (AP) — Trial has been delayed again for a South Dakota bar owner accused of raping a 12-year-old girl and two 14-year-olds

KOKK radio reports 35-year-old Werner Fajardo is now scheduled for trial beginning Aug. 15. A telephone survey is planned to help gauge whether Fajardo can get a fair trial in Beadle County or whether the judge will move the trial out of Huron.

Prosecutors allege Fajardo provided alcohol to the three girls at his El Cuervo bar in Huron and assaulted them. He's pleaded not guilty and initially had been scheduled for trial on multiple rape charges on May 16. The judge in early May granted a defense lawyer's request to delay the trial until June 27 to give the attorney more time to prepare.

Missing Man Found Dead In Vehicle

REDFIELD (AP) — The Spink County Sheriff says officers have found the body of a man in his 70s who was reported missing.

Sheriff Kevin Schurch tells the American News in Aberdeen that the man was found dead inside his vehicle in the Turtle Creek River, about five miles west of Redfield. The body was located Wednesday morning after law enforcement began looking for the man. He was last seen in Redfield about 12 p.m. Tuesday.

Authorities say they are investigating the death. Foul play is not suspected.

Schurch says the official cause of death has not been determined. The victim's name won't be released until next of kin are notified.

Tea Man Sentenced For Possessing Child Porn

SIOUX FALLS (AP) — A Tea man has been sentenced to five years in prison for possessing child pornography.

U.S. Attorney Brendan Johnson announced Wednesday that 21year-old Cameron Schwartzle was sentenced by a federal judge last

Prosecutors say Schwartzle used file-sharing software to download 150 images and four hours of videos of child pornography on

his computer.

Schwartzle was immediately turned over to the custody of the U.S. Marshal's Service.

Officials Release Name Of Dead Nebraska Boy

WAHOO, Neb. (AP) — Saunders County officials have released the name of an 11-year-old boy whose body was found in the spillway south of Lake Wanahoo in eastern Nebraska.

The sheriff's office identified the boy as Baden Martinez.

The body was recovered around 10:30 a.m. Wednesday. The boy's mother reported him missing Tuesday about 10:30 p.m. when he didn't returned to their Wahoo home. He'd gone fishing by himself around 5 p.m.

It's unclear whether an autopsy has been ordered. County Attorney Scott Tingelhoff, who also acts as the county coroner, didn't immediately return a call from The Associated Press.

Repeat DUI Offender In S.D. Convicted Again

RAPID CITY (AP) — A Rapid City man on parole for a drunken crash eight years ago that killed his 3-year-old daughter has been sentenced to a year in jail for another drunken driving conviction. Prosecutors say it's the fifth lifetime DUI for 42-year-old Raymond Salvas.

Salvas pleaded guilty to manslaughter in the 2004 crash, which happened while he was out on bond for an earlier DUI conviction. He served five years in prison.

The Lincoln Journal Star savs the commission filed its claim Tuesday in U.S. District Court in Tulsa, Ŏkla.

The lawsuit says Voss Lighting, of Lincoln, violated federal law by refusing to hire Edward Wolfe at its Tulsa location. The EEOC says Wolfe was a qualified

applicant.
"Voss Lighting appears to have a corporate culture that requires employees adhere to certain religious beliefs that have absolutely no bearing on the business of selling lighting products," EEOC trial attorney Patrick Holman said in a news release. "This litigation, we hope, will serve to illuminate Voss Lighting as to Title VII's prohibitions against discrimination on the basis of religion."

Title VII refers to a title of the Civil Rights Act of 1964.

Company Vice President Steve Sanderson told the *Journal Star* that the company denied the allegation. He says the person hired was more qualified than Wolfe.

According to the lawsuit, Voss advertised the job in Tulsa through a Baptist church attended by one of the managers in the Tulsa office. Wolfe, who did not attend the church, learned

Johnson Leads Banking Hearing On JPMorgan Losses

SIOUX FALLS — Sen. Tim Johnson is questioning why the largest bank in the U.S. failed to have more risk controls in place, leading to more than \$2 billion lost on trades.

Johnson, chairman of the Senate Banking Committee, opened a congressional hearing in Washington on Wednesday in which lawmakers questioned JPMorgan Chase CEO Jamie Dimon.

"How can a bank take on 'far too much risk' if the point of the trades was to reduce risk in the first place?" the South Dakota Democrat asked in his opening statement. "Or was the goal really to make money?'

JPMorgan's trading loss has heightened concerns that the biggest banks still pose risks to the nation's financial system less than four years after the start of the

2008 financial crisis. Dimon told the panel Wednesday that JPMorgan has taken steps to prevent such losses from occur-

Johnson said he disagrees with the notion that Wall Street reforms now micromanage the operations of a large bank and that regulators can't keep up with bank innovation.

While risk cannot be eliminated from our economy, we can and must demand that banks take risk management seriously and maintain strong controls," Johnson said. "We must also demand that regulators do their job well.'

Since the crisis, Dimon has been an outspoken voice against stricter financial regulation. He has complained that lawmakers and regulators have gone too far in overhauling the financial system and might be slowing the economic recovery.

The start of the hearing was delayed by shouting demonstrators, and at least a dozen people were escorted from the room.

Johnson said questions must be answered if the nation wants its largest banks to better manage their risks to maintain financial stability.
