Jobs Report Shows Steady Prospects For S.D.

SIOUX FALLS (AP) — South Dakota employers say they plan to hire workers at a solid pace throughout the summer.

The report by Manpower Inc. shows that 21 percent of businesses surveyed plan to add employees from July through September, while only 3 percent say they expect to reduce payrolls.

About 75 percent of employers surveyed expect to maintain current staff levels.

The Sioux Falls Argus Leader reports that the results are nearly identical to the previous quarter.

Omaha Police Investigating Shooting Death

OMAHA, Neb. (AP) — Omaha police are seeking more information about an early morning shooting that killed a man.

Police said the unidentified victim was discovered by an officer on bike patrol shortly after 2 a.m. Sunday. The officer noticed a large crowd and heard gunfire, and found the victim in a parking lot.

The man was taken to Creighton University Medical Center in critical condition. He was pronounced dead at the hospital. Authorities are not releasing more information about the victim until they notify family members. They say they have not made any arrests.

S.F. Events Center Creates Parking Problems

SIOUX FALLS (AP) — Construction on a new events center in South Dakota's largest city is slated to begin in a few weeks, and the work is going to cost the city some precious parking spots.

Sioux Falls officials are forming a committee to look at alternative parking and using off-site shuttle services, as well as creating special tailgating sections for events.

Mike Cooper, the city's planning and building services director, tells the Argus Leader that parking with be a challenge. Work on the \$115 million events center is expected to be com-

pleted by fall of 2014. The building will seat 12,000 for concerts and basketball games.

Sioux Falls voters last November narrowly approved a proposal to use money from a city sales tax already in place to help pay for the center.

Dems Nominate Two For PUC

ABERDEEN — The two Democratic candidates tapped Saturday to run for the South

Dakota Public Utilities Commission said they will criticize their incumbent Republican opponents for not doing enough to protect farmers from a failed grain-buying company. Delegates at the Democratic state conven-

tion nominated Matt McGovern, 40, a Sioux Falls lawyer and the grandson of former Sen. George McGovern, to run for a full six-year term on the commission that regulates grain warehouses and natural gas, electric and telephone utilities. McGovern likely will face current PUC member Kristie Fiegen of Sioux Falls, a former

Democrats also nominated Nick Nemec, 53, a farmer from Holabird and former state lawmaker, to run for a four-year term on the commission. He likely will face PUC Chairman Chris Nelson, former secretary of state.

Fiegen and Nelson both were appointed to

the panel last year to fill vacancies. Both have declared their candidacies, though the Republican Party will nominate candidates for the commission at its state convention next week.

McGovern told delegates that the current commissioners should have done more to protect farmers hurt by the collapse of Anderson Seeds Co. Inc., which owes farmers in North Dakota and South Dakota an estimated \$4 million for sunflowers the farmers delivered to the

Ît's just a horrible scandal and an absolute failure of the PUC to protect farmers as they should," McGovern said.

Nemec said the Anderson Seeds incident was one of the main reasons he decided to run for the commission, calling it an example of South Dakota's failure to properly regulate businesses. "This is a travesty," Nemec said.

Nelson said the Democrats' criticism is unfair because the current three members of the commission — all Republicans — have done everything they legally could to protect the un-

"For them to say we failed is an absolute falsehood because we complied with state law in every regard," Nelson said.

Nelson said the commission later this month will unveil a proposal to strengthen

laws covering the regulation of grain ware-

houses and grain buyers. The PUC has said Anderson Seeds appeared to be in good financial shape when it was licensed as a grain buyer in 2010, but the commission revoked the company's license after receiving complaints early this year from farmers who were not paid for sunflowers they delivered to the Redfield, S.D., operation.

A Canadian company has said it has an agreement to purchase the Redfield site. But officials have said it appears there will be no money left to pay farmers after the proceeds of the sale are used to repay a secured bank loan secured. Farmers who have not been paid for grain are unsecured creditors, meaning they get paid only after secured creditors.

Unpaid Bills Mounting At New Beef-Processing Plant

ABERDEEN (AP) — Unpaid bills and contractor complaints are piling up at a \$110 million beef-processing plant in northeastern South Dakota that is scheduled to open this

Brown County records show that contractors have filed liens for more than \$1.3 million against Northern Beef Packers since Jan. 1, about \$1.2 million of which has not been

paid. Documents show the plant owes more than \$10 million from previous years.

David Palmer, Northern Beef Packers CEO and president, tells the American News in Aberdeen the plant does not have enough money to pay its bills because it has not sold all of its Tax Incremental Finance (TIF) bonds, and hasn't secured financing from other

"We have a limited amount of money and we are paying contractors doing work for us now, so we can get the plant open," Palmer said. "It is a choice we have made. The best way to get all the creditors paid is to get the plant open.'

Palmer estimates the amount from previous liens before this year to be about \$6.7


