## YANKTON COUNTY COMMISSION MEETING May 21, 2013

The regular meeting of the Yankton County Board of Commissioners was called to order by Chairman Bruce Jensen at 3:30 p.m. on Tuesday, May 21, 2013 at the Commission Chambers in the County Government Center. The Pledge of Allegiance was recited.

Roll call was taken with the following members present: Bruce Jensen, Mark Johnson, Garry Moore and Allen Sinclair. Absent: Donna Freng.

Also present at the start of the meeting were the following county officials: Poor Relief Director Jennifer Adamson and Register of Deeds Brian Hunhoff (meeting recorder).

Action 13226C: A motion was made by Johnson and seconded by Sinclair to approve the agenda with the following additions: executive session for personnel and contractual matters; and discussion of the possibility of merging the Auditor and Treasurer offices. All present voted ave; motion car-

Action 13227C: A motion was made by Sinclair and seconded by Johnson to approve minutes from the May 7, 2013 regular meeting. All present voted aye; motion car-

Action 13228C: A motion was made by Sinclair and seconded by Moore to recess the regular session and enter executive session with Poor Relief Director Adamson to discuss indigent issues. All present voted aye; motion carried.

Action 13229C: A motion was made by Sinclair and seconded by Moore to reconvene in regular

Chairman Jensen reported no action would be taken as a result of the executive session.

Government Center Security System: Emergency Management Director Paul Scherschligt said the security system at the County Government Center could be replaced at a cost of \$25,886. Integrated Technology and Security (ITS) is the vendor that provided the estimate, but there would need to be an advertisement for bids before the project could move forward. Scherschligt said a department head asked to have the current system evaluated, so he toured the building with two vendors. Their consensus was that the existing system needs to be replaced. Scherschligt said the current system's panic buttons are not working and only the Auditor's office has the capability of recording video activity in the building. The new system would feature cameras activated by motion sensors, and record activity in the building's public areas, along with all people entering or leaving the Government Center. Register of Deeds Hunhoff said department heads wished to hear a presentation on exactly how the new system will differ from the current system before the Commission takes action. Scherschligt agreed to bring a representative of ITS to a department head meeting in Pursuant to SDCL 46-2A-2, the June. Commissioner Jensen said he would also like Scherschligt to provide protocol training for the building's staff in the event of a

> 211 Program: EM Director Scherschligt, Yankton Mayor Nancy Wenande and Yankton United Way Director Lauren Hansen spoke to the Board in favor of Yankton County participating in a 211 program for Bon Homme, Hutchinson and Yankton counties. The program would allow residents to dial 211 to get information on child care, volunteer needs, health care options, employment, severe weather, disaster response, suicide prevention and many other services. Scherschligt said the 211 service would take pressure off the 911 system because fewer people would use that number for non-emergency calls. Hansen said 211 would serve as a connector for the community. Annual cost of the three-county program would be \$22,091 with Yankton County contributing \$13,462 of that amount. The cost share is based on 60 cents per resident of each county. Commissioner Jensen asked the presenters to bring the proposed 211 contract to a future meeting for additional cost-benefit analysis.

Yankton Search and Rescue: EM Director Scherschligt asked the Board to place Yankton Search and Rescue Program under his department's management and rename it Yankton County Search and Rescue. Under terms of the agreement, Search equipment would be placed in Emergency Management's inventory and become county property. Scherschligt said the change would require no additional personnel, and he would still use Search and Rescue's current leadership chain of command for dive teams, search teams and rescue teams. Scherschligt said the merger would make both agencies stronger and more cohesive. He requested the change take effect July 1. Commissioner Moore expressed support for the concept, but was concerned about the budgetary logistics of a mid-year change. Commissioner Johnson said the merger would ensure safer and more consistent funding for the Search and Rescue program. The Board agreed to ask the South Dakota Department of Legislative Audit for input and revisit the plan during June budget hear-

Generator Bid: Bids were opened at 2 p.m. on May 21, as advertised, for a generator for the Emergency Services Building. EM Director Scherschligt said awarding of the bid was inadvertently left off the May 21 meeting agenda, requiring a brief special meeting later in the week so the item can be given proper public

Action 13230OEMHS: A motion was made by Sinclair and seconded by Johnson to hold a special meeting of the Board on May 24 at 12 noon to act on bids for a generator for the Emergency Services Building. All present voted aye; motion carried.

**Emergency Services Insurance:** EM Director Scherschligt and Emergency Medical Services Administrator Steve Hawkins asked to switch current insurance coverage for their departments to Fire Pak Insurance. The two department heads said this change would save the county money by lowering the annual premium from \$24,000 to \$20,000; and lower the deductible from \$2,500 to \$250. Commissioner Sinclair said he wanted to have Roger Smith, the county's insurance agent, at the Board's June 4 meeting to hear his opinion of the pro-

of \$107,750 from Arrow Manufacturing of Rock Rapids, Iowa for an ambulance remount. The remount process involves placing one of the County's current ambulance boxes on a new chassis (cab, engine, frame, wheels). All present voted aye; motion carried.

Phone System Problems: Knology/Wow representative Paul Buriak was present to discuss several problems with the new phone system in the County Government Center. Treasurer Pam Marchand, Director of Equalization Lori Mackey, Zoning Administrator Patrick Garrity, and Register of Deeds Hunhoff all shared specific staff complaints about the new phones, ranging from poor sound quality to a problematic transfer system. Buriak said he will continue to work with Government Center staff to resolve the problems and make necessary changes.

Dog Complaint: Roger and Caro-

lyn Holtzmann appeared before the Board to request assistance dealing with neighborhood dogs that have repeatedly damaged the siding of their home along Timberland Drive, west of Yankton. The Holtzmanns said they notified the neighbor who owned the dogs, but damage to their property continued. The Board directed Zoning Administrator Garrity to send a letter to the neighbors requesting the dogs be prevented from continually damaging the Holtzmann residence. The Board also asked States Attorney Rob Klimisch and Garrity to begin the process of amending the county's nuisance ordinance to include language that specifically addresses incidents of this type.

Highway Report: Highway Superintendent Brian Gustad gave the Board an update on some of the work his department is doing, including crack-sealing on several oil roads; grading on gravel roads; sign repair and maintenance; and equipment repairs.

**Highway Entrance Application:** Supt. Gustad distributed a proposed application form for property owners who plan to build new entrances or approaches along any Yankton County highway. Gustad listed several specifications, including a minimum of an 18-inch steel culvert: clean fill dirt; and grass reseeding after construction. The application form would require exact location, a legal description, and date of installation. Gustad suggested \$75 as the application fee. Commissioner Sinclair requested the item be placed on the June 4 meeting agenda for possible Board action.
