Parkston Farmer Awarded \$1.1 Million In Case

OLIVET — A Parkston farmer has been awarded \$1.1 million against a former Watertown cattle seller for fraudulently misrepresenting the origin of a shipment of cattle to his farm.

In what investigators from the State of South Dakota's Animal Industry Board described as one of the "most complex and wideranging schemes" they had confronted, Parkston farmer Curtis Huether accused David Bisson of fraudulently misrepresenting the origin of a shipment of cattle to his farm in 2008. Bisson's fraud resulted in Huether's cattle being quarantined for approximately eight months. Huether also claimed that Mihm Transportation Co., an Iowa trucking company, was involved in a conspiracy to further Bisson's fraud.

Huether was awarded approximately \$100,000 in damages and \$1,000,000 in punitive damages against Bisson. On Friday, after a week-long trial, a Hutchinson County jury also found that the lowa trucking company committed civil conspiracy in the case.

Huether was represented by Scott Swier, Senior Partner at Swier Law Firm, Prof. LLC of Avon. "This was a complex case involving numerous 'moving parts,' so we are pleased for Curtis and his family," said Scott Swier.

Family Files Lawsuit In Man's Death

VERDIGRE, Neb. — The family of a Verdigre man killed last summer in a motorcycle accident has filed a lawsuit against Chinese product manufacturers and U.S. importers.

The suit was filed Monday in District Court at the Knox County courthouse in Center, Neb., according to a press release by family attorney John Thomas.

Mark Pischel, 54, suffered massive head injuries when his motorcycle suddenly went out of control because the rear tire abruptly went flat, Thomas said.

According to authorities, the August accident occurred on Nebraska Highway 14 near Creighton, Neb. Pischel was taken to a Creighton hospital, then was transferred to a Sioux City hospital where he died the next day.

Pischel's widow, Kim, filed the wrongful death action on behalf of her husband's next of kin, including his two children, according to the press release.

In separate remarks, Thomas told the *Press & Dakotan* that the family isn't requesting any specified amount of damages.

Dustin Pischel, the deceased man's son, offered a statement in the press release.

"My mother, sister and I want no family to suffer a loss like we suffered because a product that should be safe," he said. "Corners were cut, and unsuspecting purchasers are endangered as a result."

At the time of his death, Mark Pischel was returning home after being fitted for a tuxedo to serve as best man in an upcoming wedding, Thomas said. During Pischel's return trip, the rear tire of his motorcycle spontaneously lost its air pressure, the attorney added.

The suit alleges the tire contained a defective valve stem, like one of millions recalled by the manufacturer and U.S. importer, Thomas said in the press release.

The suit names as defendants Dill Air Control Products LLC; HFR Hwa Fong Rubber Company aka Duro Tire Company; Topseal Co., a surname or subsidiary of Shanghai Baolong Automotive Corp.; Tech International, Importer; Shanghai JMSTAR Motorcycle Co., Ltd.; New Star Technology, Distributor; and City Scooters, LLC.

The defendants are a Chinese manufacturer, a Taiwanese company with a U.S. subsidiary, a U.S.

importer, a U.S. distributor and the seller in the distribution chain.

According to the suit, the valve stem in the rear tire, like many valve stems in Chinese tires, contained defective rubber that would not withstand normal and foreseeable use and weathering, Thomas said in the release.

The rubber cracked, weakened and became vulnerable to spontaneous failure, the attorney added.

The court papers filed by the Pischel family allege Mark Pischel's motorcycle tire went flat without warning for this reason.

The lawsuit alleges the manufacturers and importers failed to adequately design, manufacture, test or assure quality standards were met before the tire and the defective valve stem were sold.

At the time of his death, Mark Pischel had worked 14 years at Mike Durfee State Prison in Springfield.

"We think it is important for people to recognize that products made outside the USA, but imported for sale here, may not meet the same rigorous safety standards as are demanded of U.S. products," Thomas said.

Don't be surprised if you see a 1929 Ford Tri-Motor (it has three engines and has been nicknamed "The Tin Goose") aircraft flying over Yankton later this month. It's not an illusion or time warp.

The Ford Tri-Motor will be visiting Chan Gurney Airport, Yankton, on June 20-23. The luxury airliner of the late 1920s is being hosted by Yankton EAA (Experimental Aircraft Association) Chapter 1029. The unique aircraft is on a tour of the Midwest and will be arriving from Quincy, Ill., on June 20 and will depart on June 24 for Mitchell.

Passenger flights will be available at Yankton on June 20 from 2-5 p.m. and on June 21-23 from 9 a.m.-5 p.m. The aircraft has 9 passenger seats and a co-pilot seat available and every seat has a window. Passengers will travel back to the early days of what was considered luxurious commercial air travel. Passengers are encouraged to bring a camera to record and share this experience. Tickets can be purchased in advance; walk-up tickets will also be available. There will even be tickets available for the copilot seat.
