The more conclusive findings announced Thursday were aided by evidence sent to the United States by France, which, along with Britain, has announced it had determined that Assad's government had used chem cal weapons.

Not all Medal of Honor recipients returned home alive.

Thursday's program honored Sue Wilson of San Angelo, Texas. She attended school with Rains in Odessa, and her brother, Alfred "Mac" Wilson, was killed in Vietnam in 1969 at age 21.

Sue Wilson held a picture of her late brother and his framed Medal of Honor. She described to the Press & Dakotan her brother's ultimate sacrifice.

'There was enemy fire and they were ambushed. He threw his body on a hand grenade," she said. "(My brother's death) just killed my mother. She died three months to the day after my brother was killed. She grieved herself to death and died of a broken heart."

Sue Wilson said she felt grateful for the support given wounded service members and seeing Harris and the 1956 Thunderbird.

"Ronnie Rains and John Folsom don't want our military to be forgotten," she said. "I feel so honored to be among this and to be part of this.'

Unpaid Internships

In Jeopardy After Court Ruling BY SAM HANANEL

WASHINGTON - Unpaid internships have long been a path of opportunity for students and recent graduates looking to get a foot in the door in the entertainment, publishing and other prominent industries.

But those days of working for free could be numbered. A federal judge ruled this week that Fox Searchlight Pictures violated minimum wage and overtime laws by not paying interns who worked on production of the movie "Black Swan." He said they performed the same work as paid employees.

The case may lead some companies to rethink whether it's worth the legal risk to hire interns to work without pay. Critics claim unpaid internships exploit young workers and drive down wages. Employers say they invest money in the programs and offer mentoring similar to vocational programs.

Assad's stunning military success last week at Qusair, near the Lebanese border, and preparations for offensives against Homs and Aleppo have made the matter more urgent.

While McCain has pressed for a greater role for the U.S. military, other lawmakers have expressed reservations about American involvement in another conflict and fears that weapons sent to the rebels could fall into the hands of al-Qaida-linked groups.

Sen. Chris Murphy, D-Conn., a member of the Senate Foreign Relations Committee, condemned the Assad regime but expressed serious concerns about the United States being pulled into a proxy war.

There are many actions that the United States can take to increase our humanitarian assistance to refugee populations and opposition groups short of injecting more weapons into the conflict," Murphy said. "I urge the president to exercise restraint and to consult closely with Congress before undertaking any course of action to commit American military resources to Syrian opposition forces."

House Speaker John Boehner, R-Ohio, also urged the White House to consult with Congress.

"It is long past time to bring the Assad regime's bloodshed in Syria to an end," he said through a spokesman, Brendan Buck. "As President Obama examines his options, it is our nope ne will properly consult with Congress before taking any action."

belts are being removed from the region, the specific number is difficult to identify, according to Rich Schwartz, the Yankton County Farm Service Agency (FSA) director. Many of the shelterbelts that exist today were planted within programs, such as the Conservation

Reserve Program (CRP), to which the landowners no longer belong.

"Lots of the shelterbelts being taken out are for the old original farm homesteads, and there isn't any cost share now," Schwartz said. "Some of them being taken out were likely in CRP, but once the CRP expires, they can do whatever they want with that land. We can't track that.

In addition to clearing more land for farming, Henderson said that there are also many other reasons for clearing out the trees.

"They can harbor varmints or can be an eyesore in some cases,' he said. "One of the biggest reasons is there aren't as many families here anymore. Many of those trees were planted by homesteaders for protection, and they just aren't needed anymore.'

Despite many shelterbelt trees being removed, Schwartz said there are still plenty of reasons to plant new ones, and financially incentives are available through the FSA.

"We do have some programs in CRP for windbreaks or what we call a living snow fence to keep snow off the road," he said.

Schwartz added that requirements and incentives vary for each situation and program. While signup for the continuous CRP continues through Sept. 30, the general CRP sign-up ends today (Friday). For more information, contact the local FSA office at 605-665-2662.

"If you're going to put in trees, we can help you," Schwartz said.
