4-H Cheating Scandal Reaches Appeals Court

MITCHELL (AP) — The 8th U.S. Circuit Court of Appeals is weighing arguments in a lawsuit stemming from a 4H cheating scandal in

The family of White Lake teenager Bayley Kroupa says she was humiliated and denied due process when she was banned from 4-H competition in 2011 for an alleged ethics violation. They're suing and seeking \$850,000 in damages.

4-H officials have appealed a federal judge's ruling that Bayley can participate in 4-H competitions while the lawsuit proceeds. The *Daily* Republic reports appellate judges heard arguments in the case in St. Paul, Minn., on Thursday and will rule later.

The Kroupa family attorney says Bayley has been denied the opportunity to win future cash prizes. 4-H attorneys say Bayley can still participate in 4-H — just not in competitions.

Suspect Injured In Police Chase In Iowa, SD

CANTON (AP) — A suspect has been taken to a hospital with what authorities say are minor injuries after a police chase that started in Iowa and ended in South Dakota.

The Thursday night chase cut a path through Lyon and Sioux Counties in Iowa and ended when the suspect crashed into a tree in

An unoccupied Lyon County Sheriff's Office vehicle was hit by the suspect's vehicle. No officers were injured.

There was no immediate word on what prompted the chase.

Man Gets Life Term For Fatal Omaha Stabbing

OMAHA, Neb. (AP) — A 63-year-old man has been given life in prison for killing his former roommate in Omaha.

Court records say Michael Juranek was sentenced on Thursday. Juranek was found guilty of first-degree murder for fatally stabbing 52-year-old Jimmy McBride on Sept. 14, 2011, in south Omaha. Officers say Juranek and McBride had gotten into a fight.

The men shared an Omaha house for a time but were evicted and were living on the streets.

Juranek also was convicted of a weapons charge.

A woman with the man told police that he went into the water at Scenic Park Campground around 4 a.m. on Friday.

Officials say the search will resume after a dive team and boats equipped with side-scanning sonar can be deployed.

Police haven't released the man's name.

University officials say the move is needed because of steadily increasing enrollment.

Plans call for Midland students to be on the Blair campus beginning in 2015 or 2016.

Mega Millions Ticket Sold In R.C. Worth \$40K

RAPID CITY (AP) — A Mega Millions ticket sold in Rapid City is worth \$40,000 in the latest drawing.

South Dakota lottery officials say the ticket matched four of five white ball numbers and the Mega Ball in Tuesday's drawing to win the game's \$10,000 third prize. The winner also purchased a \$1 option that quadrupled the amount.

The odds of winning \$40,000 playing Mega Millions are one in about 689,000. The winner has about six months to claim the prize.

Mega Millions is played in 43 states, the District of Columbia and the U.S. Virgin Islands. The jackpot was at \$29 million for the Friday

Governors Gather For Unveilings

PIERRE — Gov. Dennis Daugaard and all liv-

ing former South Dakota governors gathered Friday in the state Capitol to unveil life-size bronze statues of three former governors.

The current governor was joined by former Govs. Frank Farrar, Harvey Wollman, Walter Dale Miller and Mike Rounds to celebrate the three latest additions to the Trail of Governors project that is placing statues of former governors on a route being created throughout downtown Pierre and the Capitol grounds.

The statues being added this year feature Farrar, Wollman and Bill Janklow, who died last

year.
The statue of Janklow, who served four terms as governor, drew the biggest reaction from the crowd. It shows Janklow, who liked to take charge in emergency situations, pointing with his left hand while holding a bullhorn in his right hand as he dealt with the 1998 tornado that leveled the town of Spencer.

"In wind storms, tornadoes, floods, Bill was on the spot," Daugaard told the crowd. "Someone was out there needing his help."
Daugaard said Farrar, Wollman and Janklow

will be known for their accomplishments because they put the state's welfare ahead of poli-

tics.
"These governors were all direct, honest and candid," Daugaard said. "They knew they were governor of all South Dakota, though, and it was the quality of the idea that mattered most, not who proposed it or the politics of the person who had the idea."

The Trail of Governors Foundation plans to erect three statues each year. The first three were unveiled last year: former Govs. Arthur Mellette, Harlan Bushfield and Miller.

The South Dakota Community Foundation is handling donations for the \$2 million project. Donations now total about \$412,000.

Farrar, 84, who continues to compete in athletic events, is depicted in his statue as striding forward. The lawyer and banker is known for improving education and working on economic development when he was governor in 1969-1971.

Farrar urged the crowd to treat people kindly and trust them unless they prove them-

"Treat everyone in this room, in this city, in this country and in the rest of the world as if they are the most important person ever. If we all did that, we'd have a lot less trouble," Farrar said.

Wollman, 78, became governor for six months in 1978, when as lieutenant governor he got the job after Gov. Dick Kneip resigned to take an ambassadorship. Before that, Wollman had a long career in the Legislature. He helped rewrite constitutional provisions that reorganized state government.

"I think we have one of the greatest states in the nation," Wollman said. "Its future will be determined by the actions of ordinary people like you and like me."

Janklow's son, Russell, also spoke to the crowd, noting that his father enjoyed ceremonies for others but shied away from those

Janklow was governor in 1979-1987 and then again in 1995-2003. He cut property taxes, saved the state's rail system and put South Dakota ahead of most states in wiring schools to the In-

Neb. Christian College Expels Lesbian, Charges Tuition

OMAHA, Neb. — Danielle Powell was going through a hard time in the spring of 2011, just months away from graduating from a conservative Christian college in Nebraska. She had fallen in love with another woman, a strictly forbidden relationship at a school where even prolonged hugs are banned.

Powell said she was working at a civil rights foundation in Mississippi to finish her psychology degree when she was called back to Grace University in Omaha and confronted about the relationship. She was eventually expelled — then sent a bill for \$6,000 to reimburse what the school said were federal loans and grants that needed to be repaid because she didn't finish the semester.

Powell is now fighting the Omaha school, arguing that her tuition was covered by scholarships and that federal loans wouldn't need to be repaid in that amount. She also notes she was kicked out even after undergoing months of counseling, spiritual training and mentoring insisted upon by the school following her initial suspen-

"I shouldn't have this debt hanging over me from a school that clearly didn't want me," the 24year-old said.

The university insists that the \$6,000 covers federal grants and loans that, by law, must be repaid to the federal government because

Powell didn't finish her final semester. School officials declined to discuss specifics of Powell's case, citing federal student privacy laws, but through a public relations agency said it would provide Powell official transcripts and transfer her credits

Powell is skeptical. She noted that nine months after she was expelled in January 2012, the registrar's office denied her request for her transcripts because of the \$6,000 bill, though she eventually received student copies of her transcripts.

Grace University's code of conduct for its students is strict: No kissing, no prolonged hugs and certainly no premarital sex. The school even monitors students' television habits, forbidding HBO, MTV, Comedy Central and several other channels "because of the values they promote." The rules are laid out in a student handbook signed by students every year.

"No one was more surprised than me," Powell recalled of her relationship. "I had been very religious since I was a small child, and that did not fit in with what I thought I believed.'

It's not unusual to see gay and lesbian students disciplined or even expelled from private Bibleand faith-based colleges, but Powell's case is unusual, said Ken Upton, an attorney at Lambda Legal. The national civil rights organization helps gay, lesbian, bisexual and transgender people.

Nazi Unit Leader's Minn. Life Prompts Shock

MINNEAPOLIS (AP) — The revelation Friday that a former commander of a Nazi SS-led military unit has lived quietly in Minneapolis for the past six decades came as a shock to people who knew him, prompted harsh condemnations from World War II survivors in the U.S. and Europe, and led prosecutors in Poland to say they would investigate.

An Associated Press investigation found that 94-year-old Michael Karkoc served as a top commander in the Ukrainian Self-Defense Legion during World War II. The unit is accused of wartime atrocities, including the burning of villages filled with women and children. Wartime records don't show that Karkoc had a direct hand in war crimes, though records indicate he lied about his military past when immigrating to

"I know him personally. We talk, laugh. He takes care of his vard and walks with his wife," his next-door neighbor, Gordon Gnasdoskey, said Friday. Gnasdoskey, the grandson of a Ukrainian immigrant himself, said he was disturbed by the revelations about his longtime neighbor.

No one answered the door Friday morning at Karkoc's house on

a residential street in northeast Minneapolis, where several television news trucks were parked outside. Karkoc had earlier declined to comment on his wartime service when approached by the AP, and repeated efforts to arrange an interview through his son — including again Friday — were unsuccessful.

Sam Rafowitz, an 88-year-old Jewish resident of the Minneapolis suburb of Minnetonka, grew up in Warsaw, Poland, and spent four years working in concentration camps. He took a hard line after hearing the news about Karkoc.

"I think they should put him on trial," said Řafowitz, who was born near the border of Germany and Poland He may get his wish: Poland's

National Remembrance Institute, which prosecutes wartime crimes, said its prosecutors would investigate Karkoc's "possible role" in crimes committed by the legion and would provide "every possible assistance" in gathering evidence for the U.S. justice system. The U.S. government has previously used lies in immigration papers to deport dozens of suspected Nazi war
