Wayne E. Pibal Jr., age 52, of Mission Hill, passed away Tuesday, June 25, 2013 at St. Mary's Hospital in Rochester, Minn. from complications due to an infection.

Funeral services will be Monday, July 1, at 2 p.m. at Opsahl-Kostel Funeral Home and Crematory in Yankton with the Rev. Rod Veldhuizen officiating. Visitation with the family present will be from 4-7 p.m., Sunday, June 30, at Opsahl-Kostel Funeral Home. A celebration of Wayne's life will follow at 7 p.m.

Wayne was born Sept. 30, 1960 to Wayne and Gloria (List) Pibal at St. Vincents's Hospital in Sioux City, Iowa. He was raised at the family home near Mission Hill and was proud to say that he was one of the few people to ever attend kindergarten at the 4-H building in Yankton. He graduated from Yankton High School in 1978, where he distinguished himself in debate, oral interpretation and theater.

He attended the University of South Dakota, Springfield, where he earned a degree in drafting.

In 1981, he returned to Yankton and worked as a draftsman for Kolberg Manufacturing until 1983 when he went into business for himself, opening Speedy's Pizza at Yankton's Tripp Park Plaza. In 1984, he went to work for Syncom in Mitchell and, later, Minneapolis, Minn., until he was offered a sales position with Best Business Products in 1986.

In 1988, he opened Home Town Realty in Yankton, during which time he served as president of the Lewis & Clark Board of Realtors.

Eventually, Home Town Realty morphed into Collection Trust Collection Agency, and later added on Collection Trust Publications.

But despite his various business ventures, Wayne was best known for his editorial column "Nobody Asked Me ..." in the Yankton County Observer, which he

wrote from 2002 to 2013. His "tell it like I see it" style earned him a wide following and strong reputation as a political writer. His writing also gained statewide attention, garnering him four first place awards and four more second and third place awards in the Best General Interest column category in the South Dakota Newspaper Association's Better Newspaper contest.

reiterated in the state constitution by voters in 2006. "I guess I support that," South Dakota Gov. Dennis

Daugaard told The Associated Press on Wednesday. "I voted for it along with a majority of South Dakotans.'

The governor said he thinks marriage as an institution has a stabilizing effect on the raising of children.

"It doesn't mean the state is homophobic," Daugaard said. "It just extends some additional benefits to a married couple to help them provide a home for children.'

Attorney General Marty Jackley said South Dakota's definition of marriage, which is limited to a man and a woman, remains valid.

"After today's U.S Supreme Court decisions, South Dakota constitution and legislative enactments defining marriage to be between a man and a woman remain in effect as a matter of law,' Jackley said in a statement.

Lawrence Novotny, board president of Equality South Dakota, said he's happy that people in legal same-sex marriages will now be treated equally by the federal government.

"This decision puts that equality back in place for everybody," Novotny said.

He said the decision is not going to change anything in South Dakota, but the opinion is a good sign that the court may eventually move toward declaring state laws that ban same-sex marriage

unconstitutional. 'Work will still have to be done to get that removed," Novotny said. "That's down

lawsuit to challenge the amendment in federal court.

'We're going to get to get together, examine the decision, and look at possible ways that we could take this to court," said Shelley Kiel, president of the Omaha-based Citizens for Equal Protection. "We've also been talking over the last couple of months about a doing a statewide petition to overturn the ban to fight it out in the trenches."

Social conservatives noted that both rulings were narrowly drawn, and the Proposition 8 ruling applied only to California. They also argued that Nebraska's constitutional amendment has already survived a federal court challenge, and was passed with overwhelming support from voters.

"I can't deny that there's been a national shift, and maybe even a state shift," said Dave Bydalek, executive director of the Lincoln-based group Family First. "However, this is an opportunity to talk about why marriage between a man and a woman is such an important institution, in the marketplace of ideas, without bashing people who don't agree with your viewpoint. The critical role of man-woman marriage isn't really diminished by these rulings.

Bydalek — speaking on be-half of his group and the Ne-braska Family Council — said he still believes most Nebraskans still oppose gay marriage.

Nebraska limits marriage to one man and one woman and doesn't recognize civil unions, domestic partnerships or any other relationships between same-sex couples.
