LAKE ANDES — One of the next Lake Andes aldermen could be decided by the luck of the draw or the roll of the dice.

After Tuesday's joint city-school election, one city race remained in doubt. In the Ward III race for a two-year term, incumbent George Hazuka and challenger Todd Breen tied with 19 votes each.

The election will be canvassed at 5 p.m. June 8 in City Hall. Following the election canvass, both candidates have five days to request a recount. If the

election remains deadlocked even after a recount, state statute directs the city finance officer to determine the draw of lots to settle the race.

"You could pull a card out of the deck or throw dice," said finance officer Debbra Houseman.

The council wants to decide the winner in time for the July 6 regular meeting, Houseman said.

In the other city race, challenger Dennis Tronvold won the two-year term as Ward I alderman with 17 votes. He was followed by challenger Frank Kistler and incumbent Edwin Bruner with a respective 13 and 5

votes.

The city election drew 73 total voters for 22.5 percent turnout in Ward I and 25 percent turnout in Ward III. No provisional ballots were cast.

In the Andes Central school board race, voters re-elected three incumbents for three-year terms. Winning new terms were Terry Svatos with 108 votes, Debbra Houseman with 86 and Nicole Gray with 72. The fourth candidate, challenger Ardie Lantz, finished with 42 votes.

The current three-year terms expire June 30, according to school business manager Susan Johnson.

The school board race drew a total of 122 voters for 8.9 percent turnout. No provisional ballots were cast.

The joint city-school race used the Andes Central school gymnasium as the one polling place. With her name on the school ballot, Houseman said she stays away from the polling place much of an election day to avoid any appearance of impropriety.

"I let Susan (Johnson) head up the election. I just check in to make sure there are no problems on the city end. That way, I can't be accused of interfering,"
