Voting will take place at the National Guard Armory/Community Center from 7 a.m.-7 p.m. on June 30.

Board President Jim Brady says, www "The Board of Directors recognizes the importance of this election, especially the opportunity for each and every resident in Vermillion to have and voice their opinion. We understand the two issues on the ballot could be a little confusing because of the 'yes' or 'no' options and which each of them mean. So we want to make sure and do everything we can to have everyone educated on the issues and what a 'yes' or 'no' vote will translate to mean."

This is a simplified explanation of those choices.

1. Malt beverage 5 percent markup fee on the wholesale cost to help pay for a portion of city bond debt (Prentis Park Improvements Project). The bond issue was overwhelmingly voted for by Vermillion voters in Nov. 2014. a. YES vote = Repeal the ordinance and do

not generate funding support for the bond/ Prentis Park Project.

b. NO vote = Keep the ordinance as adopt-

ed by City Council and collect the 5 percent markup on malt beverages to help support the bond/Prentis Park Project

2. Day-care regulations in Vermillion. (Registration, safety requirements, building & fire codes, not listed on the sex offender registry.)

a. YES vote = Adopt the ordinance passed by City Council.

b. NO vote = Do not adopt the ordinance. The VCDC Legislative Affairs Committee is sponsoring an open forum at the Vermillion City Hall, Council Chambers, on Tuesday, June 23, from 6-8 p.m. The forum is open and encouraging to the public to attend. The purpose of this forum is to provide the public an opportunity to ask questions to advocates representing both sides of opinion regarding these two ballot topics, and to clarify any mistaken facts involved with each issue. The forum will also be televised on local Channel 3.

You can also go to Vermillionís web page www.vermillion.us to find a link that will provide factual information about both issues; OR, anyone interested in the text of these issues can go to the City Finance Office for a sample ballot. Absentee voting is currently open and can be done any time during business hours at City Hall leading up to June 30.

Farmers' Market Nutrition Program Set

The Nebraska Senior Farmers' Market Nutrition Program (SFMNP) provides low-income senior citizens with coupons to purchase fresh produce or honey (pure only) at Nebraska farmers' markets and roadside stands.

The purposes of the program are to provide fresh, nutritious, unprepared, locally grown fruits, vegetables, herbs and honey to low-income seniors and increase the consumption of agricultural commodities by expanding or aiding in the development of new farmers' markets and roadside stands. Nebraska's SFMNP State Plan of Operations was officially approved early in the year, allowing the state to continue the operation of this program for 2015.

In order for the participants to be eligible for the program, individuals must meet categorical and income eligibility requirements. Categorically, participants must be 60 years of age or older. Income is measured in one of two ways. An individual, single household's gross income cannot exceed \$21,589.50; a two-person household's gross income cannot exceed \$29,100.50. Older adults wanting to be considered for the program may be asked to provide documentation showing age and income eligibility at the time of registration.

Older adults enrolled in the program will receive SFMNP coupons, which they will be able to exchange for fresh, nutritious, unprepared, locally grown fruits, vegetables, herbs and/or honey at registered farmers markets and roadside stands. Coupon distribution will start in June and may run through September. Coupons must be spent on or before Oct. 31, 2015. Coupons will be available through participating Area Agencies on Aging, local senior centers, and local Commodity Supplemental Food Programs' distribution sites.

Because appropriations are limited, services will not be provided in every community, and not all eligible seniors may be served. If additional funding appears likely, waiting lists may be used.
