han Jaime-SantaCruz, a Level 4 coach at the Yankton complex. “Now that we’ve seen how the community came out to support these events, we thought it would be an additional experience for Yankton and for these archers to come in,” she said.

The host family would be responsible for providing Cezair with a place to stay (a single or double occupancy

said would give the family an opportunity to take Cezair with them to various community events — perhaps including the upcoming Fourth of July festivities.

“I know that five weeks is a long time; that’s a big commitment for any family,” Santacruz said. “But we’re just trying to reach as many people as we can, for this summer or for future programs.”

Yankton has welcomed international archers in the past (and not just for tournaments), and Santacruz had earlier extended an invitation to Cezair — the coach has known the family for a few years.

“I told her if she was ever interested in training, I’d be more than happy to have her come here,” Santacruz said. “And they immediately jumped on it. They’re so eager for her to improve her skills.”

Ideally, the five-week stay in Yankton would provide Cezair with the necessary tools when she returns home to compete in the Open Outdoor National Tournament.

Trinidad and Tobago sent one archer to Yankton for the Youth Championships two weeks ago, proof that the sport is growing in the Caribbean island nation.

“Archery in all of Latin America has been growing for the past 10 years,” Santacruz said. “Mexico has been leading a lot of it, but countries in the Caribbean have really taken it up.”

Now, they’ll have the chance to train in Yankton, which boasts an indoor range and two Olympic-sized outdoor ranges.

“The objective of a facility this size is for other countries to bring teams and for individual athletes to come train,” Santacruz said. “They would have access to all the facilities and feedback from the coaching staff here.”

Having an international visitor to Yankton would also ideally educate the community on the facility that is becoming an attraction to worldwide archers, Santacruz said.

“One of the things that we need to do more of as a center is expose the community to the caliber of facility we have,” she said. “A lot of people don’t understand that this center is the biggest one in the country.

“Even the Olympic Training Centers aren’t as comprehensive as this center is.”

# Keystone XL Pipeline Public Input Session Scheduled

PIERRE — The South Dakota Public Utilities Commission will hold a public input session Monday, July 6, to hear comments about the construction permit certification for the South Dakotaportion of the Keystone XL Pipeline proposed by TransCanada Keystone Pipeline, LP. The session begins at 5:30 p.m. CDT in Room 414 of the State Capitol in Pierre and will adjourn no later than 8:30 p.m.

Individuals offering oral comments to PUC Commissioners Chris Nelson, Kristie Fiegen and Gary Hanson should be prepared to follow these guidelines:

- A commenter must state his/her name, address and organization, if any.
- In order to provide equal speaking opportunity, a five-minute time limit will be allowed for each commenter. A commenter may not yield remaining time he/she may have to another speaker.
- Commenters should not read published documents, such as reports or newsletter articles, as part of their verbal comments but rather submit those items to the commission to become part of the public record for this docket.

The PUC will accept written comments at any time, including at the public input session. Public comments must include the commenter’s full name and address and should include the docket number (HP14-001) or the project name, as well as the commenter’s email address and phone number, if available. These comments can be sent to puc@state.sd.us; PUC, 500 E. Capitol Ave., Pierre, SD 57501 or delivered to the PUC at the public input session. The comments will be filed in the docket.

An evidentiary hearing for the Keystone XL Pipeline construction permit certification is scheduled for July 27-Aug. 4 in the State Capitol in Pierre.

ed with two different budgets by Highway Superintendent Brian Gustad.

“One was a big number with a lot of improvements to be done on the highways — roughly around \$6 million. And then another around \$4

million and that’s just taking care of a some bridges without doing any overlays,” the chairman said.

The \$6 million budget called for seven miles of new asphalt overlays, which Woods said can run up in cost very quickly.

“It’s been several years since there’s been any overlays throughout the county,” he said. “It’s roughly \$200,000 to do an overlay, and we have

a lot of miles to do and not a lot of funds to pay for it all.”

A preliminary budget must be submitted to the state by Aug. 1. The commission will hold a second budget meeting June 29 in the commission chamber of the Yankton County Government Center at 4 p.m.

# Youth Trooper Academy Held in Pierre

PIERRE — A group of South Dakota teens this week is learning what it is like to train as an actual recruit to the South Dakota Highway Patrol.

The fourth annual Youth Trooper Academy is being held at the Mickelson Law Enforcement Training Center in Pierre. It is sponsored by the Highway Patrol and the South Dakota American Legion.

This year’s Youth Trooper Academy includes 19 young adults, ages 16 and 17, who are starting their senior year in high school this fall. They were selected by representatives from the Highway Patrol and American Legion.

Maj. Rick Miller, assistant superintendent of the Highway Patrol, says the academy features the same training as required for the regular Highway Patrol recruits.

“This week, these young men and women are going to experience the high standards set for Highway Patrol recruits and what it means to become a Highway Patrol Trooper,” he says. “This also is a chance for current Troopers to interact with some exceptional young people.”

The academy started Monday and will end with a graduation ceremony Friday afternoon. During the week, the recruits will undergo classroom and hands-on training in areas such as firearms safety, defensive driving, crash investigation, traffic stops, leadership, police service dog handling, citizenship and criminal law. Each day, the academy recruits have a flag raising ceremony at 7:45 a.m.

Veteran Highway Patrol troopers will serve as mentors and leaders. Troopers and officers from other law enforcement agencies will be the instructors.

Larry Price, a past state American Legion Commander, is Vice Chairman of the Americanism Commission of the national American Legion. He says the Youth Trooper Academy is an important Legion youth program.

“We look forward to this program every year,” Miller says. “We also are pleased to work with American Legion on such a worthy project.”
