Turner County has set flooding records, Gillespie said. Davis broke a 1969 record for the Vermillion River, but the water has receded from the town, he said. "Things have settled down,"

Gillespie said. "We are in recovery (mode) right now.' The state Department of Transportation announced Thursday that Highway 18 west of Davis and Highway 46 at Centerville are now open.

However, another section of Highway 46 northwest of Lesterville has gone under water. The highway is now closed for two miles from mile marker 323 to 325. In addition, Highway 44 east of Parkston has been closed between mile markers 362 and

The National Weather Service has continued its flood warning for the James River. The river near Scotland is expected to hit 19.8 feet by 7 p.m. today (Friday). The flood stage is 13 feet, and the record stage is 20.5 feet.

The flood warning also continues for the Vermillion River, which has a flood stage of 14 feet. Near Wakonda, the river will remain near 17.3 feet through today. At Vermillion, the river will crest near 26.7 feet by today and fall below flood stage (21 feet) Wednesday.

During Thursday's conference call, state officials provided an

update on flooding efforts. The Vermillion River may have seen its worst flooding, according to Todd Heitkamp with the National Weather Service in Sioux

"We don't expect things to worsen along the Vermillion River," he said. "We believe the highest water levels are already past. There may be a secondary crest that's not as high as the pre-

vious crest.' The situation is different for the James River, Heitkamp said. "With the James, you're talking a lot of water that is still yet to

come down across the state," he said. "The James River will remain high for a long period of time. That's the typical James.' Because the James River

moves so slowly, water could take weeks to move through the basin, Heitkamp said. He advised against assuming the river will act the same from one part of the valley to another. "We can't translate (river lev-

els) from one area to the other and expect it to be at the same level or higher," he said. "Just because it's 27.5 feet at Redfield doesn't mean it will be 27.5 feet at

out eastern South Dakota, said state Transportation Secretary

Darin Bergquist. "We are seeing, particularly in the southeast part of the state, a number of roads closed due to the volume of water going over the road," he said. "We are also dealing with periodic ice jams across structures. Fortunately, they have not been all at one time, and we were able to move and respond by the next time

(another ice jam) occurs." The state's Emergency Operations Center (ĔOC) has been collecting flood information and coordinating responses across the state, said Kristi Turman, director of the South Dakota Office of Emergency

Management. For the first time, the EOC has added an aerial survey to its flood monitoring, Turman said. Flights are conducted three times daily over the James, Vermillion and Big Sioux rivers.

"That has been invaluable to us in making decisions and pre-

planning," she said. The South Dakota National Guard (SDNG) stands ready to respond to emergency calls, said Maj. Aaron Jordan, the SDNG director of military support. The units have worked mostly with search-and-rescue preparation and hauling engineer equipment

and other assets, he said. Meanwhile, the weather forecast calls for a major change that will affect the flood watch, Heitkamp said. This week's temperatures in the 50s and 60s will give way to a cold front, dropping

the mercury to the 20s, he said. "The cooler temperatures will work in our favor as far as slowing the snow melt even more," he said "The flow of the rivers will slow as

well. A storm system is predicted to move into the area today, mainly affecting the southern one-third of the state and bringing snowfall to the extreme south, Heitkamp said.

Gusts will reach up to 30 mph. "For areas where people live along the lakes, that may cause some ice problems," he said. "The thing to our advantage with this, a lot of ice remains on the lakes. The ice remains very thick. The winds may not be strong enough or sustained for a long enough period of time to cause additional problems in those areas."

Another storm system is expected to move into the area Monday through Wednesday, Heitkamp said. The storm system could bring a mix of rain and snow, but substantial

precipitation is not expected. The flooding may be receding in some areas, but state and local officials are remaining vigilant, Turman

"We are by no means out of the woods yet with the flooding events," she said. "We continue to ahead of the situation as best we

see if you can get grant money, or is the smart thing to do to go after this long-term loan?" he said. "We're certainly not going to do something that the people who live along the ditch and pay taxes into that district don't

want us to do.' The assessment for property owners along the proposed project generates about \$12,000 per vear, according to Yankton County Auditor Paula Jones. The fund currently has approximately \$100,000 in it.

Commissioner Mark Johnson estimated that payments on a \$245,000 loan over 40 years at 4 percent would be less than

\$7,000 a year. "It seems to me that it's certainly affordable with the revenue you have now," Johnson said.

Yankton County State's Attorney Rob Klimisch is currently in discussions with the South Dakota attorney general's office to see if the County Commission, acting as the County Ditch Board, can act as the borrowing entity for the proj-
