did with the first guidelines that were passed last year.

The first time around, I think there should have been more time for people to prepare for the changes," she said. "These proposals right now probably won't go into practice until the 2014-15 school year, so it gives us a year to prepare for them."

Officials would monitor schools by visiting them to validate what's going on and to make sure they're following the guidelines. However, Kramer doesn't believe local governments would have the time available to monitor local schools' food programs.

They are expecting us to monitor the things going on outside of the food program, and as the food director at YSD, it would be tough for me to monitor what goes on outside of the cafeteria schools," she said. "The rest of the school would likely need to get involved to monitor that.'

One aspect of the guidelines that Kramer is worried about is the industry having to come up with new product sizes to fit the regulations proposed. She said the amount of products that the food industry sells to schools is small in comparison to stores, and they may refuse to change in order to accommodate the new guidelines.

There are a lot of questions still out there on all of the proposals put forward," she said. "One of the biggest challenges we are going to have comes in 2014, when the sodium caps go into effect. The USDA extended the unlimited meats and grains into next year, which helped, but the calorie limits have not changed.

One of the things that Kramer has been preparing for is the new rules that will go into effect next year on school breakfast options. Students will be required to have a full cup of fruit and vegetables, compared to a half-cup

now. Kramer said a lot of schools are looking into not serving any proteins next year in order to stay within the calorie limits. She said certain proteins won't count for any of the guidelines, and schools will already have added costs with the additional fruits and vegetables, so some might choose to not serve some proteins.

"I believe that protein is an important part of breakfast, and carbs help breakfast last longer than a bowl of cereal would," Kramer said. "Breakfast items next year will all have to be 100 percent whole grain, which YSD has been serving at least 51 percent whole grains.'

She added that some of the standards won't be fully implemented until 2020, and it's a gradual adjustment with the sodium and whole grain guidelines. She said the sodium caps will be the most difficult for her to adjust to.

Kramer believes impacts of the new guidelines are already being seen across the country.

"I hope the school lunch restrictions make kids more aware of what they're eating," she said. "The guidelines might be able to impact a full generation of kids knowing how to eat healthy, and hopefully they'll accept it and know that it's good for them."

Kramer added that some states that have been working on the new guidelines are already beginning to see lower obesity rates. She said the new standards, along with the programs out there to help kids get more active and eating healthier, could lead to a generation of kids that live longer.

"School lunches aren't as simple as they used to be when you could just count fruits, grains and vegetables," she said. "The first year of changes went pretty well and kids have gotten used to it. As a whole, more fruits and vegetables are being consumed, which is a good thing. Change just takes some time and getting used to."

"The question is, are we going to achieve these savings through badly designed spending cuts that make no attempt whatever to distinguish between more sensible government spending and less sensible spending?"

Sen. Patty Murray of Washington said that was precisely what Democrats had tried to do by proposing the deferral of Pentagon cuts until U.S. combat troops have come home from Afghanistan in two years' time.

At the same time, she said the Democrats had reasonably proposed replacing half of the pending cuts with higher taxes on "the wealthiest Americans and biggest corporations.'

In fact, the Democratic measure also included small increases for a variety of small programs such as biodiesel education, assistance for biomass crops and certification of organic foods.

Boehner and House Republicans show no hurry to alter the cuts, contending they provide leverage with Obama in their demand for savings from government benefit programs. Yet they are expected to launch legislation next week to replenish government coffers after current funding expires on March 27, and that measure

package that has been more than two agonizing years in the making.

"The objective here ought to be not just to deal with sequester but to deal with the underlying spending problems, which require tax reform" as well as reform of benefit programs like Medicare, Medicaid and Social Security," said Sen. Rob Portman, R-Ohio.

Democratic senators emerged from a lunch with Transportation Secretary Ray LaHood and top Pentagon officials and said the current cuts could not be allowed to stand.

Sen. Chris Murphy, D-Pa., said the session had confirmed to him that as currently constituted, the cuts were 'a really, really dumb idea.

In a cycle of crisis followed by compromise over the past two years, Obama and congressional Republicans have agreed to more than \$3.6 trillion in long-term deficit savings over a decade.

None of the savings to date has come from the big benefit programs that lawmakers in both parties say must be tackled if the country is to gain control over its finances. Each party fears the political fallout of confronting them on their own, but Democrats, in particular, are reluctant to scale back programs that they count as their political birthright.

Their rival speeches on the Senate floor weren't the first time that

programs. Large parts of the budget are off-limits, including programs for veterans, Social Security and Medicare benefits.

The Republican alternative would have required Obama to propose an alternative that relied exclusively on spending cuts, ruled out tax increases and limited what he could take from Pentagon accounts.

The Democratic measure would have canceled the \$85 billion in cuts, and replaced them with a combination of tax increases and cuts to defense and farm programs that would phase in over a decade. Deficits would have risen by more \$42 billion in the first year and \$38 billion over the two following years before gradually beginning to decline.

While the White House has issued a steady stream of severe warnings about the impact of across-the-board cuts, the president said Wednesday night, "This is not a cliff, but it is a tumble downward. It's conceivable that in the first week, the first two weeks, the first three weeks, the first month ... a lot of people may not notice the full impact of the sequester."

Building South Dakota Fund, which would be used support housing, infrastructure, workforce development and other programs needed to spur economic development.

The special fund also would get a portion of unclaimed property the state receives from abandoned bank accounts.

The legislative leaders said they do not know how much money would wind up in the special fund because there's no way to predict how many projects would contribute contractor's excise tax payments each year. They said unclaimed property receipts also vary from year to year.

Senate Democratic Leader Jason Frerichs of Wilmot said the sales tax breaks could be used to encourage manufacturing, wind power projects and agricultural processing plants. The state needs to boost development in rural areas, he said.

South Dakota now has no incentive program because a previous program that refunded construction taxes for

big industrial projects was allowed to expire Dec. 31. A replacement plan suggested by Gov. Dennis Daugaard was rejected by voters in the November election. The governor's plan would have taken money from the contractor's excise tax to be used for discretionary grants to companies that would not have located in South Dakota without those incentives, but opponents said that would have used money that should instead be spent on education and other priorities.

The legislative leaders said their new plan would be funded largely by contractor's excise taxes paid by companies that would not come to South Dakota without the program. The state also is getting more unclaimed property funds because a large bank has moved to South Dakota and the state has changed its laws. Banks used to give the state unclaimed deposits after five years when owners could not be located, but the new law shortened that to three years.

the measure before the main run of the legislative session ends late next week.

Senate President Pro Tem Corey Brown, R-Gettysburg, said South Dakota not only charges its 4 percent state sales tax on construction projects, but also a 2 percent excise tax on a contractor's gross receipts. South Dakota is one of only a few states that have a contractor's excise tax, which means construction is cheaper in states with no such tax, he said.

The plan would refund part or all of the state sales tax paid by projects of more than \$20 million that would not locate in South Dakota without such an incentive. The contractor's excise taxes paid by those projects would be placed in a special account, called the
