ing in our home so Corey didn't have to be gone for a long time."

The partnership between Corey and the canine has gone much better and faster than the Briests imagined it would.

"There is an amazing bond between Corey and Baker," Jenny said. "(Baker) became an instant friend with Corey and has gone most places with him. He is very focused."

While Baker has provided a new avenue for Corey, the Briests haven't traveled an easy road.

Corey's injuries left him legally blind and affected his speech, balance and short-term memory. After initial treatment in Washington, Corey underwent two years of stateside treatment in Minnesota and California before returning to Yankton.

Jenny remained with him throughout his treatment, making occasional return trips to Yankton. She credited a number of caring professionals who provided outstanding treatment.

While her husband's life definitely changed, Jenny also found herself becoming a more outspoken person. The first challenge came immediately, when she received assistance from then-U.S. Rep. Stephanie Herseth Sandlin (D-S.D.) in obtaining a flight to Germany to see Corey.

Jenny continued to speak up for Corey's needed medical care. She credited South Dakota's senators, Democrat Tim Johnson and Republican John Thune, with providing assistance and support.

"I'm not the same person I was before all this started. I went from being quiet to assertive," Jenny said. "A lot of people say, 'I'm not able to do this.' But you are able to do it. You need to step up and ask questions. You need to fight for what you need."

One of the biggest joys came when the couple returned home for good in 2007. They were greeted at the Yankton airport by hundreds of family, friends and strangers. Corey received a rousing ovation at the welcome home ceremony in the Summit Activities Center gymnasium.

"We have a community like no other," Jenny said. "They welcomed us and stood behind us."

Corey also received his Purple Heart, a long-awaited moment that Jenny refused to compromise.

"They always wanted to present Corey with his Purple Heart in the hospital, but he was in a coma," Jenny said. "Corey earned this, and he deserved a special ceremony and recognition."

The Briests were also greeted with a new house in Yankton, built and financed by \$285,000 in donations from across the nation. The effort worked with the "Operation Opening Doors of South Dakota" organization and received national attention.

The new home accommodates Corey's accessibility needs, including an elevator. Sen. Johnson, who suffered a brain hemorrhage and faces his own accessibility issues, toured the Briests' home and marveled at its special features.

The Briests remain strong advocates for all "wounded warriors." Through the years, the couple appeared on CBS' "60 Minutes" and "The Oprah Winfrey Show."

The Briests have also befriended network television correspondent Bob Woodruff and his wife, Lee. Bob suffered traumatic brain injuries in January 2006 while covering the Iraq War for ABC News. The Woodruffs wrote a book detailing Bob's recovery, and they founded the Bob Woodruff Foundation (ReMind.org) to assist wounded soldiers and their families in receiving needed care.

Lee spoke at the Goodwill Industries banquet in Sioux City in April 2008, where she met the Briests beforehand and recognized the couple

during the program. The Woodruffs and Briests remain in touch.

"Lee's my girlfriend," Corey said playfully.

Lee Woodruff has offered simple yet life-changing advice about life's priorities, Jenny said.

"Lee said, 'You learn to leave the dishes in the sink. Your family is much more important.' She also advises you not to go to bed mad or to sweat the small stuff," Jenny said.

Corey continues to receive physical, speech and occupational therapy at Avera Sacred Heart Hospital in Yankton. He takes training and works at Ability Building Services (ABS) and Truxedo in Yankton. He also takes "Brain Power" classes that cover current events and keep him mentally agile.

In addition, Corey attends his children's activities and enjoys the outdoors. He takes part in the annual poker run and fireworks display dedicated to a fallen Charlie Battery member, Sgt. Richard Schild of Tabor.

Corey faces physical challenges and becomes frustrated at times, but he has remained seizure free for more than two years, Jenny said.

"Every Dec. 4 (the anniversary of the Iraq ambush), we celebrate 'Corey's Alive Day' at our house," Jenny said. "We celebrate his achievements of the past year, and I thank every day that he's with us."

Corey plans to stay active for years to come.

"He plans to walk his daughter down the (wedding) aisle some day," Jenny said. "He wants to be with us every day."

And every day remains a gift, with no looking back, Jenny said.

"We can't change the past," she said. "But we are focused on what we can do to make it better for the future."

applying levies.

"Maybe we'll have to take (the money owed) out of our contingency (fund)," Moore said.

In another case, commissioners had to rescind a motion approved last fall to institute a levy on Turkey Valley Ditch Association members for maintenance of the drainage ditch.

"The taxes were levied, we believe, incorrectly because it was only levied on properties that actually had the ditch going through it," Commissioner Mark Johnson said. "Those taxes need to be levied on everyone (in the association) equally. Since we can't go back and levy taxes on everybody else, we need to rescind the motion and abate the taxes for those who were levied this year."

Commissioners also approved a motion to have the auditor's office send a letter to those landowners who were incorrectly levied, informing them that an abatement is available.

In other business Monday, the commission reluctantly rescinded a motion from last September to forfeit the bond for Vermillion construction company LRC, Inc.

It was awarded a \$276,000 bid to construct the Deer Boulevard Trail from south of Highway 52 to the Missouri River in August 2010. However, the County Commission was not satisfied with the end result. One of the largest concerns is soft spots in the base that will likely lead to asphalt failure.

The company had agreed to come back in the spring or summer of 2012 to address the issues but no work was completed.

Laurie Schultz, administration program manager for the South Dakota Department of Transportation, advised the County Commission Monday that it should give LRC until July 1 to complete the work. Doing so would mean that the county had followed its contract with the company to the letter and, therefore, any risk of having to pay back the sizable chunk of federal funds obtained to construct the trail would be nullified.

The commission was vocal about its displeasure in having to give LRC another chance on the project. Moore expressed his distaste by casting the sole vote against rescinding the aforementioned motion.

The commission also instructed Johnson Engineering, its engineer for the project, to create a list of items LRC needs to address on the trail.

Also Monday, the commission:

- gave permission to Highway Superintendent Brian Gustad to contract with D-Ware, Inc., for up to \$2,500 annually for a cost accounting and asset management program, as well as a sign inventory, management and reporting system;

- was told by Gustad that spring weight limits are now posted;

- approved an amendment to the Yankton County Personnel Manual related to the Highway Department. It makes changes that Gustad and the commission believe will save money, such as having the work week extend from midnight Saturday through 11:59 p.m. Friday and allowing the superintendent to send employees home once a 40-hour work week is completed;

- announced that a hire was made for the Auditor's Office contingent on a background check;

- approved an amendment to the county burn ban ordinance;

- approved the issuance and sale of bonds in the maximum principal amount of \$148,000 for work on the Yankton-Clay County Lateral Drainage Ditch No. 2; and

- renewed a contract with Hutchinson County for housing its prisoners.
