"(That) is going to be the cheapest site. There is no way around that," said Kyle Goodmanson, the city's environmental services director. "It was designed in 1972 with the idea of adding on to the east side.'

However, as the planning process for a new plant intensiied last year, the City Commission opted to have a study done to evaluate other potential sites.

The results of that research, which was conducted by HDR. Inc., was presented to the com-

mission this week. Four sites were included in the study:

 Option one is adjacent to Water Treatment Plant No. 2 and is estimated to cost \$28.7 million. The water plant would be constructed partially into the side slope, and the height of the building is anticipated to be similar to the existing facility. Not only does this site allow the new plant to utilize existing infrastructure, but it would allow interconnection with Plant No. 2;

 Option two is just north of Water Treatment Plant No. 2 along Levee Street and east of the Meridian Bridge. It is estimated to cost just more than \$29 million. Goodmanson said that site would be a tight fit for the plant, and it would end up being so close to the Meridian Bridge that people could probably jump on to the roof. Additionally, an environmental investigation would have to be done. In the 1990s, the area was evaluated for potential waste products based on industry practices for coal gasification in the early 1900s. However, there is no evidence that a subsurface investigation was done at that time. HDR predicts that the environmental study could cost \$150,000 (which is included in the aforementioned estimate for building at the site) and delay water plant construction for a year or more. If the site is contaminated, clean-up could cost much more and delay construction longer:

• Option three is at Paddle Wheel Point in the vicinity of where the city plans to

construct a collector well. The estimated cost of building there is between \$37.1 million and \$43.2 million, depending if dedicated raw water transmission mains or a common raw water transmission main is built be-

tween the new plant and Plant No. 2. According to the study, the advantage to locating the water treatment plant at this site would be space, as there are approximately 57 acres of cityowned property. Additionally, other water department services could eventually be relocated there, including management offices, distribution system equipment storage

and maintenance facilities. A concern is that other facilities in that area have experienced settlement during and after construction. Stabilizing the foundation of the plant with piling or some other technique would be recommended; and

• Option four is the industrial park near the intersection of Alumax Drive and Bill Baggs Road. It is estimated to cost \$45.7 million. The study states that construction of the water treatment plant in the industrial park could provide companies with easy access to high-quality water. The construction needs would be similar to that at the Paddle Wheel Point site, except it would need an additional 8,000 feet of raw water transmission main. Similarly, treated water will need to be transmitted another 8,000 feet or more back to the city to connect to the existing distribution system.

Commissioner David Knoff was the loudest advocate for discussing alternatives to option one.

"I have a real concern about putting a 50- to 70-year building in the middle of our best park, he said. "We'll be dead before this thing has used up its life. I think we should look further.

"I think the citizens would be happy to have that plant in a different location," Knoff added. "I think there is potential backlash if we put the plant right in the middle of the park. Commissioners Charlie

Gross, Jake Hoffner and Craig Sommer also expressed reservations about building adjacent to Plant No. 2.

However, Sommer

acknowledged the additional costs associated with other sites were a major hurdle.

Conceding that the plant would likely be built at Riverside Park, he said, "We re-zoned a lot of that area down there to get new development. I think we need to be cognizant of the fact that the building has got to be as low profile as we can make it and as aesthetically appealing as we can make it if it's going to go there.'

For Mayor Nancy Wenande, it came down to funding.

"Looking at the options as presented tonight, there were some pros and cons to each of them, but I think as commissioners we still need to be very cognizant of the dollars that are associated with all these other options," she said. "Knowing we probably aren't going to be able to go out and get a lot of additional grant money it's probably going to, for the most part, fall on the backs of our citizens who are water users. With that being said, I'm somewhat uncomfortable exploring a lot of other options that are going to put a lot of the cost on taxpayers and water users.'

Commissioner Pauline Akland expressed concern that if the project is delayed any longer, it could result in higher costs.

Mark Wenzlaff, who lives just north of Plant No. 2, told the commission he was concerned that a new industrial facility is being added to the park and next to areas that have been rezoned for residential uses in recent years.

Yankton resident Ed Gleich said he thought the Paddle Wheel Point location would offer the best long-term

Ultimately, the commission took no action on the presentation — essentially giving staff permission to continue with plans to build adjacent to Plant No. 2. According to the current timeline, the new plant would be finished in the spring of 2017 at the earliest.

'The more times you bring an animal (out), the more it increases the risk of the

spread of a disease," she said. Concern about the virus led to the cancellation of the South Dakota State Fair's 4H

cause it requires an early weigh-in and increases the risk for animal comingling. Exhibitors also can participate in the state fair without going first to a county fair, which will reduce the amount of interaction between pigs.

In North Dakota, where PED was confirmed in a swine herd in the eastern part of the state in late February, state animal health officials have expanded rules for all pigs moving within the state, including those shown at county fairs and the state fair.

"People, without moving a pig at all, can be moving PED between fairs in different states," said state veterinarian Susan Keller.

Any pigs brought into the state for exhibition must have a permanent identification, such as a tattoo, and also a second approved tag, such as a U.S. Department of Agriculture metal tag. Pigs moved within North Dakota also must be tagged, though the requirements are less strict, she said.
