NOAA's Office Of Education Issues Request For Applications To Strengthen Enviormental Literacy

WASHINGTON - NOAA's Office of Education has issued a request for applications for projects designed to strengthen the public's and/or K-12 students' environmental literacy to improve community resilience to extreme weather events and environmental changes.

Successful projects will advance NOAA's mission and build the environmental literacy necessary for community resilience by focusing on geographic awareness and an understanding of Earth systems and the threats and vulnerabilities that are associated with a community's location.

Eligible applicants are limited to institutions of higher education; other nonprofits, including informal education institutions such as museums, zoos and aquariums; K-12 public and independent schools and school systems; and state, local and Indian tribal governments in the United States

Proposed projects should be between two and five years in duration and have total budget requests of \$250,000 to \$500,000 for all years of the project.

The deadline for applications to this funding opportu-nity is 11:59:59 pm EDT on April 13, 2015. Applications

The Mount Marty College club trap shooting team recently received grant funds from the MidwayUSA Foundation, a public charity working to provide financial support to youth shooting teams through its Team Endowment Account Program. The Mount Marty College club trap shooting team began in March of 2014 and was the first institution of higher education in South Dakota to introduce the sport at the collegiate level. The club team consists of men and women shooters and holds their practices and local competitions at the Jim River Trap Range in Yankton.

Grants totaling over \$1.4 million were sent to 475 youth shooting teams in this most recent grant cycle. Teams are eligible to apply for a grant once per year and can grow their Team Endow-

The 2015 Student Research Poster Session runs from 11 a.m. to 3 p.m. Thursday, March 5, in the State Capitol Rotunda. The public is invited to attend, and enjoy ice cream courtesy of South Dakota State University.

The 16 represent students statewide who are pursuing research in a variety of disciplines.

'We look forward to introducing lawmakers to a group of very creative and industrious students, all of them in the pursuit of new knowledge," said Jack Warner, executive director and CEO of the South Dakota Board of Regents, which helps sponsor the event. "We want state policymakers to directly meet the beneficiaries of their research investments. At the same time, these students have the unique opportunity to learn more about the impact of public policy decisions on higher education.


