**I have lived here in the Yankton Area since:** We moved to Yankton from Mitchell, SD in the fall of 2011. My husband needed long term care, and our son and his family live in Yankton, so we selected the Sister James Care Center.

**I began volunteering:** In 2011, at Sister James, where my husband was residing. The need was and still is great at the facility. In the fall of 2012, I began, in addition, volunteering at the Lincoln Elementary School, where our grandsons attend.

That year I volunteered in four different classrooms. In 2013, I cut that down to three rooms, and in 2014, that became just two rooms. I had been a teacher for 34 years, and felt I wanted to watch our grandsons learn, and volunteering to assist in their school was the way to do that.

**I continue volunteering because:** The need is so great at both the Elementary School and at Sister James. Watching and helping children develop the academic skills to survive and be successful in today's world is very satisfying. Assisting the residents at Sister James in many ways is like assisting in an elementary classroom. Yes, there is an age difference but there are many similarities. The smiles you get when you help someone in need are well worth the effort of volunteering.

**I volunteer at (list organizations and duties per-**

**formed):** Lincoln School, mainly 2nd and 4th grades. I perform any duty the teachers may need help with but mainly in the area of reading. This year I have had the privilege of assisting a child learn the English language. I have found it to be the most rewarding teaching I have ever done. I am so grateful to Mr. Struck and Mrs. Hoelsing for allowing me that privilege. I assist at Sister James by creating place cards for the dining tables, and assisting during meal times. At my church, The United Church of Christ, I serve on the Missions Board, assist with Church School, and serve as a Pastoral Partner.

**Approximate hours per year that I volunteer:** This year, assisting the student with the English Language, I am at the Elementary School about five hours a day, five days a week. To be very honest, I have no idea how

many hours a year I have volunteered, but I know that this school year so far I have helped out over 550 hours. I can honestly say 550 hours very well spent. Rewording a well-known phrase, my motto is: "Have I helped someone today?"

**Volunteer work is enjoyable because:** When I volunteer at the Elementary School, it gives the teacher more time for the daily instruction of the classroom, which increases the quality of education for our grandsons. If I can use my skills, to assist someone, that is a valuable use of my time. The smiles of thanks from the children or the elderly help me feel useful, needed and that I have a purpose in my daily life.

**My best volunteering experiences:** As I stated earlier, helping an individual student learn the English language, who was non English speaking, would be my best experience. I can only imagine the feelings of this child, never having been to any school, and coming to Yankton, not knowing the language. The small part I have played in changing this child's life is an experience I will never forget. I have gained so much from this volunteering experience.

**The advice I would give to those thinking about getting out there and volunteering in their communities is:** START TODAY! That card game can wait, and so can that dust on the end table. Somebody needs your help, and they need your help now. Just knowing your time has made a difference in the life of someone else is one of the best feelings in the world.
