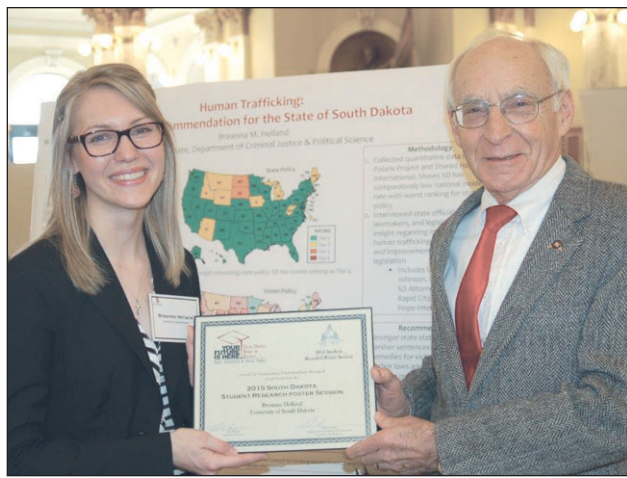

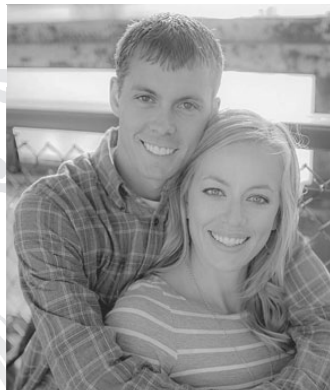

What Does It Really Mean?

Dear Dave,
I bought a piece of lake property not long ago, and the developer has first right of refusal if we decide to sell it. We originally looked at the property as an investment or building site, but I really don't understand what first right of refusal means.

Dear Craig,
A lot depends on the wording, but typically it means that you can sell property to another buyer subject to the developer not wanting to buy it back at that price.

If you decided to sell within the timeframe specified in the first right of refusal contract you'd have to notify the developer you have a written offer on the property. Then, you have to give him a chance to buy the lot first at that price.

Or, you could just ask the developer — in writing — to waive his first right of refusal if this is something you want to do. They're in the business of selling lots, not buying them, so it may be an easy deal.

Just make sure your broker is not directly connected to the mutual fund. You don't want someone with a vested interest. What you're looking for here is a person who can objectively connect you to a good mutual fund, with a solid track record of at least five to 10 years.

I'd like to send my kids to a private Christian school, and they would begin classes the same month we'll finally be out of debt. We would have to pay this out over the course of the school year, so would you consider this to be an

investment or more debt?

Dear Ed,
I don't borrow money whether it's an investment or not. But lots of private schools have tuition plans where you don't have to borrow money, and you just make two or three payments during the academic year.

I don't know if I would really call that a debt, because you can always take the child out of the school if you see you can't make the payment. Just make sure you carefully look over any contract involved and know what you're getting into before you sign up for the ride.

You don't want to obligate yourself to money you don't have, especially when you've worked so hard to get out of debt. Just save up, and have a place in your budget for tuition.

South Dakota Students Compete For State Title In Poetry Out Loud Citation Competition

PIERRE — Eight South Dakota high school students from across the state will share their talents and the works of great poets while competing for the state title at the Poetry Out Loud recitation contest Monday, March 16, in Sioux Falls.

Poetry Out Loud, a national arts education program, starts in the classroom and encourages the study of poetry by offering educational materials and a dynamic recitation competition to high schools across the country. South Dakota's program is administered by the South Dakota Arts Council with help from the Aberdeen Area Arts Council and South

Dakota Public Broadcasting. The state finalists were selected from a preliminary, video round. The finalists selected include: Julia Rankin, Belle Fourche; Georgiana Esther Shmagin, Brookings; Karissa Blum, Flandreau; Tucker Hammer, Sioux Falls Lincoln; Alex Schumacher, Sioux Falls Washington; Dustin Lehrke, Sisseton; Kate Struckman-Johnson, Vermillion; and Ashley Brage, Watertown.

Three students will also share their original poetry as part of a separate competition held in conjunction with Poetry Out Loud. Jimi Dawn Swallow, Little Wound High School, Kyle, Anna Koeppe,

Rosholt; and Matthew Hopkins, Watertown, were awarded for their submitted pieces.

The contest will begin at 1 p.m., CDT, March 16, in the auditorium at Edison Middle School, 2101 S. West Ave., Sioux Falls. It is free to attend and open to the public. A live-stream of the event can be viewed at <http://www.sdpb.org/poetry-outloud/>.

Poetry Out Loud was created in partnership by the National Endowment for the Arts and the Poetry Foundation with the collaboration of state arts agencies. It is intended to foster the next generation of literary readers by

building on the resurgence of poetry as an oral art form. Through Poetry Out Loud, students master public speaking skills, build self-confidence and learn about their literary heritage.
