The case began Oct. 20 when the Knox County sheriff's office and the Verdigre police responded to a report of a shooting at 620 Main Street in Verdigre. Linda Privett was found shot at her home and was pronounced dead at the scene. Verdigre

Rescue responded to the incident.

Phillip Privett was taken into custody by the officers, according to Knox County Sheriff Don Henery. There are no other suspects in the shooting, the sheriff said.

The Douglas County coroner's office performed an autopsy in Omaha. The autopsy determined Linda Privett died from a gunshot wound to her face and neck, according to Henery and Verdigre Police Chief Dean Wavrunek.

The defendant was initially taken to the Nebraska state penitentiary for safety reasons. He was later transferred to the Madison County Jail in Madison, Nebraska.

Privett's bond was denied, and he remains in the custody of the Knox County sheriff's department.

The defendant had

previously waived his preliminary hearing in Knox County Court and was bound over to Knox County District Court.

"It is a headache ... but I wouldn't say that the headache is greater than students having additional dollars," Smith said. "It does help students.'

Residents voted 55 percent to 45 percent in November for a measure that raises the minimum hourly wage from 7.25 to 8.50 an hour, increases the \$2.13 hourly tip wage to half the minimum wage, and ties future increases to the cost of living. Smith said the higher minimum

wage that the system implemented at

the end of December had to be absorbed into university budgets that were already set for the current fiscal year. Smith said it is going to be factored into the university's budget for the upcoming fiscal year.

Once we project the budget for next year and include the increase, it won't be as big of an issue," said South Dakota Student Federation Executive Director Jess Peterson, who attends the University of South Dakota.

Board of Regents Executive Director and CEO Jack Warner said the universities are employing common strategies as a result of the wage increase. Some campuses have also seen reduced

South Dakota State University is

projected to have about \$481,000 in increased costs, the highest of any of the universities. Allyson Helms, a student senator at the school, said the university has a significant number of student workers, which has caused a lot of adjustments.

A university spokesman said the school closes its student union two hours earlier on certain days in part because of the wage hike. Smith said the main dining area at Northern State, which is operated by a private company, closes in the afternoon on weekdays as a result of the increase and lack of student use.

A spokeswoman for Aramark, the firm that runs the food service, didn't response to a request for comment.

Forbes. He was also a cohost on the Nickelodeon show "U Pick Live" from 2002-2004 Neves was in the area for Wednesday's Wire Me Awake event in Vermillion.

Neves said that most success stems from people and entities doing things when nobody is watching.

"A consistent theme I've seen with the successful entrepreneurs and CEOs from all across the country and all across the globe that they have in common is they do those regular things that make people want to turn the volume up on them," he said. "They're willing to do those things when no one is watching that 95 percent of the population is unwilling to do.

He added these same success stories also often come down to the people they surround themselves with, especially if those surrounding them are willing to push that

"One thing that's really consistent about these exceptional entrepreneur men and women that I got the opportunity to interview with is that they've set themselves up with people who kind of make them better in the people that they hire and they work with," he said. "I've found that they consistently find themselves in positions where they're willing to get friction in their life. I think a lot of times, I've found — specifically with the younger generation, they kind of crawl back from criticism or some of that friction. The best folks out there are willing to receive that and

they want to receive that." On a younger workforce, Neves said things have changed drastically as far as work ethic.

"Work ethic among young people really is changing and it really depends on who you're talking to," he said. "Absolutely, there are some

hungry Millennials out there that are looking to make some things happen. I think Millennials are a generation in a unique situation because they saw a lot of promises made to their parents that didn't work out, so there's some fear and trepidation. Young people are absolutely willing to work, but they really want to find something that's meaningful.

Neves said that being in the Midwest also gives leaders a number of advantages they might not have on the coasts.

"In South Dakota, you probably have a distinct advantage that others don't have," he said. "In a lot of ways, products are being built for people in big cities. A lot of services are being built for people in big cities, but they're not being built for folks in the middle of the country. ... I think there's a huge edge to being here. Also, I would say there's the support of the community. You can get the support of a community here way more than you can in New York or way more than you can in San Francisco. And from a quality of life perspective -I've seen towns like this and I've been to the Omahas of the world — you can simultaneously build a business and have a great quality of life and not have to sacrifice some of those things that are
