Film Provokes Debate About Censorship

VERMILLION (AP) — A University of South Dakota professor is refusing calls to cancel the screening of a documentary that depicts brutality against Muslim women.

The "Honor Diaries" is to be screened at the university's annual women and gender conference April 10. The *Argus Leader* reports that some staff and faculty members want the showing canceled.

Media and journalism professor and conference coordinator Miglena Sternadori says she won't bow to the pressure. She says the film depicts issues that are relevant to the conference, and that it's wrong to censor a film.

The film features women activists who work in a culture that condones abuses of women. "Honor Diaries" has been praised for bringing attention to the plight of women in Middle East cultures, but it's also been criticized as anti-Muslim propaganda.

Four Arrested In Yankton Meth Bust

Four people were arrested Sunday after a search warrant at a Yankton residence turned up items used in the manufacture of methamphetamines.

All four were arrested on a number of charges, including possession of drug paraphernalia, unauthorized manufacture, distribution, counterfeiting or possession of substances with high potential for abuse as a felony and knowing a child was present where using, distributing or manufacturing methamphetamines.

Lt. Todd Brandt of the Yankton Police Department did not elaborate on how many children were present in the house or ages, but did tell the *Press & Dakotan* they are now in safe care.

The case remains under investigation.
