Former Area Standouts Among Seven Jacks To Qualify For NCAA Track Championship Preliminaries

BROOKINGS — Seven South Dakota State University track and field athletes kept their seasons alive by qualifying for the NCAA Championship Preliminaries in Austin, Texas on May 27-29.

Three men and four women qualified for the two-region format by securing a top-48 mark in their region by virtue of their season best mark. The Jackrabbits will compete in the west region. The top 12 athletes in the east and west regions, 24 total, will advance to the NCAA Championships in Eugene, Ore. on June 9-12.

On the men's side, Parkston native Luke Leischner qualified with the 35th-fastest time in the 400-meter dash. Jared Vlastuin qualified in the long jump, and Sean Burns qualified in the hammer throw.

On the women's side, Tyndall native Michelle Schuch makes a return trip in the hammer throw. Jennifer Mack qualified in the hammer throw, and Nicole Davis will compete in the 3,000-meter steeplechase.

Baseball: Jacks Sweep WIU, Play For Title Today

BROOKINGS — South Dakota State played four runs in the bottom of ninth inning to tie the game, then scored the winning run in the 11th to complete a sweep of Western Illinois in a Summit League baseball doubleheader Friday afternoon at Erv Huether Field.

The Jackrabbits opened the day with an 18-4 seven-inning victory, setting a Division I-era record for wins in a season. SDSU improved to 36-18 overall and 18-8 in the Summit League. Western Illinois dropped to 13-38 overall, 5-20 in league play.

The series and regular season conclude today (Saturday) with a home doubleheader scheduled at Erv Huether Field. Should SDSU win both games today, the Jackrabbits would secure the No. 1 seed in next week's Summit League Championship.
