

Runoff above Sioux City in April was 63 percent of normal, bringing in 1.8 million acre feet (MAF) of runoff compared to a normal amount of 2.9 MAF. When coupled with the long-term forecasts for summer precipitation in the upper basin, the result is a below-normal runoff forecast for calendar year 2012.

That represents nearly a full reversal from 2011 conditions, said Jody Farhat, chief of the Corps' Missouri River Basin water management division.

"Conditions have changed dramatically from last year, especially in regards to moun-tain snowpack," she said. "While the risk of flooding due to mountain snowpack runoff is low, the risk of localized flooding from rainfall-driven events is normal.'

A 50 percent chance of flooding exists for the tributaries below Gavins Point Dam at Yankton, according to Kevin Low with the Missouri River Basin Forecast Center.

"In mid-March, three locations on the Missouri River itself experienced minor flooding," he said. "Typically, the lower portion of the basin can expect to continue flooding through the remainder of the spring."

The lack of snowpack, combined with warmer winter temperatures and soil conditions, have fueled the dry conditions, according to Corps hydrologist Kevin Stamm.

"As of May 1, the northern Plains was exhibiting some drought conditions," he said. 'The long-term forecast calls for slightly drier conditions in fall 2012.



conditions, according to South Dakota state climatologist Dennis Todey.

'We saw very dry conditions in March," he said. "We have recently seen a recovery of some of the soil moisture deficits from last fall and this spring."

However, the current outlook calls for warmer and drier conditions than average, Todey said.

This year's below-average runoff is reflected in the Gavins Point releases, which averaged 26,200 cfs in April. The flows were reduced from 27,000 cfs to 25,000 cfs Friday in response to downstream rainfall.

Releases from Gavins Point will be reduced to zero for eight hours on May 9 to assess damages of the spillway slabs.

Releases are expected to reach 30,000 cfs next week, according to Corps officials.

The move will be taken to prevent the endangered least tern and threatened piping plover from nesting on low sandbars that would be flooded later this summer when higher releases are needed to provide navigation flows. The nesting season runs from May to late August.

The reservoir's elevation is currently 1,206.6 feet mean sea level. It is expected to return to elevation 1,206 by the end of May.

Fort Randall releases averaged 23,400 cfs during April. Releases in May will be adjusted as necessary to maintain Gavins Point near elevation 1,206.

The Fort Randall reservoir ended the month near elevation 1,354.3, which is 1.5 feet higher than the previous month. It is expected to increase to 1,355.2 by the end of the month.




