Spillway Road To Close Monday For Cleanup

The U.S. Army Corps of Engineers has announced that the road over the powerplant and spillway deck will be closed for an extended period to allow personnel to remove and clean the trash racks at the Gavins Point Powerplant.

The trash racks prevent large pieces of debris from entering the turbine units. All water will be diverted through the spillway while the work is in progress.

The spillway road will close at 8 a.m. on Monday May 14, through approximately 5 p.m. Friday, May 18. This closure will include overnight hours.

During the closure, parks in the downstream area of Gavins Point Dam may be accessed as follows:

- Parks South of the Missouri River, including Nebraska Tailwaters and Nebraska's Lewis and Clark State Recreation area (including Weigand and Burbach);
- Highway 81 to highway 121 West;
- Parks North of the Missouri River including Cottonwood Day Use, Training Dike Recreation area, Pierson Ranch, Chief White Crane and South Dakota's Lewis and Clark Recreation Area (including Yankton, Gavins Point and Midway units).
- Highway 52 West from Yankton.

Yankton School Board To Meet Monday

The Yankton School Board will hold its regular monthly meeting Monday at 5:30 p.m. at the YSD Administration Building located at 2410 West City Limits Road.

At the meeting, the preliminary 2012-13 budget for district funds will be presented. The agenda also includes discussing funding for Title I and Title II-A Class Size Reduction Programs, as well as hearing a report on a school/community alcohol/drug prevention committee's effort to cooperate and possibly reduce students' use of alcohol and drugs.

Simulated Driving Program Offered Next Week

A "simulated reality" program for drivers, particularly young drivers, will be held at the Riverfront Event Center (second floor) next week. Times are 1-8 p.m. Monday through Wednesday and 11 a.m.-8 p.m. Friday.

This program will teach impaired driving as well as driving education by using state-of-the-art driving simulators.

Construction On Douglas Begins Next Week

Construction on Douglas Avenue from 25th Street to Anna Street is scheduled to begin the week of May 14.

The plan for this project is to first complete the installation of a sidewalk on the west side of the road and then to remove and replace the pavement. The street will remain open during the sidewalk work, but it will be closed to traffic while street pavement is replaced.

The anticipated time to complete this project is six to seven weeks, weather permitting.

Hwy 50 Reconstruction To Begin In Clay Co.

The South Dakota Department of Transportation advises motorists that the westbound lane reconstruction project on Highway 50 from Vermillion to Gayville will begin on Tuesday, May 15.

The work consists of completely removing and replacing the existing surface, widening the roadway, and constructing asphalt concrete shoulders.

Beginning Tuesday (May 15), depending on the weather, traffic will be placed head-to-head on the eastbound lanes for the duration of the project.

Reconstruction completion is scheduled for late this fall. Knife River Midwest of Sioux City, Iowa, is the prime contractor on the \$13.2 million Highway 50 project in Clay County.

Students Gain Investment Experience In First USD-Wells Fargo Equity Research Competition

VERMILLION — The University of South Dakota Department of Finance recently partnered with Wells Fargo EFS to sponsor the first USD-Wells Fargo Student Equity Research Competition. Through a donation from Wells Fargo to the USD Finance Department, 11 students competed in the equity research competition, which allowed the participants to gain investment analysis and valuation experience.

The 11 USD students formed four teams to analyze four different publicly traded for-profit education firms, Capella University, DeVry University, ITT Education Services and Strayer Education, the winner of the competition. Students on the Strayer Education team were senior accounting major Rebecca Duncan of Bran-

don, Logan Nord of Harrisburg, a sophomore economics major, and Aaron Steele, a sophomore finance major from Vermillion. They received a prize of \$1,500 while second place in the competition (and \$1,000 in prize money) was awarded to ITT Educational Services, which included M.B.A. student Tyler Stewart of Sioux City, Iowa, and Nicholas Gates of Mitchell, who graduated with his M.B.A. from USD last summer. Third place Capella University researchers Alex C. Johnson, a senior finance major from Spencer, Iowa, Aaron Oestmann, a senior finance major from Rapid City and junior finance major Howard Schmidt of Loveland, Colo., received \$500. Brandon Flynn, Matthew Hicks and Joseph Jares, all senior finance

majors from Sioux Falls, finished in fourth place and received \$250 for their analysis of DeVry University.

The competition, which began with a kickoff event in February, also included a 10-page research report and a 20-minute presentation, and it was judged by Glen Herrick, senior vice president, Corporate Finance and Treasury at Wells Fargo, Jason Engman, C.F.A., assistant vice president at Wells Fargo, and Jarrod Edelen, C.F.A., a small/midcap portfolio manager at the South Dakota Investment Council. The research presentations, all open to the public, were held on the morning of April 13 at Beacom Hall on the USD campus.
