K. Porter Construction, Inc. of Norfolk has the \$662,081 contract for the slide repair project at Reference Post 3.3. Traffic will be maintained on a gravel shoofly adjacent to the slide repair work. Reduced speeds will be enforced. Completion of the project is anticipated this summer.

## Rules Review Committee To Meet May 29

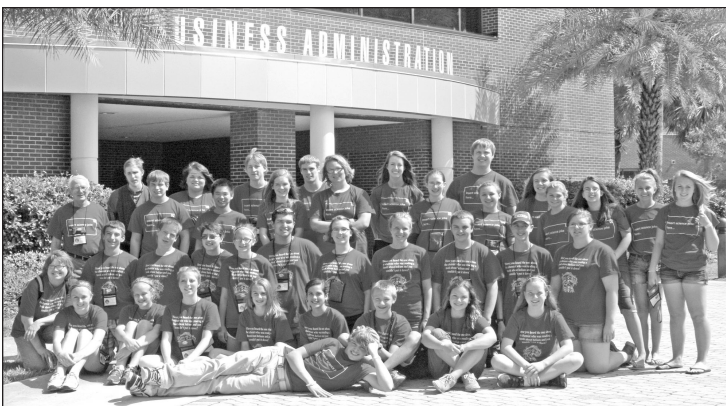

The committee will review rules proposed by the Attorney General: Law Enforcement Officers Standards and Training Commission; Bureau of Personnel; Department of Agriculture: Division of Agricultural Services, S.D. Animal Industry Board, and SD Weed and Pest Control Commission; Department of Game, Fish and Parks; Department of Human Services: Division of Rehabilitation Services; Department of Labor and Regulation: Appraiser Certification Program and Division of Insurance; Department of Revenue: Commission on Gaming, Division of Business Tax, and Division of Property and Special Taxes; Department of Social Services: Division of Economic Assistance and Division of Medical Services; and the Secretary of State: Board of Finance. 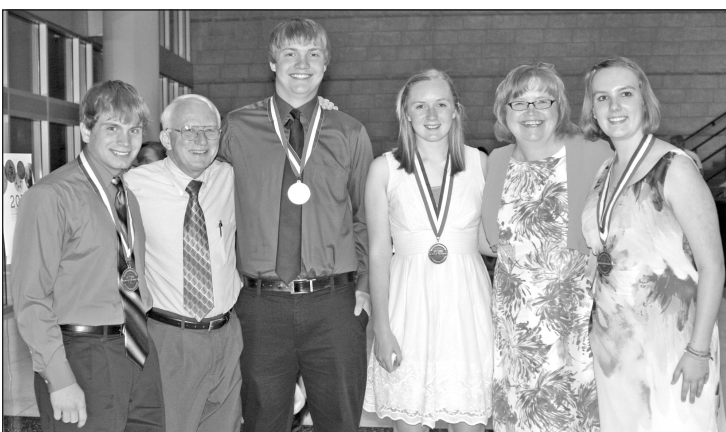

ORLANDO, Fla. — For most Yankton students, summer vacation began on Tuesday, May 15. But this was not the case for the 35 members of the Science Olympiad Team.

Instead, on the evening of May 15, the team boarded a bus for a 30-hour ride to the National Science Olympiad Competition on the University of Central Florida campus. Many students continued to study and prepare for the competition while on the bus, some waited to arrive at the hotel to tweak their inventions, while still others waited to run some pre-competition trials of their inventions on campus.

The Science Olympiad National Tournament is the pinnacle of achievement for 120 of the country's best Science Olympiad teams, representing more than 2,000 students. Medals are given to the top 6 place finishers in individual events and the top 10 place finishers in the team competition. This year, the Science Olympiad National Tournament was hosted on May 18-19 by the University of Central Florida in Orlando. for General Motors and the Pentagon, he said.

"I'll paint anything, but this sign is more dear to my heart because it comes from the automotive industry," Harris said. "Darrell wanted something with the cars and the company name that could be seen from a distance. He kind of left the design up to me."

Darrell liked the fact that Harris wanted to leave off all of the lettering and put their name on the sign with realistic flames, he said.

"(Harris) said he would do a three-dimensional image with cars on it, so we handed him a picture so he could come up with his artist drawing," Darrell said. "They're both our vehicles, which makes it more personal to us."

Harris said he wanted to do something with hot rods and fit the theme of the hot rod culture for the sign. He said realistic flames are the most popular image in the automotive paint industry now.

"We put cobblestones in the picture as well, because that helps give the sense of distance

and depth and takes you back into the sign," Harris said. "We also played around with the reflection from the flames on the cars, so that was a lot of fun to do."

Harris said he tried to portray something that took sign art to a new level. He added that the sign will last for a long time and will be somewhat like a landmark.

Darrell wanted something that would have people turn around, come back and look at the sign, he said.

"Our sign we had years ago was the first thing people saw when they came over the bridge," he said. "As it deteriorated away, I wanted something that would draw the attention from people walking the bicycle trail and people driving by."

Darrell said he feels people will stop and take pictures of the sign, and he is hoping it will bring reflection to the business.

Harris said he enjoys working in the Midwest, and when Darrell contacted him, he was more than willing to paint the sign.

"Getting to do this for Darrell and Ray and everybody here has been a real pleasure," Harris said. "I'm very proud of it."

culture and bulk transit of grain, thus helping to conserve our highways. But Yankton County will have to shoulder some of the financial responsibility to see Napa-Platte come to fruition.

**3. What are the biggest challenges facing the county in the next four years and how will you work to address them?**

Infrastructure will be foremost on the county agenda. Yankton County has some colorful but aging bridges, and with so many aging blacktop roads which provide transit of grains and hay from farm to market, this will be a priority. The county must have conservative, active leadership to continue to facilitate farm-to-market traffic.

**4. What is Yankton County's biggest strength/weakness?**

Those who have lived or trav-

eled elsewhere and utilized camping/fishing facilities elsewhere fully recognize that Yankton County's Lewis and Clark Lake parks, with proximity to other venues such as churches, family dining and entertainment opportunities provide the ultimate recreation destination for families. And as our farming operations continue to produce an abundance of grain and hay, the county road system will continue to be burdened. County commissioners must be diligent in maintaining these trade routes. And since the typefaces must be nearly worn off the Washington, D.C., printing presses, I do not foresee much federal money coming this way in the near future. Conservative must be the guide word for county government, or any other form of responsible government.
