Transfer Station Extends Sat. Hours

Beginning the week of May 4 and ending the week of Nov. 2, the City of Yankton Transfer Station Saturday hours will be extended one hour. Saturday hours will be from 8 a.m.-4:45 p.m. during this period.

Also beginning the week of May 4 and ending the week of Nov. 2, the City of Yankton Transfer Station will be open for grass clipping disposal on Monday and Thursday evenings from 6-8 p.m. The City of Yankton will be accepting only grass clippings on Monday and Thursday evenings for this season at no charge.

The City of Yankton Transfer Station will not be open for grass clipping disposal on Wednesday evenings.

Grass clippings may also be taken to the Transfer Station during normal business hours of 8 a.m.-3:45 p.m. weekdays and 8 a.m.-4:45 p.m. Saturdays.

The public is asked to keep all other materials, such as garbage, tree limbs and branches, trash bags, batteries, rocks, concrete and all other items out of the grass clippings. Customers are to empty all leaf and grass from garbage bags and dispose of plastic bags in dumpster next to the grass pile.

Dumping items other than grass clipping and leaves is illegal.

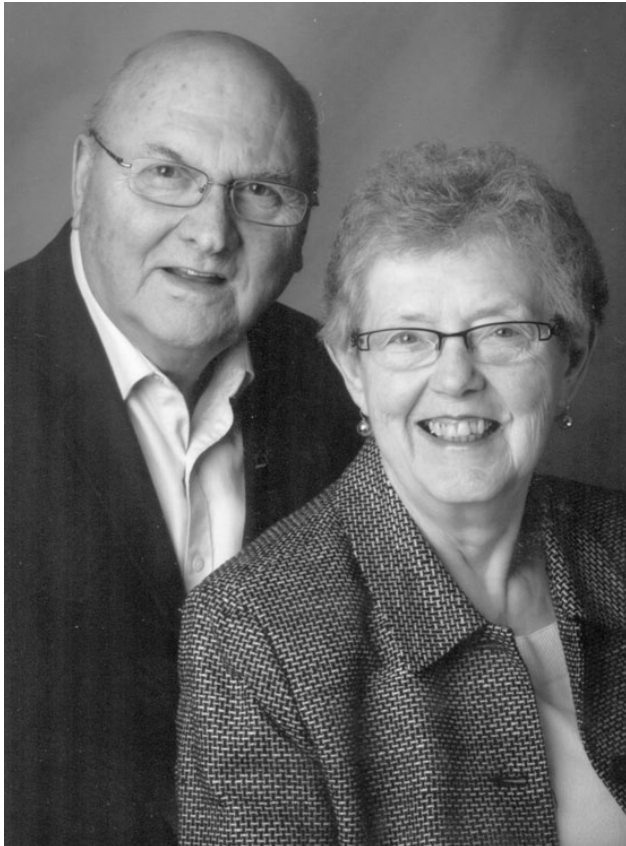

Benders To Receive Honorary Doctorates At Commencement

Charles and Alberta Bender are set to receive Honorary Doctorates from Mount Marty College during the 2014 spring commencement exercises at 2 p.m. Saturday, May 10, in Laddie E. Cimpl Arena, Yankton.

Charles Bender was born in St. Helena, Nebraska, and graduated from Holy Trinity High School, now Cedar Catholic High School in 1953. He entered the U.S. Army where he served from 1956 to 1958. After his time with the Army, he served as a member of the South Dakota Army National Guard from 1958 to 1961. In 1959, Charles started as a laborer for the Welf Construction Company. During his time with Welf Construction, Charles worked on the construction of the Sacred Heart Monastery in 1959, the addition to Sacred Heart Hospital in 1965, the concrete structure of the current Sacred Heart Hospital, Whitby Hall, Corby Hall and the Old Library building. In 1991, he became an owning partner and president of Welf Construction, while owner projects included the remodel and addition to the Sacred Heart Monastery, St. Scholastica building and remodel of the Roncalli Center.

Kathryn O'Leary Higgins is the President of the Higgins Company, a Washington, D.C. government relations firm. Prior to forming her own company, she was sworn in as the 36th Member of the National Transportation Safety Board on Jan. 3, 2006.

Ms. Higgins came to Washington from Yankton. She graduated from Mount Marty High School in 1965 and attended Mount Marty College for two years before transferring to the University of Nebraska where she earned a bachelor of science degree.

She has more than three decades of experience in the public and private sectors. BBB: Internet Explorer Users Are Vulnerable To Attack

OMAHA, Neb. — A vulnerability in Microsoft's popular Internet Explorer web browser can allow a "remote, unauthorized attack" on users' computers, the company announced over the weekend via a Service Advisory. Although it is working to fix the problem, the company suggests "workarounds."

Meanwhile, the U.S. Computer Emergency Readiness Team, a division of the De-

partment of Homeland Security, is urging computer users to employ Microsoft's Enhanced Mitigation Experience Toolkit (EMET) if possible, or temporarily switch to a different browser until an official update is made available.

The "use-after-free" vulnerability can allow remote attackers to install code on a user's computer without authorization. Versions 6 through 11 of Internet Explorer (IE) are vulnerable, and users who still have the Win-

dows XP operating system are at greater risk because the company is no longer supporting the product.

Better Business Bureau is joining with security experts in recommending that IE users take the following steps:

- Download the Enhanced Mitigation Experience Toolkit (EMET) at <http://support.microsoft.com/kb/2458544> on your computer for additional protection (although it may not mitigate this particular vulnerability);

- Temporarily switch to a different web browser, such as Google's Chrome or Mozilla's Firefox.

- Disable Adobe Flash, as the attack may not work without it.

Windows XP users should upgrade their operating system or disconnect the computer from the Internet, as the company no longer supports this version of Windows.
