# **U.S. Attorney Brendan Johnson To Deliver Keynote Address At Spring Commencement**

VERMILLION, — Brendan Johnson, the chief federal law enforcement officer for the state of South Dakota, will deliver the keynote address as the University of South Dakota celebrates its 127th Spring Commencement at 9:30 a.m. on Saturday, May 10.

Johnson, a 1998 USD graduate with a B.S. degree in history and political science, was nominated by President Barack Obama as the 40th United States Attornev for the District of South Dakota and was confirmed unanimously by the United



States Senate on Oct. 15, 2009. As South Dakota's chief federal law enforcement officer, he supervises the prose-

cution of all federal crimes and the litigation of civil matters in which the United States government has an interest. Prior to being confirmed as U.S. Attorney for South Dakota, Johnson was a partner at Johnson, Heidepriem, Abdallah and Johnson, LLP; and a state prosecutor in the Minnehaha County State's Attorney Office. He graduated from the University of Virginia School of Law in 2001. Johnson and his wife, Jana, are the parents of four children.

In addition to Johnson's keynote address, USD will

confer degrees to more than 1,200 candidates at the DakotaDome. The 127th Spring will also honor distinguished faculty from the 2013-14 academic year, including recipients of the Belbas-Larson Awards for Excellence in Teaching; the Richard and eral Arts; the John Wesley presented to the outstanding lege of Fine Arts Distinguished Professor Award.

"It will be very sad for me," Abbott said, standing in the atrium of the Al Neuharth Media Center, "to walk through this building and not see Jack here.

Abbott recalls being approached by Neuharth, and being told, "We have some things that we want to do. We want to start some programs that make a difference. We want to talk about the First Amendment. We want to work on diversity."

Marsh, with Neuharth's blessing, spent the last 17 years ensuring those goals

were addressed. He oversaw development of the Al Neuharth Media Center at USD, Neuharth's alma mater, where Marsh was the founding director and eventually president. Later, Marsh was promoted to president and chief operating officer of the Freedom Forum Diversity Institute, Inc., and split his time between offices in Washington, Nashville and Vermillion.

Until he left that position last year, he was responsible for the Freedom Forum's efforts to diversify the nation's newsrooms. He helped promote fairness in the media and worked to advance journalism education.

The last 17 years have really been a wonderful experience — not only because we got to work together, but also because we got to work with Al," Abbott said. "We got to work with the folks at the Freedom Forum. We got to work with people from all across the country who were involved in Jack's programs — I'll always think of them in that way — as Jack's programs. I know Al started them, but they were Jack's programs."

We've had the privilege

"You have been there for so many of them for so long, and I know you'll continue to be," she said.

Van Maanen announced that Marsh has established the Jack Marsh Student Media Scholarship Fund at the university.

"Already, so many people have been donating in your name," she said. "You have made such an impact on so many people across the region, and nationally, and that

based at the Newseum in Washington, D.C. Marsh became a close aide and confidante to Neuharth and was responsible for several Freedom Forum initiatives and programs that were priorities for Neuharth.

Marsh served as director of the Newseum's News-Capade and accompanied Neuharth for two years as the exhibit visited all 50 states and Canada to promote a better understanding between the news media and the public. NewsCapade was then the largest self-contained mobile exhibit in the USA.

He is founder of the American Indian Journalism Institute and is among the original organizers of the Crazy Horse Journalism Workshop held 2000-2012 at Crazy Horse Memorial. Until recently, he was an adjunct professor of journalism at USD.

"Al Neuharth would always remind us that life is not a perfect season," Marsh said to well wishers March 24, "but I have to tell you that the last 16 years of my professional years have been pretty perfect.

"Sometimes, in life, the stars align perfectly," he said, his voice breaking with emotion, "and for me and my family, the stars aligned over South Dakota when we were transferred here.'

Marsh, who was born and raised in New York, had only been to South Dakota once, when he was a child.

Through his work at the Argus Leader, and later with Al Neuharth, the Freedom Forum, and other associated organizations, he said he had the opportunity to get to know South Dakota's top journalists and leaders.

Marsh noted that much of his efforts, as he has gone to work each day for the past 16 years, have been to represent

Marsh said he feels fortunate to have arrived at USD shortly after Abbott was named its president.

"Jim Abbott, along with many, many others, has led a transformation that is breathtaking at this university," he said. "We are now a Division I institution, and that means we are D-I not just in athletics. That D-I standard is now achieved at this university across the board.

"It all starts at the top, and Jim Abbott is the person who provides that leadership. What a privilege it has been for me and for Betty to become friends with the Abbotts, to become a colleague. and for us, in many ways, to become pundits," Marsh said.

Marsh said he, his wife and his two grown daughters are now full-fledged South Dakotans. He will continue to serve on the boards of the Crazy Horse Memorial Foundation, the national organization Face It TOGETHER and the South Dakota Symphony Orchestra.




