Rezac has left a legacy beyond major building and remodeling projects, Ekeren said. He pointed to the emphasis on quality care and achieving patient and staff satisfaction.

As hospital CEO, Rezac will help preside over one remaining major event — Monday's groundbreaking for the Avera Yankton Care Center Replacement Facility and Hospice. The ceremony will take place at the Majestic Bluffs site west of Yankton.

'We're building two more wings and a hospice. It's going to be in the \$11-12 million range, so it's a big project," Ekeren said. "That will be a challenging project, and we will have one terrific state-of-the-art, long-term care community. We won't take a back seat to anyone."

Rezac has laid a strong foundation for the hospital's future, Ekeren said. "I think we are headed in

a lot of different areas that are very positive for us and for the community," he said. "But it's also a challenging time for health care with the Affordable Care Act and the other pieces that are going to be there two, three or four years from now, or even after (this year's) elections.'

That sense of constant flux means remaining flexible, he added.

"We like to be able to anticipate as much as we can. But some things are out of our hands when it comes to federal rule making or state issues such as Medicaid expansion," he said. "In our case, being part of Avera Health provides a tremendous benefit. It helps us deliver services not only for Yankton but also the region.'

In that sense, ASHH has emerged as a regional medical resource, Ekeren said.

"We have a medical staff in Yankton that is certainly much larger than your typical community of 14,000 people," he said. "We draw (patients) from a 15-county area in South Dakota and Nebraska. Yankton is a regional medical destination, and we certainly appreciate the need to make sure we are

meeting those expectations." Rezac has strengthened ASHH's relationship with the University of South Dakota School of Medicine, Ekeren said. Yankton serves as one of three sites in South Dakota for clinical training and has become nationally recognized for its "Yankton model" of instruction, he

"Those students (who train at Yankton) have very good test results, and they tend to stay in South Dakota," he said.

With more than 1,200 employees, ASHH ranks as one of Yankton's largest employers, Ekeren said. Rezac's successor will face the challenge of recruiting and retaining health care workers, he said.

"You look at the age of our workforce, especially certain professions such as nursing, over the next 10, 15 and 20 vears," he said. There are a significant number of retirements, and when you look, are there enough people in the pipeline?"

Rezac's successor has a tough act to follow, Ekeren said.

"Pam has been very active and very effective," he said. "She is leaving very big shoes to fill."

reservoir system is still currently below the base of the annual flood control pool at 54.6 million acre-feet. With the forecasted runoff, the reservoir system will rise into the annual flood control zone this year, and then the stored water will be used during the remainder of the year to provide downstream flow support to things like navigation and water sup-

She added that the Corps does not anticipate evacuating water above the rate needed for downstream uses this vear.

"However, if a significant precipitation event would occur in the upper basin, any flood water that is cap tured in the reservoirs will be evacuated through the remainder of the season at rates that are well within the channel," Farhat said.

The potential exists for minor to moderate flooding in the lower Missouri River and its tributaries due to normal thunderstorm activity. In that case, the Corps could utilize available flood control space in the reservoirs to limit downstream river levels.

Typical summer thunderstorms can cause local-

ized flooding downstream of the reservoir system," Farhat stated. "Reducing releases from Gavins Point in response to downstream rainfall is part of our normal flood risk reduction measures, and the reservoir system has storage space available for these operations in the event of flooding downstream.'

Gavins Point Dam releases averaged 27,400 cubic feet per second (cfs) during April.

The flows are currently at 26,000 cfs and are expected to reach 30,000 cfs around mid-May to prevent endangered least terns and threatened piping plovers from nesting on low sandbars.

With the release of the U.S. National Climate Assessment this week, the *Press* & Dakotan asked officials on the conference call what steps they are taking to prepare for the effects of climate change. The projections in the assessment suggest more frequent and more intense droughts, heavy downpours and heat waves in the Great Plains.

"We have several different studies going on (regarding climate change)," Farhat said. "We've done some of our own analysis. We did a post-2011 flood attribution study looking at that, and there are other climate change studies in the works right now. They are all trying

to help us have a more informed process to make better decisions. To date, we haven't made any particular changes to the operation plan because of climate change, but all of these studies are providing additional information that will be useful."

Dr. Dennis Todey, the South Dakota state climatologist, said his office has participated with the Corps on one such study that looked at mountain snow pack and what decisions may need to be made because of those levels.

"The two biggest things we are seeing (in relation to the Missouri River basin) are precipitation changes," he said. "In the eastern part of the basin over the last century, we have seen, especially recently, some very large increases in overall precipitation. That has led to increased flooding. The western part of the basin (is seeing) decreases in the frequency of flooding.

"The other big pattern change we have seen is, despite what we saw last winter, increasingly warm winters," he added. "That's been the biggest temperature change overall.'
