RE: Time For A Change/Term Limits

Dear Congressman Ryan:

I am addressing this letter to you, in part, Reed where you are treated free of charge? because of your elected position as a member of the House and because of your position on the Budget Committee. I could address this letter to any member of Congress as I believe they are, for the most part, in lockstep. Based on the position you hold in the House, I perceive you to be the biggest threat to the security of our Country at this time. You hold a unique position in the House which permits you to propose the budget for the operation of the government, a budget which you know the Senate will never pass. I am also addressing this, in part, to the citizens of South Dakota as whatever action you take inevitably affects South Dakotans.

You made a comment to the effect that twenty (20) years of military service and a lifetime of retirement is not sustainable. What you didn't say is that after only five years in Congress, you can retire with a lifetime retirement with annual cost of living pay increases. You also didn't say that you earn - - - not earn - - - receive a salary of \$174,000.00 per year plus benefits. Congressman Ryan, even though a military person may retire after 20 years of service, during that 20 years, he /she may have been deployed 4-5 times, if not more. If they survive the deployments they may return to a spouse who couldn't wait for his or her return and engaged in an affair. That accounts for some of the murder/suicides involving our returning veterans. Others return without a job, depressed, suffering from PTSD and some commit never intended to have career politicians. Limited suicide. Far too many return with missing limbs, TBI, or other severe injuries.

You only have to look back at the last Inaugural Address given by President Obama and remember the Veteran who was setting next to Michelle Obama. It appeared to me that he had sustained serious combat injuries. Mrs. Obama had to help that poor Veteran get to his feet. You stood by and applauded him for his sacrifice after which you went back to the drawing board to continue your scheme to reduce his benefits, monetary and otherwise. Does your memory reach back that far? You have no vision for the future or what's best for the Country, and if your recent memory is somewhat fuzzy then you need to resign from the House and try to get your old job back flipping hamburgers at McDonalds.

I served 2 years in Vietnam but we didn't have to deal with the roadside bombs that today's military has to deal with when deployed. I returned home with all of my body parts intact. That is not always true for our combat veterans of today.

Here in Yankton, we have a combat Veteran who is totally blind. He gets around his home by clinging to his daughter's shoulders. She will not stay young forever. She will grow up, get married, have a family of her own and then where will that leave the disabled Veteran? His wife will care for him as long as possible, but after that he will wind up in a VA Nursing Home. There he will die, like them, to have their retirement and cost of living reduced by individuals such as you, an individual who receives \$174,000.00 per year with an annual cost of living increase of 5% (except during election years). I personally do not know of one single individual who earns \$174,000.00 per year. In the case of Congress, there are actually those who believe they are underpaid!! If they believe they are underpaid, let them resign and return to the private sector and see what it is really like to actually have to work for a living. I believe that Congress, as a whole, presents the biggest danger/threat to the citizens of the United States. In one of your budgets, you attempted to decimate Medicare. When I receive my Medicare statement, I am surprised that any doctor would take Medicare patients. If I spend an hour with my doctor, some Medicare bureaucrat with all of his or her infinite wisdom, declares that the average office visit is 15 minutes when in fact it takes about 10 minutes for the nurses to take your vitals, ascertain the nature of your concern and put you in the doctor's office. The doctor goes over your medical history and will normally order labs. In a day or so, he sends you a letter with the results of the lab work and makes any necessary changes to your medication. The office visit is usually at least one hour, but at times more than that. Yet, he gets paid for 80% of a 15 minute Medicare established policy. If you have your way,

"We decided to provide this service because we saw a great opportunity to serve a segment of the population that is greatly underserved," he said. "It's important for us to be responsive to market demands, and there is a significant demand for this service.'

The challenging behavior unit will operate separately from the rest of the Irene campus. The new unit will take adand dietary department for meals. State officials approached facilities about giving up nurs-

vantage of the main kitchen

ing home beds to create challenging behavior units, said Director of Nursing Staci Binde.

"This (unit) will house a very diversified group of people," she said. "It's a step-down unit, where patients get ready to transition out to their homes or to a traditional long-term care facility.'

The change at the Irene facility has been in the works for more than a year, Breidenbach said.

"The concept of Sunshine Terrace began in late 2012, and we were finally approved to begin the project in July 2013,"

he said. "Once the plans were established and approved, renovations began in February of this year."

As part of the renovations, five rooms in the wing were torn out and converted into the dining room and living room, Breidenbach said. "We have finally come to the end of the project and we are looking forward to opening Monday,' he said.

The initial admissions call for two residents Monday, followed by two more Tuesday and one more Wednesday, according to Tallie Cassanova, who works with admissions and referrals. The unit should be filled May 28, then develop a waiting list.

The Irene facility works

with the state Department of Social Services in determining placement of residents and also their discharge plan when they are ready to move into

other living arrangements, Cassanova said. Breidenbach said the initial residents will come mostly from the Human Services Center in Yankton.

The design and opening of the challenging behavior unit has become a partnership, Breidenbach said

The unit was designed in collaboration with Avera Behavioral Health and the Human Services Center. It is a remodel designed to be a distinct unit to create a safe, homelike area with low stimulation to help us more effectively manage more

volatile behaviors," he said.

"We will be offering a wide array of activities designed to engage our residents and manage behaviors through recreational therapy. The general categories of activities we offer include social, cognitive, movement, sensory and creative."

Sunset Manor Avera has added 17 new staff members for its Sunshine Terrace site, Breidenbach said.

Sunshine Terrace has hired additional registered nurses, licensed practical nurses, certified nurse assistants. restorative aides and recreational advocates, Breidenbach said

"We are fully staffed and ready to go for the start of the unit," he said.

Recreation advocate Sandi Stratton said she will combine a number of activities in serving residents' needs.

We offer one-to-one care each day," she said. "We also have group activities both inside and outside of the facility. They could enjoy fishing, nature walks and visits to farms. We also plan to have groups come in from various youth organizations who will give presentation or programs for earning Merit badges or other projects. It's all part of our giving back to the community.3
