Competency Test To Be Done

A psychiatric evaluation for a man accused of murdering his uncle in Yankton is set to occur at the end of the week.

Joshua Charles Hudson has been charged with second-degree murder in connection with the March 7 death of 46-year-old Todd Hudson. He is also charged with aggravated assault and grand theft.

Second-degree homicide as murder is a Class B felony for which the punishment is life imprisonment.

Hudson previously told Circuit Judge Glen Eng that he did not want legal counsel and would instead represent himself. Despite Hudson's wishes

at that March hearing, Eng appointed Dan Fox to represent him.

Last month, Eng granted a request to have a psychiatric evaluation done at the expense of Yankton County to determine if Hudson meets a threshold of competency to represent himself.

Fox told the court Monday that Dr. Melissa Spanggaard of Avera University Psychiatry Associates in Sioux Falls will conduct the competency evaluation Friday. He estimated that the results of the procedure will be available in the next four weeks.

Eng set the next hearing in the matter for 8:30 a.m. June 9.

Authorities received a non-emergency phone call from Todd Hudson's ex-wife at 8:40 a.m. March 7 requesting a welfare check on him. She later told au-

thorities that Hudson showed up at her residence and said, "I axed my uncle."

Hudson was apprehended near Jefferson later that morning after a high-speed chase with law enforcement that began in Woodbury County, Iowa.

According to authorities, he was driving a green 2002 Dodge Ram that was stolen from his deceased uncle earlier in the day. They also allege that a blacksmith hammer they believe was used to apply blunt-force trauma to the victim's head and resulted in his death was found in the vehicle.

Hudson remains in jail on a \$1 million cash-only bond.
