#### **Heavy Rains Lessen Drought In Neb.**

DES MOINES, Iowa (AP) — Recent heavy rainfall has washed away or at least lessened drought conditions in swaths of Nebraska and Iowa.

A report released Thursday by the National Drought Mitigation Center at the University of Nebraska-Lincoln says drenching rains led to significant improvements for areas of the two states considered to be in drought. Brian Fuchs, a climatologist at the center, says overall drought reduced last week by nearly 12 percent in lowa and about 17 percent in

The report says western lowa saw the greatest improvement in the state. Nebraska saw a substantial reduction in the east-central region, with a pocket now considered

Fuchs says the improvements seen within the past week are noteworthy, as changes in drought status typically occur

#### Couple To Challenge Gay Marriage Ban

BISMARCK, N.D. (AP) — A newly married lesbian couple is poised to become the first to challenge South Dakota's ban on same-sex marriage following the state's refusal to grant the women a name change after they were legally married in Minnesota.

The couple, Jenny and Nancy Rosenbrahn, plan to file the lawsuit next week in federal court, according to their attorney, Joshua Newville. The Minneapolis-based lawyer said Thursday he also has been talking with couples looking to file suit in North Dakota, which along with South Dakota and Montana are the only states with gay marriage bans that haven't been challenged in court, according to gay-rights advocacy group Human Rights Campaign.

Our focus right now is to get filed in South Dakota and to focus on the case in front of us in the immediate short term," Newville said Thursday, but "we are very seriously contemplating filing in North Dakota.'

#### **Teens Arrested After Crime Spree**

SIOUX FALLS (AP) — Two North Dakota teenagers face numerous charges after a crime spree that authorities say started in the North Dakota city of Fargo and ended in the South Dakota city of Sioux Falls, where they were arrested.

Sioux Falls police say the 15-year-old boys allegedly stole a car in Fargo and drove to Sioux Falls, where they held up a convenience store last week. The teens then allegedly stole another vehicle after pointing a gun at a man on Monday. That evening, a 12-year-old girl reported that two men knocked on her apartment door, threatened her with a gun and took her cellphone.

The teens were arrested after pointing a gun at a police officer and unsuccessfully trying to flee. Authorities later determined that the weapon was a BB gun.

## **SD Proposes Steep Deer License, Tag Cuts**

SIOUX FALLS — A state hunting regulatory commission has proposed steep cuts to the number of licenses and tags available for many of South Dakota's deer hunting seasons to counter a shrinking herd caused by harsh winters, disease and habitat loss.

The South Dakota Game, Fish and Parks Commission detailed the proposed changes Thursday. They would affect the East and West Rivers deer hunting seasons, as well as the one in the Black Hills, where no antlerless licenses would be issued for 2014.

"Unfortunately, the stars are aligned against wildlife here," wildlife program administrator Chad Switzer said. "Deer can't fly south in the winter."

Other factors affecting the popula-

tion are the spread of epizootic hemorrhagic disease, which is transmitted by a biting midge, and the transformation of so-called shelterbelts into corn and soybean fields.

Under the proposal, the East River 2014 deer season would see 19,375 any deer tags compared to 21,465 in 2013. But the most drastic cut applies to antlerless deer tags, which would be cut by almost 60 percent. The commission allowed for 29,170 of those tags in 2013, but is proposing only 10,700 for

Resident licenses in the East River would be cut to 26,025 from 33,265 in

The West River season would have 16,075 any deer tags, a reduction of about 1,700 compared to last year. Antlerless tags, however, would be reduced by 86 percent, bringing the number to 3,885. Only 18,310 resident licenses would be available during this season, a cut of 17 percent.

In the Black Hills season, only singletag licenses are available. The proposal leaves the season with no antlerless licenses for 2014, but calls for 200 resident any-deer licenses and 3,000 resident whitetail deer licenses.

Custer State Park will again have 10 any-whitetail licenses and 20 antlerless whitetail muzzleloader licenses.

Changes are also planned for the 2014 archery season and in the licensing of youth deer hunters.

Switzer said the changes are expected to last two to three years.

The commission plans on finalizing the proposal during a gathering June 5-6 in Yankton. Public comments are being taken.

## Nebraska's Online **Background Check** System Proving Popular

LINCOLN, Neb. (AP) — The addition of online access to criminal records for background checks has proved popular with Nebraska residents who want to see whether a prospective employee, a neighbor or a future spouse has ever been arrested.

More than a year ago the Nebraska State Patrol put its background check system online. It lets people check a name through the patrol database for \$18. The site is accessible at www.ne.gov/go/crime-re-

Patrol Lt. John Shelton told the *Lincoln Journal* Star that if the numbers keep climbing, the system will have run 40,000 checks by the end of the year -40percent online. In 2013 there were 37,501 name checks, with 11,688 of them

"It's popular. Every month we see those numbers continue to climb,' Shelton told the newspaper.

The names are run through the patrol's criminal history database, which Shelton said contains information from all people who are arrested and fingerprinted in Nebraska. That includes arrests in Nebraska by federal agencies, if the person detained is subsequently held and fingerprinted in a Nebraska county jail. It doesn't include information on people arrested only in other states or countries.

Without the online service, a name check can take seven to 10 days. The online system will provide a result immediately if the person checked has no criminal record, Shelton

But about 25 percent of the time, an arrest will be noted and, under state law, the information can't be released until the patrol determines what happened in the case: Was the person ultimately charged after the arrest? Prosecuted? Convicted?

The system hasn't saved the patrol any money, Shelton said, because doing less work on preliminary namebased background checks has freed patrol employees to do other work

## **South Dakota Board Turns To Unnamed Landmarks**

PIERRE — The South Dakota Board on Geographic Names is beginning a new chapter after completing its initial mission of removing the word "squaw" from the names of features in the state, officials said at a Thursday meeting.

The board was established in 2009 to correct offensive nomenclature including 'squaw" and "Negro." Āfrican-American leaders have advocated keeping "negro" in place names, saying it's not offensive and preserves the legacy of black South Dakotans.

'We've come a long way,' said Tribal Affairs Secretary J.R. LaPlante, chairman of the board. "We've accomplished our mission.'

The Legislature approved the board's final changes to offensive place names earlier this year. Now the board is taking proposals on other name changes and for unnamed geographic features.

"It's kind of an expanded role for the board. People want to continue to have someone to go to with proposed changes," LaPlante

June Hansen, vice chair of the board and a compliance officer in the Department of Transportation, agreed. She said the U.S. Board on Geographic Names wants states to have parallel boards to address issues at a local level.

State board members discussed procedures at the meeting, including a new form for proposed name changes. They have rule making authority and state funding to cover travel expenses for the first time. LaPlante said that means the board can send a representative to a national conference and discuss the state's use of the Lakota language in renaming features.

Board members discussed the single remaining use of "squaw" in a state feature, in Shannon County. The board cannot change the name without permission from the private landowner. Members unanimously agreed to recommend that the Oglala Sioux Tribe contact the property owner to solicit the name change.

The board also agreed that it will only address the names of state geographic features, such as buttes and lakes and creeks, not the names of cities and counties.
