Fund Drive Passes \$158,000 Mark

Thanks to the continued generosity of businesses and individuals, the Regional Technical Education Center (RTEC) continues to close in on its goal of raising \$200,000 as part of the Workforce Development Fund Drive.

LINCOLN, Neb. — Comments are being sought on a strategic plan for a system of care that supports children, young adults and families in meeting mental health and other needs. It's intended to result in improved access to appropriate and timely community-based care that is family-driven and youthguided, and designed to improve mental health outcomes and eliminate fragmented approaches to care.

The draft plan was developed with public input by the Nebraska Department of Health and Human Services, the Nebraska Children and Families Foundation and the Nebraska Federation of Families, as well as partners, advocacy groups, children and families.

"Meeting the needs of families with children who need mental health services is challenging," said Scot L. Adams, director of the Division of Behavioral Health. "This plan is an opportunity to bring together all the different kinds of services and supports that may be needed to address those

Today, there is a tool provided by the Department of Education that can help you make your decision, said Carrie Johnson, SDSU Extension Family Resource Management

"The Repayment Estimator is a great way to visualize what your payments will be under each of the different plans," Johnson said.

She explains that there are

two ways to use the new tool which can be found by visiting studentloans.gov or studentaid.gov. "You have the option of linking right to your personal student loan information or entering all of your loans yourself," Johnson said.

However, to get the most out of this new tool Johnson encourages students to sign in. "By entering your information, the calculator pulls your current student loan debt from the National Student Loan Data System (NSLDS) and gives you a personalized run down of what your payments will be with each of the repayment options," she said.
