# **Crofton Surprises To Open State**

OMAHA, Neb. - The 3200meter relay wasn't supposed to be a highlight event for the Crofton Lady Warriors.

No, they came into Fri-day's Class C final with the second-worst qualifying time, set at the district meet last week. On paper, the Lady Warriors weren't a threat.

Instead, Crofton's quartet - which included two juniors and two freshmen shaved off a full minute to win the relay title on Friday at the Nebraska State Track Meet in Omaha.

'Coming down here, that's how it goes," said junior anchor Quinn Wragge. "Those times don't mean anything. "You just have to run the

best you can."

And that's exactly what they did. Crofton's relay group of freshman Kelsey Sanger, freshman Monica Arens, Wragge and junior Allison Arens clocked a 9:40:03 to win by 14 seconds.

That was exactly why the group, who had two months earlier won yet another state basketball title, was especially excited after the race.

Crofton came into the state meet with a qualifying time of 10:41.4, a full 38 seconds behind Sutton's district time.

'They probably thought, 'Maybe they're not going to be the best," Sanger said, referring to the other schools, "but we had one of the best times we've had.'

The Lady Warriors could-

n't have done it without the leadership of Wragge, whose split helped push Crofton ahead even further.

"We're so lucky to have Quinn," Monica Arens said. "I don't know what we'd do without her."

The same could be said of the two freshmen, Monica Arens and Sanger, according to Wragge. Neither athlete had competed at a state track meet.

"This is totally different," Wragge said, referring to the Burke atmosphere. "They did so well, I'm proud of them."

The Crofton girls weren't the only members of their school to exceed expectations on Friday. Senior Alex "A.J." Janssen

shaved 11 seconds off his qualifying time to finish third in the 3200-meter run. Janssen clocked a 10:00.68 to finish behind champion Andrew Fields of Ord (9:44.93) and Collin Meusch of Kearney Catholic (9:56.3).

"I wanted to get out fast and maybe go for the school record," he said. "I didn't have enough to stick with it, but I'm just happy to be here.'

Janssen agreed with the idea that district times, especially those by Crofton from a cold and windy day last week in Hartington, were a little deceiving.

"With the weather, we all assumed we could drop those times," Janssen said. "Most strong runners can persevere.

"The competition is the biggest thing.

The competition was certainly a factor for Crofton junior Maria Wortmann in the discus.

Wortmann finished fourth in the event at 126-feet-9. She watched in the finals champion Alexandra Meyer of Superior launch a throw

155-feet. With that in mind, Wortmann said she was just happy to see her name among the leaders.

OMAHA — Heat wasn't about to slow down Breana Gallup.

No, the Wausa senior had already overcome quite an incident earlier in the week. The stitches on her forehead were painful evidence.

Gallup, who had to get stitches after hitting her head on a wall while making a snack last Monday, finished second in the Class D girls' 3200-meter run to highlight Friday's action for Wausa at the Nebraska State Track Meet in Omaha.

races over the years, Gallup had locked horns with Cramer. It was more of the same Friday, as Cramer won the title in 12:04.69.

"I thought I could get her if she did pass me, but no," Gallup said. Another Wausa junior had

Austin Hegge surprised many — including himself by finishing second in the boys' triple jump with a season best mark of 43-feet-5.5. "I've never gone over 39

A Doane College recruit, Gallup led the 2-mile race for the first seven laps, but was passed on the final 200 meters by Anselmo-Merna junior Elizabeth Cramer.

"I thought if I just stayed loose, I could get it," said Gallup, who finished second in a time of 12:11.94. "But there are some pretty good runners.

"I had to go harder, but I just didn't have it."

Even before stepping on to the Burke Stadium track, Gallup suffered quite the lead-in to the state meet early Monday morning.

"I just wanted to make some mac and cheese, and I got really dizzy and nauseous, then passed out," said Gallup, who hit her head on a wall and opened up a goodsized gash.

The good news, she said? "I get the stitches out Tuesday, so I'm counting down the days," Gallup said, with a smile.

Gallup's runner-up performance in the 3200 was her best state meet finish of her high school career. She took third place in her freshman and sophomore years, and fourth a year ago as a junior. And in many of those

expect anything crazy, Hegge said.

After the preliminaries, Hegge was sitting fifth, but beat the jumper tied with him. He was then, however passed by under an inch.

"I just had to think, 'I'm going to beat him," Hegge said. "I was honestly just hoping for third."

Instead, Hegge earned his team eight points for second place, which could potentially play a huge role in the Vikings' bid for a top-3 team finish.

"It's amazing. He's always his last jump that's his best," Wausa jumps coach Tylor Fincher said. "It's always been that way.'

Hegge wasn't done in the jumps, though. He qualified with the second-best clocking in the 100-meter dash prelims at 11.14. and later had the best prelim time in the 200meter dash (22.77). The Wausa boys also fin-

ished 11th in the 3200-meter relays in 8:45.49, which was another season best, according to head coach Greg Conn.

"When you have something like that, that's almost as good as a medal for those kids," Conn said. On the girls' side for

Wausa, Brittanii Claussen and Hartington's Cami Stratman tied for 12th in the long jump at 15-4.

It will be on the boys' side, though, where Wausa could be set up for a good final day in Omaha, Conn said.

'We're really excited about (today), but I'd say we're cautiously optimistic," he said.

In other area girls' finishes on Friday, Hartington junior Shelby Hochstein finished 23rd in the pole vault at 7feet-6, while freshman teammate Sydney Lammers tied

for 24th at 7-6.Senior Sara Pinkelman finished 15th in the discus at 101-10. The Wynot 3200-meter

relay quartet finished 12th (10:44.31).

And on the boys' side, Tanner Fischer of Hartington was 11th in the 3200-meter run in 10:33.88, and Garrett Watters of Randolph took 12th place in the shot put at 46-4

RAPID CITY - Four Yankton Bucks and two doubles teams remain alive entering today's (Saturday) final day of the South Dakota State Boys' Tennis Tournament, being held in Rapid City.

Sioux Falls Lincoln leads the team race entering the final day of competition with 524 points. Sioux Falls O'Gorman ranks second at 491, followed by Mitchell (477.5) and Sioux Falls Washington (458).

Yankton is in 12th with 172.5 points. Vermillion scored 15 points.

Yankton's Brandon Frick will play for fifth place at flight five singles after going 1-1 on Friday. He dropped a 6-2, 6-2 decision to Mitchell's

Brenden Lehr, the top seed, before beating Washington's Aidan Hartwig 11-9. Frick will face Watertown's Seth Schamens in the fifth place match.

Yankton's Hunter Rockne advanced to the fifth place match at flight six singles. He dropped a 6-2 ,6-2 decision to Mitchell's Gray Determan, then beat Aberdeen Central's Matt Hollan 10-6. Rockne will face Roosevelt's Spenser Smith in the fifth place match.
