Daugaard visited Delmont Sunday, declaring a state of emergency for the town of around 250 residents. U.S. Sen. John Thune and U.S. Rep. Kristi Noem visited the town Monday. U.S. Sen. Mike Rounds was unable to attend but sent his East River director, Mark Johnston.

Thune told the *Press & Dakotan* on Wednesday that his staff remains in contact with the governor and local leaders.

"We want to provide as

much assistance as possible to the people of Delmont in what will continue to be a difficult time," the senator said.

Based on his Delmont visit, Thune said a number of

visit, Thune said a number of individuals believe a disaster declaration would help them rebuild and open up various options. "If FEMA assistance isn't

available, there are still other resources," the senator said, noting examples such as low-interest loans.

The Delmont tornado resulted in nine people

hospitalized for injuries, but there were no fatalities. "People were very fortunate to get cover and to get downstairs before this hit," Thune said, adding that others didn't get downstairs and still survived the storm.

In the wake of the Delmont tornado, Thune renewed his call for efforts to improve weather forecasting — particularly long-range models — that can benefit everything from agriculture

to public safety.

Thune noted an outpouring of support came from outside Delmont shortly after the twister. "In times of crisis, our communities really do come together to help those in need," he said.

ANSWERING THE CALL

One group of Yankton residents traveled to Delmont this week, offering their assistance in helping farmers cleanup after Sunday's tornado.

The Yankton men offered whatever help they could in getting local residents back on their feet. Three men didn't want their name used in the Press & Dakotan, while Terry Sayler said he was willing to allow his name to be used for this article.

"We're not seeking any publicity for ourselves," Sayler said. "We're just sharing our story so people know what needs are out there. We're building awareness of

what's needed."

It was a case of pay it forward, as one of the Yankton men's farm was hit hard by a tornado nearly a decade ago. The first time, he went to Delmont on his own. Upon learning authorities weren't allowing non-residents into Delmont, he offered his help

to farmers just outside town.
In particular, he noticed tremendous damage south of Delmont, particularly along Highway 18. At one farm, he helped catch and sort cattle.

helped catch and sort cattle.
The tornado created tremendous devastation, with one Delmont farmer alone facing overwhelming cleanup and recovery.

"He stepped out on his yard and was looking at all this destruction. He was distraught and didn't know what to think," Sayler said. "The first thing he was doing was getting the cattle sorted out and hauled to different farms."

Sunday's tornado was followed by Monday's blustery conditions — temperatures in the 40s with winds gusting to 30 miles per hour — that made clean-up efforts nearly impossible.

The first Yankton farmer

The first Yankton farmer decided to return Wednesday to Delmont, bringing along three other men to join in the clean-up effort. They hauled away debris, took down fencing, moved livestock and tackled whatever else was needed.

Wednesday offered tem-

Wednesday offered temperatures in the 70s, but stiff winds created challenges with the clean-up, Sayler said. "The wind was picking up little pieces of things like insulation," he said.

The farm losses included destroyed buildings, a silo that was half gone and livestock deaths. At one spot, a calf was found under debris

in the yard.

In the yard.
Ironically, some farms
were demolished while
neighboring farms suffered
little or no damage, Sayler
said. "One old wooden barn
that was leaning over to the
side before the storm was
still there." he said.

In response to the tornado, volunteers showed up to offer not only their labor but also their equipment. One party brought four skid loaders on a semi-trailer. A Hutterite colony brought food for residents and workers.

The volunteers included farmers from the Nebraska communities of Pilger and Ponca who has suffered their own tornado damage, Sayler said.

"These were people who had gone through this (destruction) before," he said.

A HELPING HAND

A number of relief organizations and efforts are offered or will soon become available to Delmont residents.

• A one-stop site opens today (Thursday) in Delmont for citizens who need tornado recovery assistance. The Multi Agency Resource Center (MARC) will be opened from noon to 8 p.m. today and Friday in the basement of the Delmont American Legion, located on Main Street.

• The Red Cross has set up a bulk distribution site for clean-up. That site is located at the American Legion in Delmont, as well. Lowe's and Home Depot are helping provide the items.

• Two response vehicles are driving through storm-damaged neighborhoods this week delivering food and water as clean-up and removal of debris continues. Since Sunday, nearly 35 Red Cross workers have served more than 4,000 meals and snacks.

• A donations management center opened
Wednesday in Delmont to
help residents impacted by
the tornado. The donations management center
is located at the Delmont
American Legion Hall. Hours
of operation are 8 a.m.-6 p.m.

each day. Because the town is not yet opened to the general public, those wanting to give items are asked to take them to the east side of town where the state Highway Patrol is stationed. That site is at the corner of 284th Street and 402nd Avenue, also known as the intersection of old Highway 18 and Betts Road. A pickup and trailer will remain available until 6 p.m. each day to accept donated items. The items will be transported to the

American Legion Hall.
Once the town is opened to the public, the items can be taken directly to the Legion Hall site.

State officials are warning
about the possible presence
of scam artists.

Attorney General Marty Jackley and the South Dakota Department of Public Safety urge Delmont tornado victims to proceed with caution when moving into the recovery phase of this disaster. Consumers who need repair work done quickly following a natural disaster are often targets of unscrupulous business practices.

Despite the overwhelming feeling after the tornado, Delmont residents have made tremendous strides in a few days, said Incident Assistance Team member Sandy Frentz.

"While it may feel like it's been a little slow, it really isn't," she said.
