USD's Daly, Minogue Earn NFCA All-Region Honors

LOUISVILLE, Ky.—South Dakota senior Allie Daly and junior Yvon Minogue have been selected to the 2015 National Fastpitch Coaches Association (NFCA) All-Midwest Region teams. Daly made the second team as catcher and Minogue was the first baseman on the third team.

A cleanup hitter from Sioux Falls, S.D., Daly leads the Summit League and ranks 41st nationally with 59 RBIs. Her batting average of .399 ranks fifth in the league and had 13 home runs this season. Daly's 41 career homers are the second-most in Summit League history. On defense, Daly has thrown out a league-leading 19 runners at catcher. Daly was also named to the 2015 CoSIDA Academic All-District team.

Hailing from Corona, Calif., Minogue was the leadoff hitter for the Coyotes this season for good reason. She's the national leader in doubles and her batting average of .470 tops the Summit League while ranking eighth nationally. Minogue also leads the league with 93 hits and ranks second with a .507 on-base percentage. At first base, Minogue holds a fielding percentage of .991. She leads the league in double plays (11) and has the second-most put outs (310).

The duo were both selected to the all-Summit League first team earlier this month.

Riley Says He Knows Of No Huskers

Planning To Transfer

LINCOLN, Neb. (AP)—Nebraska coach Mike Riley says he knows of no players planning to transfer before practice begins in August.

Riley said Thursday he's aware of fan speculation about players leaving, especially with five scholarship quarterbacks on the roster. He said he's met individually with players in recent weeks and that the roster is "status quo as we speak."

Riley said he's surprised no one is transferring because invariably one or more players left in the offseason during his years at Oregon State.

Riley also said he didn't plan to take any graduate transfers. He said he would look at a grad transfer "if it's the right guy with the right talent and if we have a special need." Riley said he isn't a coach who would "seek out" graduate transfers.

Judge Grants Class-

Action Status For Suit

Over Sports TV

NEW YORK (AP) — A federal judge says a lawsuit challenging all-or-nothing sports TV packages that require purchasing all professional hockey or baseball games can proceed as a class action.

Judge Shira Scheindlin (SHEER'-uh SHIND'-lin) ruled Thursday. She said all fans with some appetite for watching hockey and baseball broadcasts are affected by league policies requiring consumers to buy all league games rather than just the games of one team or a few teams.

Her written decision followed a three-day hearing in March. Lawyers for the leagues have said fans who brought lawsuits against Major League Baseball and the National Hockey League had failed to show common injuries warranting a class.

Last summer, Scheindlin ruled that baseball's antitrust exemption did not shield it from the litigation.

Brady Appeals Suspension; Patriots

Rebut NFL

FOXBOROUGH, Mass. (AP) — Super Bowl MVP Tom Brady appealed the four-game suspension he was handed for his role in using deflated footballs during the AFC championship game, and the players union urged Commissioner Roger Goodell to appoint a neutral arbitrator to hear the case.

The expected appeal was filed by the NFL Players Association on Thursday about an hour before a 5 p.m. Eastern deadline.

The league's collective bargaining agreement stipulates that it will be decided by Goodell or a person he designates. But the players union said in a news release that "given the NFL's history of inconsistency and arbitrary decisions in disciplinary matters, it is only fair that a neutral arbitrator hear this appeal."

The union did not detail the basis for the appeal. But in a 20,000-word rebuttal posted online by the Patriots' lawyers earlier Thursday, the team disputed the conclusions on matters of science, logic and law.

Attorney Daniel Goldberg's response claims the league's conclusions are "at best, incomplete, incorrect and lack context," claiming as one example that the "deflator" nickname used by a ballboy and cited in the discipline was about weight loss, not footballs.
