and Motorized Potentiometers. In 1968, Dale moved into the current building on E. Hwy 50. In 1985, Dale Electronics was acquired by Vishay Intertechnology. Today, the Inductors Division of Vishay, headquartered in Yankton, has grown to nearly 1,000 employees throughout the world.

Mountain Lion Killed Near Creighton

Deer Hunter Shot Cat Saturday, Officials Report

LINCOLN, Neb. — A 15-year-old deer hunter from Wayne killed a mountain lion near Creighton in northeast Nebraska on Nov. 12, according to the Nebraska Game and Parks Commission.

The boy, hunting a shelterbelt in Knox County, spotted the mountain lion 10 feet away before shooting and killing it. The mountain lion was a young male, which has been typical of mountain lions found in Nebraska outside of the Panhandle, according to Sam Wilson, furbearer and carnivore program manager with Game and Parks. The carcass was turned over to Game and Parks, as required by law.

It was the 52nd confirmed mountain lion sighting in Nebraska outside the Pine Ridge population since 1991.

Mountain lions are protected year-round in Nebraska but may be killed if threatening people or attacking livestock. No charges will be filed, as evidence indicated self-defense.

"Game and Parks is interested in documenting observations or game camera photographs of mountain lions," Wilson said. Please report any observations to your nearest Game and Parks office or call 402-471-





Glenn attended school and graduated from Chevenne County High School in 1935. Glenn attended Kansas State University from which he graduated with a degree in Veterinary Medicine in

World War II found Glenn in South Dakota testing cattle for the United States Government. He enlisted in the U.S. Army attaining the rank of Major. Upon his discharge from the Army, Glenn established his veterinary practice in Tyndall, South Dakota where he practiced for over 35 years. He married Kathryn Sully of Gregory, South Dakota in 1942 in Ft. Worth, Texas.

Glenn and his brothers participated in wrestling while in high school and Glenn followed his brothers, Clifford and Dale, as standout wrestlers at Kansas State University. He was named one of the 40 top athletes in Kansas State University history. This love for the sport of wrestling was a large part of Glenn's life and he was instrumental in the birth of the wrestling program at Tyndall High School and also assisted several other southeastern South Dakota communities start their programs. Some of his tondest memories were working with the wrestling team and watching his grandchildren and great grandchildren participate in sports.. Glenn was named to the South Dakota Wrestling Hall of Fame and was recognized by the South Dakota High School Coaches Association and the National High School Coaches Association with a Distinguished Service Award for his work in establishing high school wrestling in South Dakota.

Glenn served his community as mayor and on the Bon Homme School District School Board. He was a member of St. Leo's Catholic Church Knights of Columbus. He was president of both the South Dakota State Veterinary Association and the South Dakota Board of Veterinary Examiners. In 1967, he was recognized as the South Dakota State Veterinarian of the Year. He was the proud parent of


